## INFORMATION FOR VOTERS

- (1) Requirements for a citizen to qualify as a voter:

Citizen of the United States.

Twenty-one or more years of age. Resided in the state at least six months.

Able to read and write English.

Registered as an elector with the County Clerk or official registrar at least 30 days before election.

- (2) Voting by absentee ballot.

You may apply for an absentee ballot if:

You are a registered voter. ("Service voters" are automatically registered by following the service voting procedure.)

You have reason to believe you will be absent from your county on election day.

You live more than 15 miles from your polling place.

You are unable by reason of physical disability to go to the polls.

You are a "service voter". You are a "service voter" if you are:

In the Armed Forces or Merchant Marine of the United States.

A civilian employee of the United States, serving outside the country.

A member of a religious group or welfare agency assisting members of the Armed Forces.

A spouse or dependent of a "service voter" temporarily living outside the county in which the last home residence in this state of the "service voter" is located.

How a voter may obtain and use an absentee ballot.

You may apply for an absentee ballot if:

You will be temporarily absent from your county on election day.

You live more than 15 miles from your polling place.

You are physically unable to go to the polls.

Application for the ballot may be filed with, or mailed to the

County Clerk at any time within 60 days before the election, March 21—May 19 (Service voters, after January 1 of election year). Application includes:

Your signature.

Address or precinct number.

Statement of reason for application.

Applications filed less than five days before election, May 16-19, require additional statement that:

Voter is physically unable to get to the polls, or

Voter was unexpectedly called out of county in the five-day period.

Emergencies on Election Day:

Physical disability must be certified by licensed practitioner of healing arts or authorized Christian Science practitioner. Involuntary public services such as firefighting to be certified by person in charge.

Ballot, when voted by elector, must be returned to County Clerk not later than 8 p.m. on election day.

- (3) A voter may obtain and use a certificate of registration if he:

Changes residence within the state 30 days preceding an election. (Certificate is presented to election board in precinct to which he has moved.)

Is absent from his county on election day. (Certificate may be presented to the election board in any county in the state. Elector may vote only for state and district offices.)

- (4) If you have moved from the precinct in which you were registered to another precinct within the same county, you may vote in your old precinct if you apply for reregistration at the time of voting.

- (5) A voter is required to reregister if he:

Fails to vote in at least one county-wide election in any two-year election period.

Changes address by moving to another precinct or county.

Changes party registration.

Changes name.

## Measure No. 1

## SALARIES OF STATE LEGISLATORS

Proposed by the Fiftieth Legislative Assembly by Senate Joint Resolution No. 25, filed in the office of the Secretary of State May 18, 1959, and referred to the people as provided by section 1, Article XVII of the Constitution.

## CONSTITUTIONAL AMENDMENT

*Be It Resolved by the Senate of the State of Oregon, the House of Representatives jointly concurring:*

That section 29, Article IV of the Constitution of the State of Oregon, be amended to read as follows:

Sec. 29. The members of the Legislative Assembly shall receive for their services ~~for a salary of six hundred dollars (\$600) per annum, payable as provided by law. For each session of the legislature, they shall also receive the sum of 10 cents for every mile they shall travel in going to and returning from their place of meeting, on the most usual route,} salaries of \$175 per month each, payable as provided by law, and no other personal expenses. Each of the presiding officers of the assembly {shall, in}, by virtue of {their} his office, shall receive for his service as such an additional {compensation} salary in an amount equal to one-third of {their} his annual {allowance as members} salary as a member of the assembly.~~

NOTE: Matter in italics in an amended section is new; matter {lined out and bracketed} is existing law to be omitted.

## BALLOT TITLE

**SALARIES OF STATE LEGISLATORS**—Purpose: To amend Constitution by increasing salaries of state legislators from \$600 per year, plus mileage, to \$2100 per year.

(ESTIMATE OF COST—Under this amendment, the total salaried bill of the ninety members of the Legislature would be \$189,000, plus \$1400 additional for the presiding officers or a total of \$190,400 per annum, as opposed to the present \$54,400 per annum.)

**Measure No. 1 Salaries of State Legislators**

**EXPLANATION**

**By Committee Designated Pursuant to ORS 254.210**

The present pay of state legislators is governed by Article IV, Sec. 29, of the Oregon Constitution. It reads as follows:

"The members of the Legislative Assembly shall receive for their services a salary of Six Hundred Dollars (\$600.00) per annum, payable as provided by law. For each session of the legislature, they shall also receive the sum of 10 cents for every mile they shall travel in going to and returning from their place of meeting on the most usual route. The presiding officers of the assembly shall, in virtue (sic) of their office, receive an additional compensation equal to one-third of their annual allowance as members."

The proposed amendment would increase the compensation now paid to the members and the presiding officers of each house of the legislative assembly. It would also eliminate reimbursement for personal expense.

The present annual cost of legislative salaries is \$54,400; the proposed amendment would increase this amount to \$189,000.00. The amendment would eliminate any payment for personal expenses and therefore, while the increase in salaries would be \$136,000.00 per year, this increase would be reduced by the amount of the expenses paid to legislators heretofore. In 1959, this amounted to \$2,057.60

There is a wide variation in the compensation of legislators in other states, ranging from \$200.00 in New Hampshire to \$15,000.00 per biennium in New York. Of the states immediately adjoining Oregon, California pays \$600.00 per year with \$18.00 expenses per day during the session; Idaho pays \$10.00 per day, plus \$5.00 expenses during the session; Nevada pays \$15.00 per day and \$60.00 per session for expenses; Washington pays \$1,200 annually and expenses of \$15.00 per day.

Although Oregon ranks high among the states in per capita income, it has remained among the group paying legislators only nominal compensation. This amendment, although not lifting Oregon into the category of a state paying highest salaries to its legislators, would provide a more adequate compensation for the time devoted to legislative service.

**Measure No. 1 Salaries of State Legislators****ARGUMENT IN FAVOR****Submitted by the Legislative Committee Provided by Senate Joint Resolution No. 25 of the Fiftieth Legislative Assembly (1959)**

The people of Oregon should be represented in the state legislature by men and women elected from the ranks of all those who are to be represented. Under the present pay schedule, this is virtually impossible:

1. Unless members serve at a great financial loss to themselves and their families;
2. Unless members are independently wealthy; or
3. Unless members are subsidized by special interest groups.

**PRESENT SALARY OF A MEMBER OF THE LEGISLATURE IS \$50.00 PER MONTH.**

At the present time, members of the Oregon legislature receive \$600.00 per year, or \$50.00 per month AND NO OTHER EXPENSES EXCEPT reimbursement for ONE ROUND TRIP from their homes to the State Capitol at Salem.

**OUT-OF-POCKET LOSS FOR A MEMBER OF THE LEGISLATURE EXCEEDS \$2,500.00.**

A poll was taken this year of present and past members of the legislature to determine the average actual expenditures incurred in legislative service. The average time that a member spends in Salem during a legislative session is 120 to 140 days. Reports from 75 present members indicate that the average out-of-pocket expenditures during a session exceed \$1,400.00. Members on fixed salaries can readily determine their loss of income; members who operate small businesses, farms, or are engaged in business or the professions have a more difficult time. All estimates were on the conservative side—but at that the average loss of wages, or business income, was \$2,300.00 during the legislative session.

To recapitulate—for the legislative session:	
Average expenses .....	\$1,400.00
Average loss of wages or business income .....	2,300.00
Total expenses .....	\$3,700.00
Total legislative salary for two years	
@ \$50.00 per month .....	1,200.00
Average out-of-pocket loss .....	\$2,500.00

In addition to the out-of-pocket loss during the legislative session, members spend in excess of 60 days after the session and in the off year between sessions attending meetings of interim committees for which they receive no compensation. Interim committees provide for mileage and meals away from home, but no per diem allowance of any kind is provided. In addition, a member is expected to, and should, spend additional time in research, preparation, and consultation with constituents.

**OREGON PAYS ITS LEGISLATIVE MEMBERS LESS THAN 45 OTHER STATES.**

The salary or pay schedule for members of the legislatures of the 50 states range up to \$15,000.00 during a biennium. Many states, in addition to the salary, provide allowances up to \$50.00 per day for personal expenses during the legislative session.

**THE PROPOSED PAY SCHEDULE OF \$175.00 PER MONTH IS REASONABLE.**

During consideration of the proposed constitutional amendment at the last legislative session, the members of the legislature were fully cognizant of the

pay scales in other states. There was no intent or desire to try to match any other state. There was a desire, however, to provide an amount sufficient to reimburse members for their actual out-of-pocket expenditures during the legislative session and a modest allowance for the days, weeks and months spent in legislative service between sessions. The total salary at \$175.00 per month during a full two-year legislative term would be \$4,200.00. With out-of-pocket expenditures on an average during the session of \$3,700.00 only a modest amount would be provided for the additional expenses between sessions.

#### THE PROPOSED AMENDMENT PROVIDES NO PERSONAL EXPENSES.

When the people were asked to consider a proposed legislative pay increase in 1958, some fear was expressed that in addition to the salary provided, at some future date additional other compensation might be provided. To avoid such a possibility, the proposed amendment makes it clear that no personal expenses will be allowed. Attention is directed to the present amendment which provides:

“\* \* \* members shall receive for their services salaries of \$175.00 per month each, payable as provided by law, and no other personal expenses \* \* \*”

#### OREGON HAS LOST CAPABLE AND EXPERIENCED LEGISLATORS.

Many able leaders in the legislature have not sought reelection because of the pay schedule. Here is what some of them have said in response to our poll:

“The financial loss is one of the deciding factors in not running for re-election.”

“My absence meant a loss to the firm; I paid my law partners extra for their additional time and work.”

“Until I recoup some of my losses I can't even think of running for public office again.”

“The legislature nearly broke me.”

“We had good crops and I can run again, but is it not ironical that the working knowledge I have gained and the usefulness of this to the state must depend on the success of the harvest?”

#### LEADING CITIZEN GROUPS SUPPORT THE PAY INCREASE.

The League of Women Voters, The Oregon State Grange, Oregon Farm Bureau Federation, Associated Oregon Industries, Organized Labor (including the AFL-CIO and independent labor groups), both major political parties, Chambers of Commerce, Junior Chambers, and many others support the proposed pay increase.

We ask you to bear in mind when you vote the thoughts expressed by Ralph T. Moore in a recent Oregon publication, in which he said:

“Certainly no moderate increase in legislative pay would constitute much of an inducement to the kind of people our legislature should have. Yet, in the name of common decency, the pay should at least cover out-of-pocket expenses.”

The choice is yours. If you want to maintain an independent legislature, made up of citizens of all walks of life, free to act in the interests of all of the people, then you must provide a salary schedule which will enable our legislators at least to break even and not suffer extensive out-of-pocket losses. The proposed salary does just that—no more.

Thank you for your interest in reading this argument in support of the proposed legislative pay increase.

**WHAT SHOULD STATE LEGISLATORS BE PAID?**

Political scientists and students of government who have been analyzing this situation for a good many years have about come to agree that the pay should be enough so that anyone can afford to serve, and yet not so much that it will attract people who may not be successful or qualified, and may seek election solely for financial reward.

At the last session of the legislature a new compensation plan was adopted and referred to the electorate for action. Voting will take place at the primary election May 20. If approved the new salary plan would become effective on the date of its passage.

It provides for a monthly salary at the rate of \$175 per month.

**WHAT ARE THE RESULTS OF INADEQUATE LEGISLATIVE PAY?**

Inadequate legislative pay leads inevitably to two things: first, it eliminates many young people who would like to serve, because they cannot afford to; and, it gradually leads to legislatures composed in the main of only the wealthier people in the state.

Here in Oregon, where sessions biennially are averaging about 120 days, legislators work a good 1,200 hours at the session, and during the remainder of the biennium are called upon for at least another 300 hours of service. This actually means that they now receive about 80 cents an hour.

Oregon has been extremely fortunate that it has been able to have its laws manufactured at bargain prices due solely to the fact that a great many people have been willing to pay out of their own pockets for the sometimes dubious privilege of wrestling with our mountainous problems of government.

We've been getting far more than we've been paying for—and it's time that we abandon this archaic pay structure and take positive steps toward a realistic compensation plan for legislators by voting in favor of the pay increase measure on the May primary ballot.

WAYNE MORSE believes that an elected official should carry out the public interest by following where the facts lead. His guide post is the historic fact that our Constitutional Fathers founded our Government for the primary purpose of promoting the general welfare of ALL our people and not just a privileged FEW.

**FOREIGN POLICY**—A nuclear war would mean the end of the United States, as well as Russia. "We need to become much more concerned about the peace gap than we are about the missile gap."

**WATER CONSERVATION**—Water is rapidly becoming a scarce resource in America. We must not continue to waste it. We must conserve our water supplies through public development of multi-purpose damsites and by cleaning up stream pollution.
