- ANNEX F (PRISONERS OF WAR AND CIVILIAN INTERNEES) to 316th INTC Dat Tac SOP (U)
- 1. (3) The evacuation, classification, segregation, control and security of the above will be as provided for in the SOP of the supported command.
- 2. (U) Further handling of civilian intermees will be in accordance with the Geneva Convention, 1949, relative to the protection of civilian persons in time of war and FM 27-10. Civilian intermees will be segregated from prisoners of war as soon as possible after capture.
- 5. (U) All personnel will be thoroughly versed in necessity for maintaining proper custody and security of captured personnel, documents, and material. Appropriate action will be taken to prevent retention of captured items by individuals as souvenirs before full intelligence exploitation is completed.
- 4. (5) Special personnel of intelligence interest include:
- a. Military and civilian advisors, technicians, and other official representatives of enemy countries.
- b. Key personalities listed on wanted lists: A wanted list for the objective area will be published separately and distributed through intelligence channels to this Detachment.
- c. Guided missile and special weapons (CBR and nuclear) personnel and other personnel possessing technical information.
 - d. Known or suspected communist and enemy agents.
 - e. Military leaders of equivalent rank of Captain and above.
 - f. Sea and air crew members.
- g. High ranking deserters indicating desire to cooperate with U. S. forces.
- h. Local leaders (to include city and provincial officials, political leaders and police officials).
 - i. Personnel of ASA interest, including:
 - (1) Radio and radar operators and technicians.
 - (2) Code clerks and other code personnel.
 - . (3) Enemy electronic countermeasures personnel.
- j. Personnel possessing information affecting accomplishment of the mission.
- 5. (U) Additional personalities and processing instructions will be as determined by the G2, supported command.
