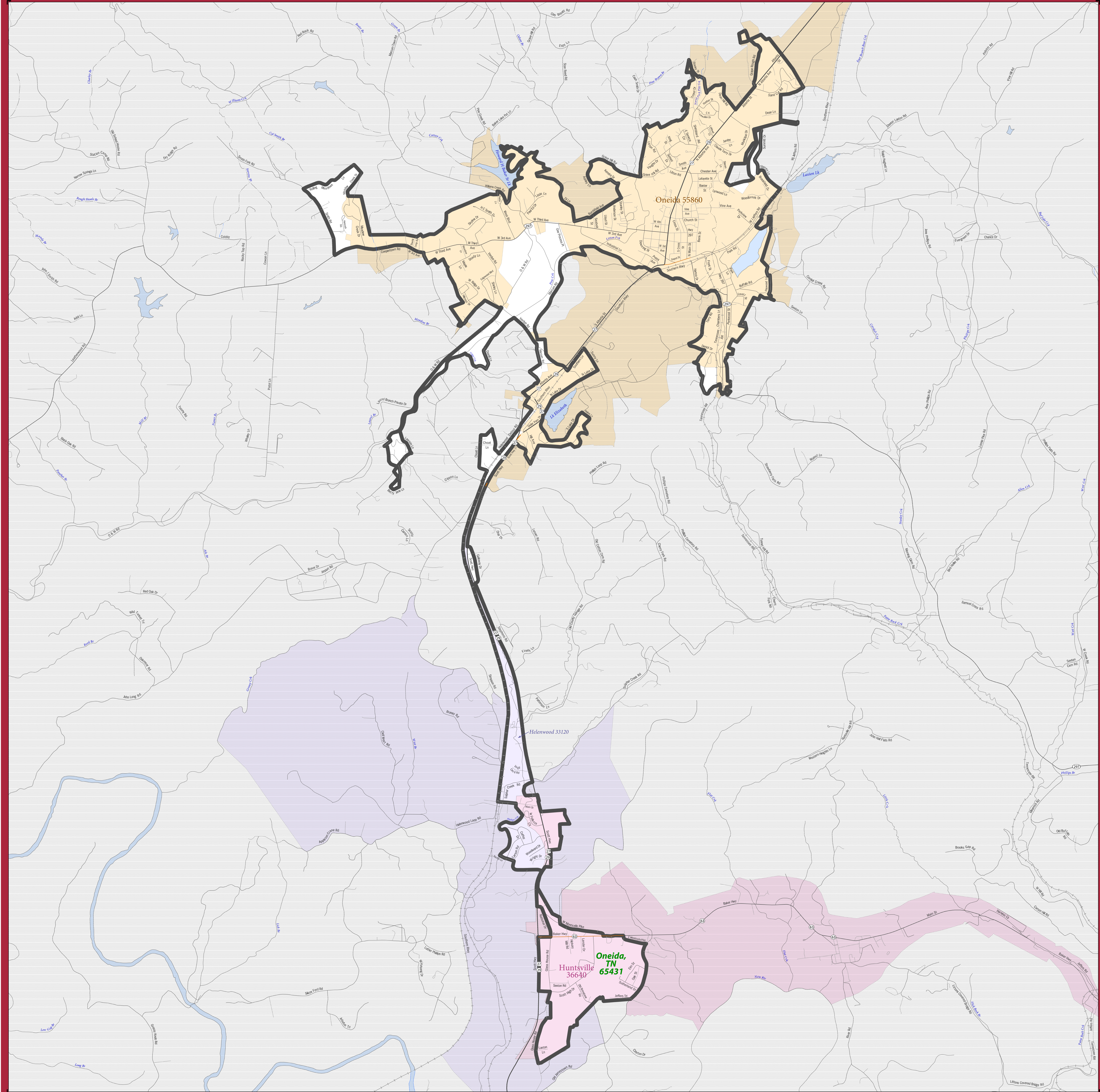


# 2010 CENSUS - URBAN CLUSTER REFERENCE MAP: Oneida, TN
