It is not considered desirable to attempt to secure technical secret coverage of P. O. box in Cuernavaca as outlined in re airtel. Mexico City should explore other available possibilities for obtaining desired coverage.

NOTE: Legat, Mexico City, has been making efforts to develop information as to the presence and activities of Chicago hoodlum Sam Giancana, who has previously visited Mexico. Legat has developed information as to the address of Harriette Blake Cain; wife of Richard S. Cain, a known associate of the subject in Chicago and has suggested that discreet technical coverage of the P. O. box for this address be established through CIA, Mexico City.

Legat being advised that such efforts to establish this coverage not desirable and that other possibilities of coverage should be explored.

Information was received from the Mexican Immigration Service that HARRIETTE BLAKE CAIN, the wife of RICHARD S. CAIN, a known associate of the subject, in her dealings with Mexican Immigration furnished her address as c/o her attorney, JORGE CASTILLO Z., Plaza de la Republica 32, Mexico City. This attorney also represented the subject.

Immigration officials advised, however, there was an additional address for her, Box 1066, Cuernavaca, Morelos, Mexico, telephone 2 61 75.

This information was furnished to MEX 258, but he advised he could not develop further information in this regard because such records are confidential. He and Mexican Immigration officials conjectured that the Cuernavaca address was the residence of the popular television performer, RAUE ASTOR, who had contracted Mrs. CAIN as a singer.

Subsequently, MEX 156 returned to Mexico City from the west coast and was furnished with information already as he was known to have contacts in the Cuernavaca Post Office. He advised on 6/8/67 that he had been unable to trace the P. O. box but had determined through a page-by-page review of the Cuernavaca telephone book that telephone number 2 61 75 is in the name of BRAY DAWSON, Casa 131, Calle Nezahualcoyotl. Reportedly Mr. DAWSON is now in Dallas, Texas, and sold this property to a Mrs. CALLE (Probably ALLEN) through MELLICENT WATSON, a local realtor who is also the administrator for the property in the absence of Mrs. CALLE from Mexico.

Source determined that P. O. Box 1066 was for a residence in the Rancho Tetela Section of Cuernavaca, located at some distance from the DAWSON house (S)(u)

On 6/13/67, MEX 156 advised he had determined that P. O. Box 1066, Cuernavaca, is listed to RICHARD SCALZETTI, address Calle de Nubes 2, Rancho Tetela, Cuernavaca. It is noted that this is CAIN's maternal surname (S)(u)

Source made pretext inquiry at this location and determined from the servants that the owner of the house is referred to as SALVADOR SCALZETTI. They indicated he was not in Mexico (S)(u)

Source noted that this is a luxury house, costing about 1,000,000 pesos (\$80,000 U.S.) It is in an isolated location and surrounded by a high wall (S)(u)

Rancho Tetela is a subdivision, and the realtor handling property in that area is Mrs. EDITH LITTLE STEWART, an American who resides at Casa Amarilla in Rancho Tetela (S)(u)

It is noted that Mexico City previously had an investigation concerning ALBERT M. ANDREAS (Bufile 164-192). ANDREAS was a fugitive in a Crime Aboard Aircraft - Assault matter, having been indicted at Athens, Georgia, on 2/1/65 in regard to an assault on a stewardess while aboard a Northwest Orient Airlines flight from Miami to Chicago on 10/28/64 (S)(u)

ANDREAS was described as white male, age 57, born 4/16/07, Sterling, Illinois, height 5' 5", weight 153 pounds, complexion dark, hair thin and graying with receding hairline, occupation retired former Chairman of the Board, North American Cement Corporation, New York (S)(u)

Reportedly the assault occurred when the stewardess requested payment for a drink and was punched in the stomach area (S)(u)

A Miami source indicated ANDREAS was at P. O. Box 703, Cuernavaca, in a residence allegedly purchased from the Swiss or the Swedish Embassy for \$300,000 (S)(u)

MEX 156 determined that ANDREAS was residing at Las Nubes 2, Rancho Tetela, Cuernavaca. He determined that P.O. Box 703 (S)(u)

was in the name of EUGENIA ALVAREZ DE GARCIA. Also listed to receive mail at this box was EBERST D. RASSING, address Atlacomulco 309. This was determined to be a non-existent address (u) (u)

ANDREAS subsequently surrendered himself and was fined \$500 (u) (u)

ANDREAS also figured in a Special Inquiry matter from Chicago entitled "OSBORN ANDREAS" (Bucab 5/26/65), his brother. Chicago is undoubtedly cognizant of the ANDREAS matter and may desire to give consideration to contacting him concerning the disposal of this house. However, it is noted there is an excellent possibility that Legat, Mexico City, can secure technical secret coverage of the P. O. box in Cuernavaca through CIA, Mexico City. This could be an extremely valuable source of information in this matter and might be prejudiced by any direct investigation concerning this residence (u) (u) [S]

UACB, Mexico City will explore possibilities of obtaining such coverage. (u) (u)

Mexico City will also explore other possibilities in obtaining discreet coverage of the residence in Cuernavaca. (u) (u)
