Guidance Section Kagawa Prefecture

In-Service Training Program in 1951

a. Principle

- 1. Education Board Secretariat holds only the training courses or lecture-classes which are really necessary and effective to the school education, because so far the lecture-classes were too often given. Not always systematically.
- 2. The course for the Teachers' New Certificate Law will be given effectively so that it may meet the demands of the teachers.
- 3. In-service training program in each school must be practised thoroughly. In order to assist it, teachers' consultants and assistant teachers' consultants on each subject visit the schools and give advice as often as possible.
- 4. Promote and assist the democratic research associations.
- 5. Save the expense, but the contents must be effective.

Kagawa Prefecture In-Service Training Advisory Committee

The Kagawa Edvisory Committee on teacher in-service training met on 4 June where the organizational plans and procedures were adopted. There are 10 committee members representing Kagawa University, the Teachers Union, the elementary, lower secondary and upper secondary schools' associations. The general aim is to make necessary suggestions for the improvement of the inservice training program which will more really meet the needs of education in the prefecture. The Guidance Section of the Prefectural Board of Education Secretariat will also attend the meetings in an unofficial capacity.

CE met with the members of the committee on 14 June for a discussion of suggested plans. The committee in general discussed general proposals for the inservice trainingprogram now planned without getting down to practical matters. CE steered the discussions into an appraisal of education needs in the schools at various levels and the use of university personnel available in giving instruction in fields where weaknesses now exist. Such fields included: secondary and elementary administration, guidance in the secondary schools, tests and measurements, evaluation of school work and vocational training in the secondary schools.
