For instance, if you have smallpox and recover from it, you natural immunity to have a smallpox which will probably last you throughout life. If you have diphtheria and recover from it, you have a naturally acquired immunity to diphtheria which lasts but a very short time. In other words, the defense which is manufactured by your body through having certain diseases may be a defense which may be permanent or it may be very transitory.

Artificially acquired immunity is the immunity that is acquired by taking vaccines and serums. Vaccines cause the system to act and manufacture its own defense. This defense is then an artificial active immunity. Serums contain the defense already manufactured by animals. The defense in this case is a passive defense or immunity.

An example of the artificial active immunity is furnished by vaccination against smallpox. The material injected causes your



Diphtheria is not "filthy animal matter." It is the clear pure serum of healthy young horses that have been artificially given diphtheria toxin. And it is full of the defense which the horse's cells and blood have produced to neutralize this toxin.
