Ads of Death.—Lots, in building lumber, were sold yesterday, to the amount of two hundred thousand, and seven hundred thousand dollars. The bids, we are informed, are all off. The bidding, the value of the original purchase, considerably, by the sales being made, and a great number lots remain as yet unsold. The sale will be continued this day.

Navy.—A dredge, yesterday evening about 8 o'clock, arrived at Murphy's wharf. Although the wind blew high at the time, and the waves around were of large combustible materials, the fire was subdued, before it could create much injury. The mayor was on the previous, directing the exertions of the citizens to quell the conflagration.

Capital Sentence.—Sentences of death were yesterday severally passed on Farache, Souco, and Hernandez, all declared guilty of the murder of Morycay. Judge Gatica, in a succinct manner, addressed the convicts in the Spanish language, and recapitulated the main circumstances of their crime. Farache heard the award of the law with evident trepidation; his features were distorted, and looks were haggard. Souco heard his fate with unconcern. Hernandez protested against the deposition of the witness, and impugned his veracity. He spoke clearly, correctly, by the side of the judge, and his words were easily understood. Attempt of Murder.—Yesterday afternoon, a Spaniard stabbed a man in three different places, in the arm, back, and neck, and that, too, without any warrantable provocation. He was arrested, and lodged in jail, one of the steps-guards, while in the act of apprehending him, in the hold of a schooner, whither he had taken refuge, was also struck by him, the knife, though slightly. The principal sufferer, we are informed, will likely recover from his wounds, which are not considered mortal.

Lots for Auction.—We have received our *Advertiser* up to the 2d of March. They contain no intelligence of any moment. On the 3d instant, a Scandinavian vessel, loading for Orense, was burnt down to the water's edge. She was loading at the time; part of her cargo, consisting of 249 boxes sugar, 50,000 pounds of coffee, and 10,000 pounds of iron, says the *Advertiser*, were destroyed. A commercial house of this city, politely favored us last evening, with an extract of a letter, dated Vina-Cruz, Feb. 2d, which corroborates the news relative to the capture of the government supplies by Gen. Santa Ana.

It is believed that instructions were about to be sent to our minister at Brazil, to inquire into and if possible, ascertain the fate of the unfortunate sailors who were unmercifully engaged in a raid, in enterprise to the North coast of the country, some fifteen years since, and were sent to the mines, and have not since been heard of, except the report (since dead) and other officers having narrowly escaped the same punishment by pure flight.—*Boston Cons. This person was committed to prison to answer to the charge of having been a party to the robbery.
