Report is hereby made in relation to
the memorandum of SCAP dated 21st October
1945 ((21 OCT. 45 AR. KD) regarding
the destroying by fire of literatures and
records of Prisoners of War ~~and~~ Information
Bureau.

1. Shown in the annexed table ^{are} ^{burnt} literatures
and records ~~destroyed by fire~~.
2. The table contains documents of the
Administrative Dept of Prisoners of War
although not so specified by SCAP memo-
randum, because Prisoners of War and
Information Bureau and Administration
Department, Army Ministry have the office
and staff common, both actually a unit,
that the documents of the latter were
indivisably related to the former.
Moreover, documents of both offices

were equally treated and burned accordingly.
Its circumstances were as given in
clause 3.

3 Circumstances of Burning Documents

(1) On the occasion of business liaison at
the Ichigaya-Dai following the announcement
of the conclusion of war on 16th August, the
following instructions were given verbally.

Principal points of Instructions read -
(according to memory)

Those come under the regulations
for handling secret military documents
(excepting code books), and those
of which retention deemed not
desirable shall be instructed as
being burnt without fail. No

(2) Basing on this instructions Lieutenant
General Hiroshi TAMURA, Commander of
Bureau of Prisoners of War ~~and~~ Information
concurrently Chief of Administration

Department of Prisoners of War issued the following command: -

Documents to be burned follows: -

(1) Documents stamped ("MITSU" and "KI-MITUS") "Secret" which are held at ^{the} Prisoners of War and Information ^{Bureau}, and the Administration Department;

(2) Documents belonging to the Administration Department of which keeping not necessary;

3. The burning was carried out around 16th to 19th of August according to the command. However, the psychic state of Japanese at that time being in utter confusion which ^{also} influenced over the judgement on selection and burning of documents, a portion of documents otherwise ^{should have been} preserved suffered destruction that the Prisoners of War and Information ^{Bureau} itself experiences no small inconvenience thereafter, for which occurrence the Bureau sincerely regrets.

Report respecting destroying literature and records of Prisoner of War Information Bureau. To: Maj. Yokoi (in pen)

Report is hereby made in relation to the memorandum of SCAP dated 21st October, 1945 (21 Oct. 45AQ KD) regarding the destroying by fire of literature and records of the Prisoner of War Information Bureau.

1. Shown in the annexed table are burnt literature and records.
2. The table contains documents of the Administrative Department of Prisoners of War although not so specified by SCAP memorandum, because the Prisoner of War ~~and~~ Information Bureau and Administration Department, Army Ministry, have their offices and staff in common, both forming actually one single unit, so that the documents of the latter were indivisibly related to the former. Moreover, documents of both offices were equally treated and burned accordingly. Its circumstances were as given in clause 3.
3. Circumstances of Burning Documents.
 - (1) On the occasion of business liaison at the Ichigaya-Dai following the announcement of the conclusion of war on 15th August, the following instructions were given verbally. Principal points of instructions read - (according to memory)
"These come under the regulations for handling secret military documents (excepting code books), and those of which retention is deemed not desirable shall be instructed to be burnt without fail. No report on burning required, according to the command".
 - (2) Basing on this (instructions) Lieutenant General HIROSHI TAMURA, Commander of the Prisoner of War Information Bureau concurrently Chief of Administration Department of Prisoners of War issued the following command:-
