ORDINANCE GRANTING **INCENTIVES** TO ATHLETES WHO REPRESENTED THE CITY OF ALAMINOS, PANGASINAN AND WON IN COMPETITIONS BRINGING HONOR TO THE CITY, SPORTS APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES

## EXPLANATORY NOTE

WHEREAS, it is the policy of the State to give incentives to athletes who are winners or medalists in legitimate local and international sports competitions pursuant to Republic Act No. 10699 or An Act Expanding The Coverage Of Incentives Granted To National Athletes And Coaches, Appropriating Funds Therefor, Repealing For The Purpose Republic Act No. 9064, Also Known As The "National Athletes, Coaches And Trainers Benefits And Incentives Act of 2001" or "Sports Benefits And Incentives Act of 2001;"

WHEREAS, the City of Alaminos is home to pupils and students-individuals, in pairs and in groups-who have proven and who continue to display their prowess and excellence through the years in various sports/ athletic competitions, bringing honor, prestige and great pride to the city, and leaving a mark in the annals of the history of city and of the country;

WHEREAS, the City Government of Alaminos finds such feats worthy of recognition and reward and deems it essential to enact a policy in line with the national government's policy of giving incentives to people, especially the youth, who have brought respect and admiration to the locality, in terms of athletic skills and excellence in sports;

**WHEREAS,** giving incentives to the winners of sports and athletic competitions is giving credence to their achievements worthy of emulation by the younger generation. These winners, through their sacrifices, enthusiasm and motivation, serve as inspiration and good role models to the youth of the City of Alaminos;

**NOW, THEREFORE,** on motion of Councilor Arvin P. Braganza, co-sponsored by PPSKP Loverly V. Bernabe, duly seconded by all members present,

# BE IT ORDAINED BY THE SANGGUNIANG PANLUNGSOD OF THE CITY OF ALAMINOS, PANGASINAN IN REGULAR SESSION ASSEMBLED AN:

**SECTION 1. SHORT TITLE.** — This Ordinance shall be known and cited as the "2022 Sports Incentives Ordinance of Alaminos City."

**SECTION 2. DECLARATION OF POLICY.** — It is hereby declared a policy of the City of Alaminos, Pangasinan to extend financial incentives to deserving youth for having given honor to the City of Alaminos in various legitimate competitions in the fields of sports, arts and other prestigious competitions.

**SECTION 3. DEFINITION OF TERMS.** — As used in this ordinance, the following terms or phrases shall be construed to mean:

- (a) Athlete is a person who is trained or skilled in exercises, sports, or games requiring physical strength, agility, or stamina.
- (b) Athletics, also called track-and-field sports or track and field, is a variety of competitions in running, walking, jumping, and throwing events.
- (c) Athletic trainer, or a sports trainer, is a person who helps amateur or professional athletes prevent injuries, give first aid when an injury occurs during a practice or event, and manage the rehabilitation programs and routines of injured athletes.
- (d) Coach, in this case a sports coach, is a person coaching in sport or who supports an athlete or client in achieving a specific personal or professional goal by providing training and guidance.
- (e) Grantee is an athlete—whether individual or a member of a pair, group or team—a coach, or a trainer who receives a financial incentive as provided for in this ordinance.
- (f) Sport pertains to any form of competitive physical activity or game that aims to use, maintain or improve physical ability and skills, while providing enjoyment to participants and, in some cases, entertainment to spectators.
- (g) Sports Competitions refer to various sports competitions that are accredited or sanctioned by the following government agencies:
  - Department of Education
  - Philippine Olympic Committee
  - Philippine Sports Commission
  - Department of the Interior and Local Government
  - Commission on Higher Education

Sports competitions may be categorized as:

- 1) Provincial and Regional sports competitions
- 2) National sports competitions include, but not limited to the following:
  - Luzon-Visayas-Mindanao League
  - Palarong Pambansa

- Philippine National Youth Games (Batang Pinoy)
- National Open
- National Games
- Special Olympics
- International and worldwide levels of sports competitions include regular sports competitions sanctioned by the International Olympic Committee and/or the International Sports Federations, such as:
  - Summer Olympics
  - World Championship of respective sports
  - Asian Games
  - Asian Championship of respective sports
  - South East Asia Games (SEA Games)
  - ASEAN Championships of respective sports
  - Special Olympics

Sports competitions shall not include exhibition games.

**SECTION 4. QUALIFICATION OF GRANTEES.** — To qualify as a grantee, the athlete must:

- a. have proof of residency which can be any one (1) of the following:
  - 1. birth certificate showing he/she was born in the City of Alaminos, or a voter's ID registered in the City of Alaminos, or a barangay certification indicating residency for at least six (6) months;
  - birth certificate of a parent born in the City of Alaminos, or voter's ID registered in Alaminos City, or a barangay certification indicating residency for at least six (6) months;
  - 3. school registration form indicating he/she is an officially enrolled student for an Alaminos City-based school for at least six (6) months and is duly representing the City of Alaminos, Pangasinan in the competitions she/he is participating in;
- b. have informed the City Government in writing of his/her participation and that she/he is an official representative of the city/province and/or the country in a particular competition before the actual competition for records purposes;
- c. be able to submit original and/or certified true copy of certification and appropriate documentations that he/she participated and won first (1st), second (2nd) or third (3rd) place or gold, silver or bronze medal accordingly in a duly accredited sports or athletic competitions in the provincial/regional, national, international and worldwide levels;
- d. have been duly certified by the City Sports Development Council that the grantee has satisfactorily submitted and has passed the basic requirements set forth in this ordinance through an appropriate resolution of the City Sports Development Council.
- e. For coaches and/or trainers
  - for national competitions must be a Filipino citizen, must submit authentic certification from appropriate authority/agency and the grantee that he/she had been the official coach/trainer of the grantee for not less than six (6) months; and

2) for international and worldwide level of competitions – must be a Filipino citizen, must submit authentic certification from appropriate authority/agency and the grantee that he/she had been the official coach/trainer of the grantee for not less than six (6) months, must submit proof of membership to the national coaches' and trainers' pool, submit proof that he/she is recognized and accredited by the Philippine Sports Commission and has represented the country as an official coach and trainer to national athletes in international competitions.

**SECTION 5. NUMBER OF GRANTEES.** — The number of grantees under this program depends on how many athletes have qualified and complied with the requirements set forth in this ordinance.

**SECTION 6. THE CITY SPORTS DEVELOPMENT COUNCIL.** — There is hereby created a City Sports Development Council, which is primarily tasked to develop potential athletes through a well-synchronized year-round calendar of sports activities and physical fitness programs for the city residents, especially the youth. It shall also judiciously screen applicants for the sports incentive based on the qualifications set forth in this ordinance and its implementing rules and regulations.

The City Sports Development Council shall be composed of the following:

# SECTION 7. AMOUNT OF INCENTIVES. —

(a) For individual sports and athletic competitions, qualified grantees shall be entitled to receive the following cash incentives:

- (c) Only the qualified grantee/s shall be entitled to receive the financial incentive. The grant shall be non-transferrable.
- (d) Coaches and Assistant Coaches of qualified grantees shall receive:
  - a. Financial incentive equivalent to ten percent (10%) of the financial incentive received by the grantee for provincial competitions;
  - b. Financial incentive equivalent to ten percent (10%) of the financial incentive received by the grantee for regional competitions;

- c. Financial incentive equivalent to twenty percent (20%) of the financial incentive received by the grantee for national competitions;
- d. Financial incentive equivalent to thirty percent (30%) of the financial incentive received by the grantee for Southeast Asian competitions;
- e. Financial incentive equivalent to forty percent (40%) of the financial incentive received by the grantee for Asian competitions; and
- f. Financial incentive equivalent to fifty percent (50%) of the financial incentive received by the grantee for international and world competitions.

**SECTION 8. INCENTIVE REWARD FOR THE SCHOOL.** — The school of the student athlete winner/s shall be given a one-time incentive reward at each level of competition amounting to:

Five Thousand Pesos (P5,000.00) for Gold Medal awardees Four Thousand Pesos (P4,000.00) for Silver Medal Awardees Three Thousand Pesos (P3,000.00) for Bronze Medal Awardees

However, where a team is composed of players from different schools and won any of the medal awards mentioned in this section, the incentive amount for any of the medal awards shall be divided equally among the schools where any the participating players belong.

**SECTION 9. FUNDS FOR THE PROGRAM.** — To carry out the provisions of this ordinance, the amount of **One Million Pesos** (PhP 1,000,000.00) shall be appropriated from the General Fund of the City Government as the initial fund for this program. Out of this fund, the amount of **Three Hundred Thousand Pesos** (PhP 300,000.00) shall be appropriated annually for replenishment under the Sports Development Office. Supplemental budget shall be appropriated as necessary.

**SECTION 10. ISSUANCE OF RULES AND REGULATIONS.** — The City Sports Development Council shall formulate and issue the Implementing Rules and Regulations (IRR) as may be necessary to carry out the provisions of this ordinance within sixty (60) upon its approval.

**SECTION 11. SEPARABILITY CLAUSE.** — The provisions of this ordinance are hereby declared separable and if one or more provisions are held invalid or unconstitutional, the remainder, or any provision hereof not affected, shall remain valid and effective.

**SECTION 12. REPEALING CLAUSE.** — All ordinances, resolutions, rules and regulations inconsistent with or contrary to the provisions of this ordinance are hereby repealed, amended or modified accordingly.

**SECTION 13. EFFECTIVITY.** — This ordinance shall take effect in accordance with the provisions of R.A. 7160, otherwise known as "The Local Government Code of 1991." This ordinance shall be posted in conspicuous locations within the City of Alaminos, Pangasinan.
