NARRATIVE SUMMARY

January


(S) The month of January 1973 was characterized by continued planning for the several possible contingencies which might result from a cessation of hostilities in South Vietnam and two major changes in the geographical areas into which combat sorties were flown.







- (S) Air-to-ground combat sorties continued at a high level from the 1st of January until the 13th of January with missions being flown into MR-1 and MR-2 of South Vietnam, Barrel Roll, and Steel Tiger areas of Laos and Route Package One of North Vietnam. On 14 January all combat sorties into North Vietnam were suspended with the result that the A-6 Intruders shifted their night road recce flights from RP-1 to Steel Tiger East in Laos. All combat operations in both North and South Vietnam were suspended on 28 January as a result of the ceasefire agreement and combat operations shifted entirely to Laos at a greatly reduced pace. Night road recce A-6 missions over Steel Tiger were suspended at this time.
- (S) With indications of a successful conclusion to a ceasefire agreement in Vietnam becoming very strong by mid month, contingency planning for the numerous possible changes that could take place in a post ceasefire period was accelerated.
- (U) MAG-15 participated in an open house for our Thai hosts on 13 January 1973. The smiling faces of the many Thai children present indicated a very successful event.
- (U) Major General M. P. RYAN, CG, III MAF and Major General L. E. BROWN, CG, 1st MAW visited Nam Phong RTAFB on 13 January in conjunction with visits to various Marine air and ground units in South East Asia. Both were briefed by members of the MAG-15 Staff.
- (U) Lieutenant General L. R. WILSON Jr., CG, FMFPac visited Nam Phong RTAFB on 22 January in conjunction with a visit to Marine units in South East Asia. He was briefed by members of the MAG-15 Staff on redeployment contingency plans.
- (U) On 27 January the last section of aircraft from MAG-15 refueled and rearmed at DaNang AB, South Vietnam. These aircraft from VMFA-232 were flown by Capt J. F. LUHMANN (pilot), Lt S. A. POLING (RIO) and Capt R. L. CAMPBELL (pilot), Capt J. C. CHURCH (RIO).
- (U) H&MS-15 Detachment 'A' redeployed to Nam Phong RTAFB, Thailand from DaNang AB, South Vietnam on 29 January, thereby terminating all MAG-15 operations in South Vietnam.





February

- (S) The month of February was highlighted by fluctuating combat requirements. The reduced fragged sorties rate which resulted from the Vietnam ceasefire was increased to near the pre-ceasefire level by mid-month and continued until the Laotian ceasefire on 22 February 1973. On 25 February, MAG-15 conducted combat operations in Cambodia.
- (C) Retrograde/redeployment planning continued in conjunction with combat operations and training. A survey team was sent to Iwakuni to investigate conditions in the areas formerly utilized by MAG-15. Preparations were made to receive the Group should it return to MCAS Iwakuni.
- (C) Planning for the eventuality of remaining in place at Nam Phong also continued. Training schedules were prepared and tested for use in a peace time environment.
- (U) MGen L. E. BROWN, CG, 1st MAW, visited MAG-15 3-4 February and received update briefings on combat air operations and contingency plans.
- (U) On 5 February, a flight of F-h's from VMFA-232 inadvertently jettisoned 22 MK-82 bombs 2 miles west of the Udorn jettison area. One Thai was killed, one small living structure was destroyed, and the surrounding rice fields were damaged. A condolence call was made by the CO, MAG-15. All claims were settled by the appropriate U.S. agency.
- (U) USAF Officers LtCol WILLIAMS, LtCol O'BRIEN, and Maj STRUCKLAND visited Nam Phong on 9 February. They represented the office of the Deputy Assistant Secretary of Defense for Drug and Alcohol Abuse. Their purpose was to review drug and alcohol abuse programs at various bases in Thailand. A briefing was held followed by a short tour of the base.
- (U) An accident occurred on 17 February involving the contract Marine liberty bus and Thai Esso oil truck. One Marine was killed, five Marines were seriously injured, and fifteen Marines sustained minor injuries. One Thai civilian was killed and a second Thai civilian was seriously injured. The USAF hospital at RTAFB, Udorn provided emergency treatment for those Marines seriously injured prior to their being medically evacuated to hospitals with better facilities.

(U) MAG-15 hosted the officers of Task Force Delta at a mess night 27 February at the Rose Garden restaurant. Col A. W. TALBERT, CO, MAG-15, presided. BGen R. W. TAYLOR, CG, Task Force Delta, and Col NIMOL, CO, RTAFB Nam Phong were guests of honor. UNGLASSIFIED



- (S) For the first time since April 1972, it appeared that MAG-15 would not be involved in combat air operations in South East Asia. Then on 30 March combat flight operations resumed to the Khmer Republic. Prior to the resumption of combat operations, retrograde and contingency plans were under continual review and updating; a vigorous air crew training syllabus was continued, minor base improvements continued, and a new weekly work schedule was instituted. In addition numerous dignitaries were given briefings and tours of the facility.
- (S) Combat air operations resumed for MAG-15 on 30 March. The mission has been visual air-to-ground ordnance delivery flown by VMFA-115 and VMFA-232. VMA(AW)-533 was not committed at this time.
- (C) OPLAN SUNSET was reviewed and adjusted as update information was received. Various contingency plans for possible future deployments were also discussed and staffed.
- (U) The three assigned aircraft squadrons carried on a vigorous training program which highlighted efficiency of operation within the local restrictions of airspace and time periods available. Full systems aircraft continue to be the goal. This has afforded high quality training. Outstanding support for training conducted was provided by VMCR-152 Det Delta, and the 621st Tactical Control Squadron, USAF.
- (U) Local improvements included the application of a dust pallative to all the roads. More living quarters were converted from tent to tin roofs.
- (U) A new weekly work schedule was instituted which afforded increased free time. This has provided an opportunity for additional utilization of recreational facilities which included Massey Field (an all sports area), an air-conditioned library, and an improvised gym.
- (U) During the month the following dignitaries visited MAG-15 in conjunction with a visit to Task Force Delta: LtGen C. A. CORCORAN, Chief of Staff, CINCPAC, MGen L. E. BROWN, CG, First MAW, MGen M. P. RYAN, CG, III MAF, and BGen VENADAS, Chief of Military Planning Office, SEATO. The visiting dignitaries were briefed on operations and future plans by the MAG-15 Commanding Officer and key members of the staff.
- (U) Col A. W. TALBERT, MAG-15 Commanding Officer, visited Iwakuni from 25 to 30 March for update briefings on contingency plans involving First MAW units.





- (S) The month of April marked one full 12 month period of combat air operations in Southeast Asia.
- (U) During the month, the Commanding General, First Marine Aircraft Wing, MGen L.E. BROWN and Commanding General, Third MAF, MGen M.P. RYAN visited MAG-15 and were briefed on operations and Contingency Plans of MAG-15 Units. Also included in their visit, was a tour of RTAFB Nam Phong. Improvements in living conditions and messing facilities at Nam Phong were topics of discussion during the tour.

May

- (S) In addition to the continued air-to-ground mission of the F-4 Squadrons and emphasised training in air-to-air combat for possible contingency operations over Laos, the A-6A squadron, VMA(AW)-533, commenced all weather/night bombing in Cambodia.
- (U) On 7 May, the new CG, First MAW, MGen F.C. LANG, visited MAG-15 for update briefs on combat operations and readiness of MAG-15 units. MGEN M.P. RYAN, CG Third MAF also visited briefly this date.
- (U) Local improvements included receipt of louvering material and application to quarters and working spaces in preparation for rainy season.
- (U) On 28 May, training flights were minimized while Memorial Day services and field meet were held at Massey Field. All MAG-15 units participated in the days events.

June

- (U) General R.E. CUSHMAN, Commandant of the Marine Corps, visited MAG-15 for briefing on operational readiness and contingency plans. Visit also included tour of MAG-15 area and visited with enlisted personnel in their billeting area.
- (U) On 9 June, MAG-15 hosted the officers of Task Force Delta at a mess night at the Oasis Restaurant. Col A.W. TALBERT, CO, MAG-15, presided: Col William CLEMENT, USAF, CO, 432d Tactical Reconnaissance Wing RTAFB Udorn was the guest of honor. Individual unit party suits were worn adding color to the evening.
- (U) Admiral J.C. DONALDSON, USN, COMFAIRWESTPAC visited MAG-15 on 5 June for update briefs on MAG-15 operations, supply and maintenance.
- (C) OPLAN Sunset received further review to ensure its compatability with actual requirements.





NARRATIVE SUMMARY

- (C) During the period 1 January 1973 thru 25 February 1973 all three operating squadrons of Marine Aircraft Group 15 continued to fly combat support missions in the Republic of Vietnam, Laos, North Vietnam and 6 missions in Cambodia. During this period the Group Intelligence Section (S-2) conducted 830 brief's and 830 de-brief's of aircrew involved in these combat support missions.
- (U) During the month of January the Group S-2 prepared 304 SEA AIROPS Reports (OPREP-4) and 31 Intelligence Summaries (INTSUM). During the month of February 45 OPREP-4's and 22 INTSUM's were prepared.
- (U) On 12 March the Group S-2 conducted an Intelligence brief on the situation in the Middle East. The briefing included Order of Battle of both Israel and Arab States, Arab territory held by Israeli Troops, and the political and economic status of both sides. Also during the month of March 2 INTSUM's were prepared by the S-2.
- (S) On the 30th of March, Marine Aircraft Group 15 was fragged to fly 12 sorties per day to assist in destroying enemy supply caches and interdicting enemy lines of communication in Cambodia. The Group S-2 responded to this commitment by conducting 694 brief's and 694 de-brief's from 30 March to 30 June 1973. The Group S-2 also prepared 316 OPREP-4's and 93 INTSUM's during this period.
- (U) From 1 January: to 30 June 1973 the Group S-2 Administration Sect on granted 39 Top Secret Clearances, 41 Secret Clearances, and downgraded 35 Top Secret Clearances to Secret.
- (U) During the period 1 January to 30 June 1973 members of Group S-2 have maintained laision with the 432nd Tactical Reconnaissance Wing (432nd TRW) USAF, located at the Royal Thai Air Force Base, Udorn, Thailand. Officer's and enlisted personnel attended USAF strike briefing's and de-briefing's conducted at the 432nd TRW Headquarters.
- (U) On 1 June 1973 1st Lt. ARCON, an Intelligence Officer with the 432nd TRW presented a brief on Communist Weapons Systems in South East Asia to aircrew personnel of VMA (AW)-533.
- (U) On 23 June 1973 CWO-3 R. D. WEBB relievedCWO-2 T. R. BURNHAM as Group Intelligence Officer. CWO-3 WEBB made a laision visit to the 432nd TRW, RTAFB Udorn, Thailand on 14-16 June and attended the Intelligence/SEA AIROPS Reports (Intel/OPREP-4) Conference hosted by the United States Special Activities Group (USSAG) at the RTAFB Nakhon Phanom, Thailand on 25-27 June 1973.

- (U) Since 1 January the Group S-2 Briefing Section has continued to give a New Aircrew/SEA INTELLIGENCE, SURVIVAL, EVASION, SEARCH, and RESCUE briefing/training. The SAR training is conducted by inserting the new aircrew into unfamiliar terrain by helicopter. Once inserted, aircrews are required to reach a pre-designated area. On reaching the area, personnel are required to use flares, a mirror, and radio equipment in attempts to vector the helicopter to their position. When satisfactory use of survival equipment is accomplished, aircrews are then extracted through the use of the Jungle Penetrator lowered by the SAR helicopter. Since 1 January 66 aircrewman have completed the SAR training. This training enhances aircrew confidence in SAR equipment.
- Prior to April 1973 anti aircraft defenses consisted mainly of small arms and 12.7mm fire. However, since then additional weapons have been introduced and/or increased. These consist of the 23mm, 37mm and the SA-7 (Surface to Air Missile). Concentrations of defenses are mainly along major Khmer insurgent, LOGs.

 A 57mm High Threat Area was established southwest of Pleiku, South Vietnam and includes a portion of Khmer and Route 19. However, MAG-15 aircrews have not encountered 57mm fire in there area of operations.
- (S) On 24 June 1973 the first SA-7 firing incident occured approximately 10 nm south of Phnom Penh, when three SA-7's were fired at a WSAF AC 130. The gunship, flying at 7,200 feet, expended 16XALE-17 flares which the missiles reacted on and exploded 15-20 feet below the aircraft.



Narrative Summary

1. (S) JANUARY - Combat flight operations continued from the Nam Phong Royal Thai Air Force Base at a pace equivalent to that of previous months.





MAG-15 squadrons logged 975 combat sorties and 1603 hours delivering 2886 tons of ordnance.

- a. From 1 through 13 January combat flight operations continued in MR-1 and MR-2 of South Vietnam, south of the 20th parallel in North Vietnam and in Laos. From 14 January until 27 January all combat operations in North Vietnam were suspended. At this time A-6 night road recce operations were shifted to the Steel Tiger area of Laos. From 28 January until the end of the month combat operations in all of North and South Vietnam were halted as a result of the Vietnam Cease-Fire agreement. This resulted in a reduction of fragged combat sorties from 37 to 18 per day and suspended the A-6 night systems flying. Bad weather was not a significant factor during the month.
- b. On 27 January, the last MAG-15 aircraft was refueled and rearmed at DaNang by H&MS-15 Det A in support of combat operations in South Vietnam.
- c. LtCol F. J. ANDERSEN attended an operations/training conference at 7/13 AF, Udorn RTAFB on 30 January to discuss the implementation of training flight operations in Thailand during the post Vietnam Cease-Fire period.
- 2. (S) FEBRUARY Combat flight operations continued from the Nam Phong Royal Thai Air Force Base at a fluctuating pace. The majority of the combat flights were in Laos with 12 sorties being flown to Cambodia on 25 February. MAG-15 squadron logged 776 sorties and 1166 hours delivering 1566 tons of ordnance. Combat operations consisted of day visual bombing by the three assigned tactical squadrons and night armed road recce by VMA (AW)-533 into both the Barrel Roll and Steel Tiger areas of Laos. Although the increased haze and smoke which is typical of this area during this time of year did not significantly hamper operations, it did prevent the accumulation of an accurate bomb damage assessment for the period.
- a. On 10 February the fragged sortie rate was changed from 23 sorties per day to 33 sorties per day. This sortie rate continued until the ceasefire went into effect at 1200G on 22 February. VMFA-115 and VMFA-232 flew 26 of the sorties as day visual DAS, and VMA(AL)-533 flew 2 day DAS and 5 night armed road recce sorties per day.
- b. On 25 February, 12 sorties were flown by MAG-15 squadrons into Cambodia. This was the first time MAG-15 aircraft had operated in that theater of operations.
- c. Since the Laotion cease-fire on 22 February MAG-15 has instituted as rigorous a flight training schedule as is permitted under airspace restrictions. Air intercept, night flying, navigation, and instrument work has been emphasized. Arrangements are under way to expand training to ACM and night aerial refueling.

- d. LtCol E. J. ANDERSEN attended a conference in Bangkok with USAF counterparts 21-23 February to discuss the proposed use of training areas in Thailand.
- 3. (S) MARCH During early March an intensive training program was undertaken. A work schedule of five flying days and one ground training day was established. During the month 627 training sorties for 990 hours were flown by the three aircraft squadrons of MAG-15. Flight training included day and night instrument, navigation, formation, air intercept, and aerial refueling sorties, plus day air combat maneuvering and field mirror landing practice.
- a. In late March the decision to employ MAG-15 assets in the Khmer Republic necessitated a reduction in proposed training. On 25 March LtCol E. J. ANDERSEN visited the United States Support Activities Group (USSAG) Headquarters at Nakhon Phanom, Thailand to commence planning for this employment. A sortie rate of 0.5 for on-hand F-4 assets was assigned. A-6 assets were not committed. An additional visit was made by LtCol ANDERSEN and Maj A. P. LORING, G-3, Task Force Delta, on 27 March to finalize the concept of operations. Within five days of initial notifications aircraft were reconfigured, tanker assets were provided, and MAG-15 returned to combat 30 March 1973.
- 4. (S) APRIL Cambodian combat operations continued with the F-4 squadrons fragged for 12 sorties each day by the 7th Air Force. The squadrons flew 340 combat sorties and logged 761 combat hours delivering 687 tons of ordnance. In addition, 382 training sorties were flown logging 625 hours by MAG-15 squadrons. Combat operations consisted of day visual bombing on targets assigned by the 7th Air Force. The length of the missions required pre-strike refueling and occassionally, depending on the time required to be in the target area, post strike refueling. VMGR-152 KC-130 tankers staging from Nam Phong provided the aerial refueling. Training flights included day and night instrument, navigation, formation, air intercept, aerial refueling, and day air combat maneuvering sorties.
- a. On 11 April LtCol E. J. ANDERSEN visited USSAG/7th AF at NKP to explore the subject of A-6 combat operations in Cambodia. All discussions were at the "action officer" level. Discussions centered on the use of the A-6 in an all-weather role which was being flown only by B-52's and F-111's. To use the A-6 in the all-weather role will require action by USSAG to change the rules of engagement. The possibility exists that the A-6's may be used in the future.
- b. On 17 April LtCol ANDERSEN attended a Joint Use Training Area Conference at the 13 AF ADVON Udorn RTAFB to finalize and schedule the training areas for May.
- 5. (S) MAY Combat and training operations continued during the month of May. MAG-15 squadrons logged 426 combat sorties and 953 hours delivering

977 tons of ordnance. In addition 366 training sorties were flown log-ging 587 hours. Combat operations were flown in Cambodia with the F-4's dropping visual under FAC control and the A-6's flying night missions engaging moving targets of opportunity along specifically assigned lines of communication. Training sorties included instrument, navigation, air combat maneuvering, air intercept and radar beacon bombing practice.

- a. Maj A. P. LORING assumed the position of MAG-15 S-3 Officer relieving LtCol E. J. ANDERSEN who returned to CONUS.
- b. The 8th of May, Maj A. P. LORING visited USSAG/7th AF to discuss employment of the A-6 aircraft for night combat operations in Cambodia. As a result of this visit the A-6's commenced night operations the 11th of May. Five armed recce missions were to be fragged over known enemy lines of communication. Additionally, the aircraft could be diverted to engage radar significant targets that were considered to be time sensitive. Radar beacon bombing was not authorized.
- c. On 17 May, Maj LORING again visited USSAG for the purpose of briefing Gen VOGT, USSAG Commander on the A-6 beacon capability. As a result of this briefing, the A-6 AMTI missions will inform ABCCC on check-in of their beacon capability and can be expected to divert to a beacon target. All drops will be on a new beacon until the A-6 bomb signature is established.
- d. On the 21st of May Maj LORING attended the Joint Training Areas Conference at 13th ADVON RTAFB to finalize and schedule the training areas for June.
- e. On 22 May Capt K. D. EDELEN departed Nam Phong for NAS Cubi Point, P. I. to effect liaison prior to VMFA-115's missile firex deployment scheduled for 25 May.
- f. On 26 May VMFA-115 aircrews and aircraft departed for NAS Cubi Point. The missile firex was scheduled to commence on 29 May with missile firings and ACM training scheduled in the A.M. Eight AIM-7 and seven AIM-9 missiles were fired the first three days of the firex, 29, 30, and 31 May.
- g. LtCol R. PLANT arrived the 27th of May to relieve Maj A. P. LORING as MAG-15 S-3 Officer. On 29 May LtCol PLANT and Maj LORING visited USSAG/7th AF Headquarters. Purpose of the visit was to introduce LtCol PLANT and discuss MAG-15 Combat Operations.






- 6. (S) JUNE Combat and training operations continued from Nam Phong at a pace equivalent to that of the month of May. VMFA-115 completed a successful missile firex and returned to the Rose Garden. Combat flights accumulated 461 sorties and 1036 hours delivering 1081 tons of ordnance in Cambodia. Training sorties were down from the previous two months to 265 sorties and 381 hours due to VMFA-232 flying the combat sorties normally flown by VMFA-115 while VMFA-115 was deployed to NAS Cubi Point, and the increase of weather in the training areas with the oncoming monsoon season. Combat opertions consisted of day visual bombing under FAC control for the F-4's and armed recce using AMTI as the primary mission for the A-6's. Commencing 16 June the A-6's commenced dropping off the newly operational radar beacon in an effort to validate the accuracy of the A-6 system. Training flights consisted of instrument, navigation, air intercept, air combat maneuvering, and radar beacon bombing practice.
- a. On 4 June, Capt K. D. EDEIEN attended a plans conference at the 13th ADVCN, Udorn RTAFB to discuss the impact of requiring all training flights to file ICAO flight plans. As a result of the conference, all Wings/Groups flying in Thailand are required to prepare and submit proposed stereotype flight plans for all non-tactical flights. Implementation into the ICAO system is anticipated during August.
- b. WFA-115 returned from NAS Cubi Point the 8th of June after a successful missile firex. Nineteen AIM-7 and 16 AIM-9 missiles were expended. Eleven aircrews were qualified or regualified with the F-4 weapon system.
- c. On 13 June Capt EDELEN attended the Joint Use Training Area Conference at 13th ADVON Udorn RTAFB to finalize and schedule the training areas for July.
- d. On 26 June LtCol R. PLANT visited USSAG/7th AF NKP Thailand to attend a combat Reports Review conference and effect liaison prior to MGen LANG's visit on the 29th. In addition this provided the opportunity to discuss NAG-15 operations in Cambodia with the Fighter Frag Shop.

NARRATIVE SUMMARY

During January the following projects were completed and accepted by MAG-15: new quarters for MAG-15 C.O. and X.O., 3M building converted to a temporary detention facility; fabrication of numerous embarkation boxes; reefers redistributed and wired in to clubs from Mess Hall #2; Bob Hope stage was lighted for future USO Shows; wiring and lighting of the Craftech building by AMPAC.

On 22 January Lt. Gen. WILSON, C.G. FMFPAC arrived at Nam Phong. The purpose of the visit was to receive a briefing/update by the Task Force Delta/MAG-15 Staff.

On 29 January VMGR-152 airlifted H&MS-15 Det Alpha from Danang to Nam Phong. A ten hour period and six trips were required to move 50 tons of cargo and 22 passengers using three KC-130 aircraft.

On 30 January the CG, Task Force Delta's Quickcamp modules were custom inspected, secured and prepared for shipment to Sattahip and Port Hueneme, California.

The following projects were completed and accepted by MAG-15 in the month of February: Concrete pads and drainage at the dog compound; new detention facility was completed; fabrication of numerous embarkation boxes; shipment of C.G. Task Force Delta's Quickcamp modules; numbering of all real property; preparation of C.G. Task Force Delta's sleeping van for air shipment to Iwakuni.

The following projects were initiated in February: Laying of pipe for the shower facilities; security lighting and fencing for base security.

MAG-15 Group Supply accepted and occupied their two Craftech buildings in February.

The Group Commander and the Group Embarkation Staff held embarkation inspections of VMA(AW)-533, VMFA-115, and H&MS-15.

The following projects were completed and accepted by MAG-15 during March: fabrication of embarkation boxes; security fence was completed around detention facility; new road surface surfaces; shipment for two (2) supply vans to Iwakuni; paving of entrance to Group Headquarters and hospital parking areas; sea huts for Group SgtMajor and MATCU equipment storage were completed; movement and retrofit of sea hut to VMGR-152 area for flight crew living spaces; construction of guard tower for base operations; complete new drain system for mess hall; water tank construction completed for RTAF; MABS installed security lighting between 0 club and Staff Club.

NARRATIVE SUMMARY (Cont.)

Lt. Gen CORCORAN, U.S.A. Chief of Staff CINCPAC was aboard for MAG-15/TFD briefings; Major General L. E. BROWN was aboard for MAG-15/TFD briefings. plus unit and element visits; Maj General RYAN, CG III MAF was aboard for MAG-15/TFD briefings.

Projects completed in April included: conversion of MAG-15 cantonment strong back tents to sea huts; non skid painting of fuel pit area; valve installed in main water line for use by Thai locals; movement of one sea hut to VMGR-152 Det D area.

Inspections of the security fencing and lighting were conducted with the lighting portion being accepted for use on 30 April.

Major General BROWN was in Nam Phong on 10 April to discuss monsoon preparation requirements.

In May information and repair materials for MAG-15 Craftech buildings and establishment of a garrison property account were requested. Work was initiated on a cooling modification on the Mess Hall, sea hut loovering, and drainage system repairs. A detachment from VMFA-115 was airlifted to Cubi Point for missile shoot on 25 May. Three (3) C-141 and one (1) C-130 aircraft were required to airlift 58 passengers and 29 short tons of cargo.

Maj General RYAN and Major General BROWN were briefed on 7 May.

During June major projects consisted of: strong back tents to sea huts conversion completed; excess usable furniture was requested and started arriving; MAG-15 reception center constructed; security and lighting completed; construction of approximately 100 embark boxes; three 24 hours showers installed; cleaning and reshaping of drain system including installation of new culverts 85% completed; completion of Mess Hall cooling modification; cantonment loovers 75% completed.

An airlift consisting of four (4) Air Force (PATMA) C-130 aircraft and one (1) Marine C-130 making one (1) trip each returned VMFA-115 missile shoot detachment from Cubi Point on 9 and 10 June. Sixty-two passengers and 20 short tons of cargo comprised the return airlift.

NARRATIVE SUMMARY

- (C) During the period 1 January 1973 thru 25 February 1973 all three operating squadrons of Marine Aircraft Group 15 continued to fly combat support missions in the Republic of Vietnam, Laos, orth Vietnam and 6 missions in Cambodia. During this period the coup Intelligence Section (S-2) conducted 830 brief's and 830 de-brief's of aircrew involved in these combat support missions.
- (U) During the month of January the Group S-2 prepared 304 SEA AIROPS Reports (OPREP-4) and 31 Intelligence Summaries (INTSUM). During the month of February 45 OPREP-4's and 22 INTSUM's were prepared.
- (U) On 12 March the Group S-2 conducted an Intelligence brief on the situation in the Middle East. The briefing included Order of Battle of both Israel and Arab States, Arab territory held by Israeli Troops, and the political and economic status of both sides. Also during the month of March 2 INTSUM's were prepared by the S-2.
- (S) On the 30th of March, Marine Aircraft Group 15 was fragged to fly 12 sorties per day to assist in destroying enemy supply caches and interdicting enemy lines of communication in Cambodia. The Group S-2 responded to this commitment by conducting 694 brief's and 694 ae-brief's from 30 March to 30 June 1973. The Group S-2 also prepared 316 OPREP-4's and 93 INTSUM's during this period.
- (U) From 1 January: to 30 June 1973 the Group S-2 Administration Section granted 39 Top Secret Clearances, 41 Secret Clearances, and downgraded 35 Top Secret Clearances to Secret.
- (U) During the period 1 January to 30 June 1973 members of Group S-2 have maintained laision with the 432nd Tactical Reconnaissance Wing (432nd TRW) USAF, located at the Royal Thai Air Force Base, Udorn, Thailand. Officer's and enlisted personnel attended USAF strike briefing's and de-briefing's conducted at the 432nd TRW Headquarters.
- (U) On 1 June 1973 1st Lt. ARGON, an Intelligence Officer with the 432nd TRW presented a brief on Communist Weapons Systems in South East Asia to aircrew personnel of VMA (AW)-533.
- (U) On 23 June 1973 CWO-3 R. D. WEBB relievedCWO-2 T. R. BURNHAM as Group Intelligence Officer. CWO-3 WEBB made a laision visit to the 432nd TRW, RTAFB Udorn, Thailand on 14-16 June and attended the Intelligence/SEA AIROPS Reports (Intel/OPREP-4) Conference hosted by the United States Special Activities Group (USSAG) at the RTAFB Nakhon Phanom, Thailand on 25-27 June 1973.

- (U) Since 1 January the Group S-2 Briefing Section has continued to give a New Aircrew/SEA INTELLIGENCE, SURVIVAL, EVASION, SEARCH, and RESCUE briefing/training. The SAR training is conducted by inserting the new aircrew into unfamiliar terrain by helicopter. Once inserted, aircrews are required to reach a pre-designated area. On reaching the area, personnel are required to use flares, a mirror, and radio equipment in attempts to vector the helicopter to their position. When satisfactory use of survival equipment is accomplished, aircrews are then extracted through the use of the Jungle Penetrator lowered by the SAR helicopter. Since 1 January 66 aircrewman have completed the SAR training. This training enhances aircrew confidence in SAR equipment.
- (S) Anti Aircraft Defenses in Cambodia (Khmer)
 Prior to April 1973 anti aircraft defenses consisted mainly of
 small arms and 12.7mm fire. However, since then additional weapons
 have been introduced and/or increased. These consist of the 23mm, 37mm
 and the SA-7 (Surface to Air Missile). Concentrations of defenses are
 mainly along major Khmer insurgent LOCs. A 57mm High Threat Area
 was established southwest of Pleiku, South Vietnam and includes a
 portion of Khmer and Route 19. However, MAG-15 aircrews have not
 encountered 57mm fire in there area of operations.
- (S) On 24 June 1973 the first SA-7 firing incident occured approximately 10 nm south of Phnom Penh, when three SA-7's were fired at a USAF AC 130. The gunship, flying at 7,200 feet, expended 16XALE-17 flares which the missiles reacted on and exploded 15-20 feet below the aircraft.

Narrative Summary

1. (S) JANUARY - Combat flight operations continued from the Nam Phong Royal Thai Air Force Base at a pace equivalent to that of previous months.

MAG-15 squadrons logged 975 combat sorties and 1603 hours delivering 2886 tons of ordnance.

- a. From 1 through 13 January combat flight operations continued in MR-1 and MR-2 of South Vietnam, south of the 20th parallel in North Vietnam and in Laos. From 14 January until 27 January all combat operations in North Vietnam were suspended. At this time A-6 night road recce operations were shifted to the Steel Tiger area of Laos. From 28 January until the end of the month combat operations in all of North and South Vietnam yere halted as a result of the Vietnam Cease-Fire agreement. This resulted in a reduction of fragged combat sorties from 37 to 18 per day and suspended the A-6 night systems flying. Bad weather was not a significant factor during the month.
- b. In 27 January, the last MAG-15 aircraft was refueled and rearmed at DaNang by H&NS-15 Det A in support of combat operations in South-Vietnam.
- c. LtCol E. J. ANDERSEN attended an operations/training conference at 7/13 AF, Udorn RTAFB on 30 January to discuss the implementation of training flight operations in Thailand during the post Vietnam Cease-Fire period.
- 2. (S) FEBRUARY Combat flight operations continued from the Nam Fhong Royal Thai Air Force Base at a fluctuating pace. The majority of the combat flights were in Laos with 12 sorties being flown to Cambodia on 25 February. NAG-15 squadron logged 776 sorties and 1166 hours delivering 1566 tons of ordnance. Combat operations consisted of day visual bombing by the three assigned tactical squadrons and night armed road recce by VMA (AW)-533 into both the Barrel Roll and Steel Tiger areas of Laos. Although the increased haze and smoke which is typical of this area during this time of year did not significantly hamper operations, it did prevent the accumulation of an accurate bomb damage assessment for the period.
- a. On 10 February the fragged sortie rate was changed from 23 sorties per day to 33 sorties per day. This sortie rate continued until the ceasefire went into effect at 1200G on 22 February. VMFA-115 and VMFA-234 flew 26 of the sorties as day visual DAS, and VMA(AW)-533 flew 2 day DAW and 5 night armed road recce sorties per day.
- b. On 25 February, 12 sorties were flown by MAG-15 squadrons into Cambodia. This was the first time NAG-15 aircraft had operated in that theater of operations.
- c. Since the Laction cease-fire on 22 February MAG-15 has instituted as rigorous a flight training schedule as is permitted under airspace restrictions. Air intercept, night flying, navigation, and instrument work has been emphasized. Arrangements are under way to expand training to ACM and night aerial refueling.

- d. LtCol E. J. ANDERSEN attended a conference in Bangkok with USAF counterparts 21-23 February to discuss the proposed use of training areas in Thailand.
- 3. (S) MARCH During early March an intensive training program was undertaken. A work schedule of five flying days and one ground training day was established. During the month 627 training sorties for 990 hours were flown by the three aircraft squadrons of MAG-15. Flight training included day and night instrument, navigation, formation, air intercept, and aerial refueling sorties, plus day air combat maneuvering and field mirror landing practice.
- a. In late March the decision to employ MAG-15 assets in the Khmer Republic necessitated a reduction in proposed training. On 25 March LtCol E. J. ANDERSEN visited the United States Support Activities Group (USSAG) Headquarters at Nakhon Phanom, Thailand to commence planning for this employment. A sortic rate of 0.5 for on-hand F-4 assets was assigned. A-6 assets were not committed. An additional visit was made by LtCol ANDERSEN and Maj A. P. LORING, G-3, Task Force Delta, on 27 March to finalize the concept of operations. Within five days of initial notifications aircraft were reconfigured, tanker assets were provided, and MAG-15 returned to combat 30 March 1973.
- 4. (S) APRIL Cambodian combat operations continued with the F-4 squadrons fragged for 12 sorties each day by the 7th Air Force. The squadrons flew 340 combat sorties and logged 761 combat hours delivering 687 tons of ordnance. In addition, 382 training sorties were flown logging 625 hours by MAG-15 squadrons. Combat operations consisted of day visual bombing on targets assigned by the 7th Air Force. The length of the missions required pre-strike refueling and occassionally, depending on the time required to be in the target area, post strike refueling. VMGR-152 KC-130 tankers staging from Nam Phong provided the aerial refueling. Training flights included day and night instrument, navigation, formation, air intercept, aerial refueling, and day air combat maneuvering sorties.
- On 11 April LtCol E. J. ANDERSEN visited USSAG/7th AF at NKP to explore the subject of A-6 combat operations in Cambodia. All discussions were at the "action officer" level. Discussions centered on the use of the A-6 in an all-weather role which was being flown only by B-52's and F-111's. To use the A-6 in the all-weather role will require action by USSAG to change the rules of engagement. The possibility exists that the A-6's may be used in the future.
- b. On 17 April LtCol ANDERSEN attended a Joint Use Training Area Conference at the 13 AF ADVON Udorn RTAFB to finalize and schedule the training areas for May.
- 5. (S) MAY Combat and training operations continued during the month of May. MAG-15 squadrons logged 426 combat sorties and 953 hours delivering

977 tons of ordinance. In addition 366 training sortics were flown logging 587 hours. Combat operations were flown in Cambodia with the F-4's dropping visual under FAC control and the A-6's flying night missions engaging moving targets of opportunity along specifically assigned lines of communication. Training sorties included instrument, navigation, air combat maneuvering, air intercept and radar beacon bombing practice.

a. Maj A. P. LORING assumed the position of MAG-15 S-3 Officer relieving LtCol E. J. ANDERSEN who returned to CONUS.

b. The 8th of May, Maj A. P. LORING visited USSAG/7th AF to discuss employment of the A-6 aircraft for night combat operations in Cambodia. As a result of this visit the A-6's commenced night operations the 11th of May. Five armed recce missions were to be fragged over known enemy lines of communication. Additionally, the aircraft could be diverted to engage radar significant targets that were considered to be time sensitive. Nadar beacon bombing was not authorized.

- c. On 17 May, Maj LORING again visited USSAG for the purpose of briefing Gen VOGT, USSAG Commander on the A-6 beacon capability. As a result of this briefing, the A-6 AMTI missions will inform ABCCC on check-in of their beacon capability and can be expected to divert to a beacon target. All drops will be on a new beacon until the A-6 bomb signature is established.
- d. On the 21st of May Maj LORING attended the Joint Training Areas Conference at 13th ADVON RTAFB to finalize and schedule the training areas for June.
- e. On 22 May Capt K. D. EDELEN departed Nam Phong for NAS Cubi Point, P. I. to effect liaison prior to VMFA-115's missile firex deployment scheduled for 25 May.
- f. On 26 May VMFA-115 aircrews and aircraft departed for NAS Cubi Foint. The missile firex was scheduled to commence on 29 May with missile firings and ACM training scheduled in the A.M. Eight AIM-7 and seven AIM-9 missiles were fired the first three days of the firex, 29, 30, and 31 May.
- g. LtCol R. PLANT arrived the 27th of May to relieve Maj A. P. LORING as MAG-15 S-3 Officer. On 29 May LtCol PLANT and Maj LORING visited USSAG/7th AF Headquarters. Purpose of the visit was to introduce LtCol PLANT and discuss MAG-15 Combat Operations.

- 6. (C) JUNE Combat and training operations continued from Nam Phong at a pace equivalent to that of the month of May. VMFA-115 completed a successful missile firex and returned to the Rose Garden. Combat flights accumulated 461 sorties and 1036 hours delivering 1081 tons of ordnance in Cambodia. Training sorties were down from the previous two months to 265 sorties and 361 hours due to VMFA-232 flying the combat sorties normally flown by VMFA-115 while VMFA-115 was deployed to NAS Cubi Point, and the increase of weather in the training areas with the oncoming monsoon season. Combat operations consisted of day visual bombing under FAC control for the F-4's and armed recce using AMTI as the primary mission for the A-6's. Commencing 16 June the A-6's commenced dropping off the newly operational radar beacon in an effort to validate the accuracy of the A-6 system. Training flight consisted of instrument, navigation, air intercept, air combat managevering, and radar beacon bombing practice.
- a. On 4 June, Capt K. E. EDELEN attended a plans conference at the 13th ADVON, Udorn RTAFB to discuss the impact of requiring all training flights to file ICAO flight plans. As a result of the conference, all Wings/Groups flying in Thailand are required to prepare and submit proposed stereotype flight plans for all non-tactical flights. Implementation into the ICAO system is anticipated during August.
- cessful missile firex. Nineteen AIM-7 and 16 AIM-9 missiles were expended. Eleven aircrews were qualified or regualified with the F-4 weapon system.
- on 13 June Capt EDELEN attended the Joint Use Training Area Conference at 1. Sh ADVON Udorn RTAFB to finalize and schedule the training areas for July.
- d. On 26 June LtCol R. PLANT visited USSAC/7th AF NKP Thailand to attend a combat Reports Review conference and effect liaison prior to MGen LANG's visit on the 29th. In addition this provided the opportunity to discuss MAC-15 operations in Cambodia with the Fighter Frag Shop.

NARRATIVE SUMMARY

During January the following projects were completed and accepted by MAG-15: new quarters for MAG-15 C.O. and X.O., 3M building converted to a temporary detention facility; fabrication of numerous embarkation boxes; recens redistributed and wired in to clubs from Mess Hall #2; Bob Hope stage wa. lighted for future USO Shows; wiring and lighting of the Craftech building by AMPAC.

On 22 January Lt. Gen. WILSON, C.G. FMFPAC arrived at Nam Phong. The purpose of the visit was to receive a briefing/update by the Task Force Delta/MAG-15 Staff.

On 29 January VMGR-152 airlifted H&MS-15 Det Alpha from Danang to Nam Phong. A ten hour period and six trips were required to move 50 tons of cargo and 22 passengers using three KC-130 aircraft.

On 30 January the CG, Task Force Delta's Quickcamp modules were custom inspected, secured and prepared for shipment to Sattahip and Port Hueneme, California.

The following projects were completed and accepted by MAG-15 in the month of February: Concrete pads and drainage at the dog compound; new detention facility were completed; fabrication of numerous embarkation boxes; shipment of C.G. Talk Force Delta's Quickcamp modules; numbering of all real property; preparation of C.G. Task Force Delta's sleeping van for air shipment to Iwakuni.

The following projects were initiated in February: Laying of pipe for the shower facilities; security lighting and fencing for base security.

MAG-15 Group Supply accepted and occupied their two Craftech buildings in February.

The Group Commander and the Group Embarkation Staff held embarkation inspections of VMA(AW)-533. VMFA-115. and H&MS-15.

The following projects were completed and accepted by MAG-15 during March: fabrication of embarkation boxes; security fence was completed around detention facility; new road surface surfaces; shipment for two (2) supply vans to Iwakuni; paving of entrance to Group Headquarters and hospital parking areas; sea huts for Group SgtMajor and MATCU equipment storage were completed; movement and retrofit of sea hut to VMGR-152 area for flight crew living spaces; construction of guard tower for base operations; complete new drain system for mess hall; water tank construction completed for RTAF; MABS installed security lighting between 0 club and Staff Club.

Lt. Gen CORCORAN, U.S.A. Chief of Staff CINCPAC was aboard for MAG-15/TFD briefings; Major General L. E. BROWN was aboard for MAG-15/TFD briefings. plus unit and element visits; MAJGeneral RYAN, CG III MAF was aboard for MAG-15/TFD briefings.

Projects completed in April included: conversion of MAG-15 cantonment strong back tents to sea huts; non skid painting of fuel pit area; valve installed in main water line for use by Thai locals; movement of one sea hut to VMGR-152 Det D area.

Inspections of the security fencing and lighting were conducted with the lighting portion being accepted for use on 30 April.

Major General BROWN was in Nam Phong on 10 April to discuss monsoon preparation requirements.

In May information and repair materials for MAG-15 Craftech buildings and establishment of a garrison property account were requested. Work was initiated on a cooling modification on the Mess Hall, sea hut loovering, and drainage system repairs. A detachment from VMFA-115 was airlifted to Cubi Point for missile shoot on 25 May. Three (3) C-141 and one (1) C-130 aircraft were required to airlift 58 passengers and 29 short tons of cargo.

Maj General RYAN and Major General BROWN were briefed on 7 May.

During June major projects consisted of: strong back tents to sea huts conversion completed; excess usable furniture was requested and started arriving; MAG-15 reception center constructed; security and lighting completed; construction of approximately 100 embark boxes; three 24 hours showers installed; cleaning and reshaping of drain system including installation of new culverts 85% completed; completion of Mess Hall cooling modification; cantonment loovers 75% completed.

NARRARIVE SUMMARY

- (U) During the month of January, Group Aviation Supply commenced an excess review program designed to identify and dispose of all excesses held in S. O. Stores. This project was rather extensive and the projected target for completion of the first phase is 1 May. A concerted effort is also being exerted on more intensive stock management in an effort to increase the supply effectiveness while decreasing the value of stock held. The Rotable Pool activity for the month was exceeding high however the aircraft "Holes" were reduced. On the Marine Corps Property side, the M. T. issue point which was established in December 1972 contributed substantally to developing valid usuage data through better cooperation between the Maintenance Shops and Marine Corps Property. Allowance lists were prepared and completed for all Squadrons and attached units, and on hand assets were identified and submitted for verification.
- (U) During the month of February the Group Aviation Supply Section commenced a maximum effort to insure that all buildings and storage spaces were water proofed as best as possible in preparation for the monsoon season. All outside storage was checked to insure that no materials subject to water damage was uncovered. On 20 February, the Group Supply Office moved to new spaces. The graftech buildings are expermental in nature and although get adequate protection from the elements, with some modification of specifications, are extremely noisey. Supply effectiveness was up again. The excess program continued. The Rotable Pool conducted an extensive review of the IMA's Module Pool. All excess was turned in and all records were adjusted to comply with current allowance list as required by current directives issued by the Aviation Supply Office. The Marine Corps Property Section continued it's validation of allowance and commented an extensive reconciliation program of outstanding documents.
- (U) During the month of March, the Material Division of the Aviation side initiated a thorough relocation of all bulk assets less all POL, to insure better protection from the weather and easier accountability. The Marine Corps side initiaed a program for validation of all T/E equiptment that had been invoiced to MAG-15 from other commands. A quarterly controlled items reconciation was recived and processed and all backorder reconcillations recived were processed in accordance with current directives.
- (U) During the month of April the Material Division of the Aviation side did a complete location verification of all stock items to insure that all items in stock had a valid locator card, also a partial inventory was conducted to sample the accuracy of the stock balance card. Approxmately 3000 line items of RFI excess material were removed from stock and turned into NSD Subic Bay during the month. Net effectiveness again increased.

- (U) During the month of May the 1st phase of the excess program was completed with over 30,000 line items having been shipped to NSD Subic. The Material Division of the Aviation side placed all stock items under covered storage with the exception of A/C external fuel tanks and certian POL products. The Marine Corps Property Section moved into a new warehouse and conducted a complete inventory of all assets on hand. All necessary adjustments were made to the records. All excess material was identified and a program set up to invoice all excessess as directed by Wing. GySgt S. Hardy was assigned as a courier for the group to Okinawa. He was given additional instruction to pick up some critically needed blank forms, and to trace shipments of jungle clothing not yet recived by MAG-15. Authority to establish a Garrison Property account was requested.
- (U) During the month of June, Group Aviation Supply completed phase II of the excess program and is awaiting disposition. Since the U1500 computer will not be sent to MAG-15. An alternate program has been implimented utilizing an off-set mechinized program. This program will allow the salvaging of some mechanization which was accomplished in preparation for U1500. If MAG-15 recives a U1500 computer this program can be programed for the change over. The Marine Corps Property Section appointed GySgt J. D. Reed as a courier to Okinawa for MAG-15. With instructions to pick up some critically needed jungle clothing, medical supplies, and NORS requirements. A annual inventory was begin with a target completion date of 20 August. The RIO at MABS Motor Transport was completely renovated and enclosed for protection from the elements. Through a concentrated effort in the Formal Account, all TE deficiences have been identified and reported to Wing, and all deficiences are on order.
- (U) During the period covered by this report MAG-15 made the following expenditures.

These funds are held by the individual flying Squadrons, and pay for JP-4 fuel, flight equipment, and administrative supplies.
