NARRATIVE SUMMARY

During the month of January, Comm. Spt. Co. retained 21 commitments, terminated none, and initiated 3 minor commitments. On 29 Jan. there was a change of command, and Major D.S. MCINTYRE assumed command of the company from Captain M.J. HILSINGER. There were resulting shifts in officer billets due to this change.

Continuing commitments are: (1) 4 man radio relay team and a An/ MRC-62 shooting from Longs Xuyen to the USS Benawah. Although this commitment still exists, 2 men were pulled back for troop redeployment. (2) Six man team operating a AN/TRC-27 shot between Hill 327 and An Hoa in support of the 11th Marines. (3) 45 man detachment at Hoi An providing multi-channel radio and teletype communication for the 2nd ROK Marine Brigade and telephone service for the United States Liaison personnel. (4) A three man radio relay team operating an AN/MRC-62 shot at Hoi An for CAG II. (5) 8 man detachment at 1st M.P. Bn. augmenting organic communication personnel. (6) Radio Plt. is maintaining one AN/PRC-25 and one AN/PRC-47 in support of 95th Medical Evacuation Hospital. (7) Wire Plt. is operating and maintaining the 5th Communication Battalion switchboard and wire system. (8) A four man team operating and maintaining a covered teletype circuit for 3rd Force Recon. Co., at Phu Bai. (9) A four man team operating and maintaining a covered teletype circuit for 1st Force Recon. Co. at Hill 34. (10) A telephone alert system for Zulu Ground Defense, MAG 16. (11) One AN/GIC-1 supplied to CAP Headquarters. (12) One man to 2nd CAP as an instructor. (13) One AN/MRC-109 supplied to 1st Force Recon. Co. (Hill 34). (14) Supplying III MAF Tech. Control with one man and communications equipment. (15) One TA-312/PT supplied to NSA Hospital. (16) Two TA-312/PT supplied to 80th General Support Group. (17) Five TA-312/PT supplied to the orphanage in East DaNang. (18) Two TA-312/PT supplied to DaNang Hospital (19) One AN/PRC-25 to the PMO, III MAF. (20) An AS-2236 to SRC Officer III MAF. (21) One wire link from Bn. C.P. to 1st Radio Bn. C.P. bunker, and an alert speaker system into 1st Radio Battalion area.

Commitments initiated: (1) one AN/MRC-110 and one driver to H & S Co. III MAF. (2) Two AN/URR-23A to Comm. Co. 5th Comm. Bn. to conduct a performance survey for AFVN. (3) Wire Plt sent parts and personnel to repair switchboard AN/MTC-1 at Headquarters, 2nd ROK Marine Brigade.
