### JUDGESHIPS, AND NOMINATIONS

Committee on the Judiciary: Committee, in executive session, ordered favorably reported with amendments S. 912, providing for the appointment of additional circuit and district judges. As approved, the bill would provide 9 additional circuit judges and 60 additional district judges.

### MINIMUM WAGE

Committee on Education and Labor: Special Subcommittee on Labor continued executive consideration of H.R. 3935, to amend the Fair Labor Standards Act of 1938 in regard to increasing the Federal minimum wage to \$1.25 an hour. The subcommittee will continue on this subject, in executive session, Tuesday, February 28.
