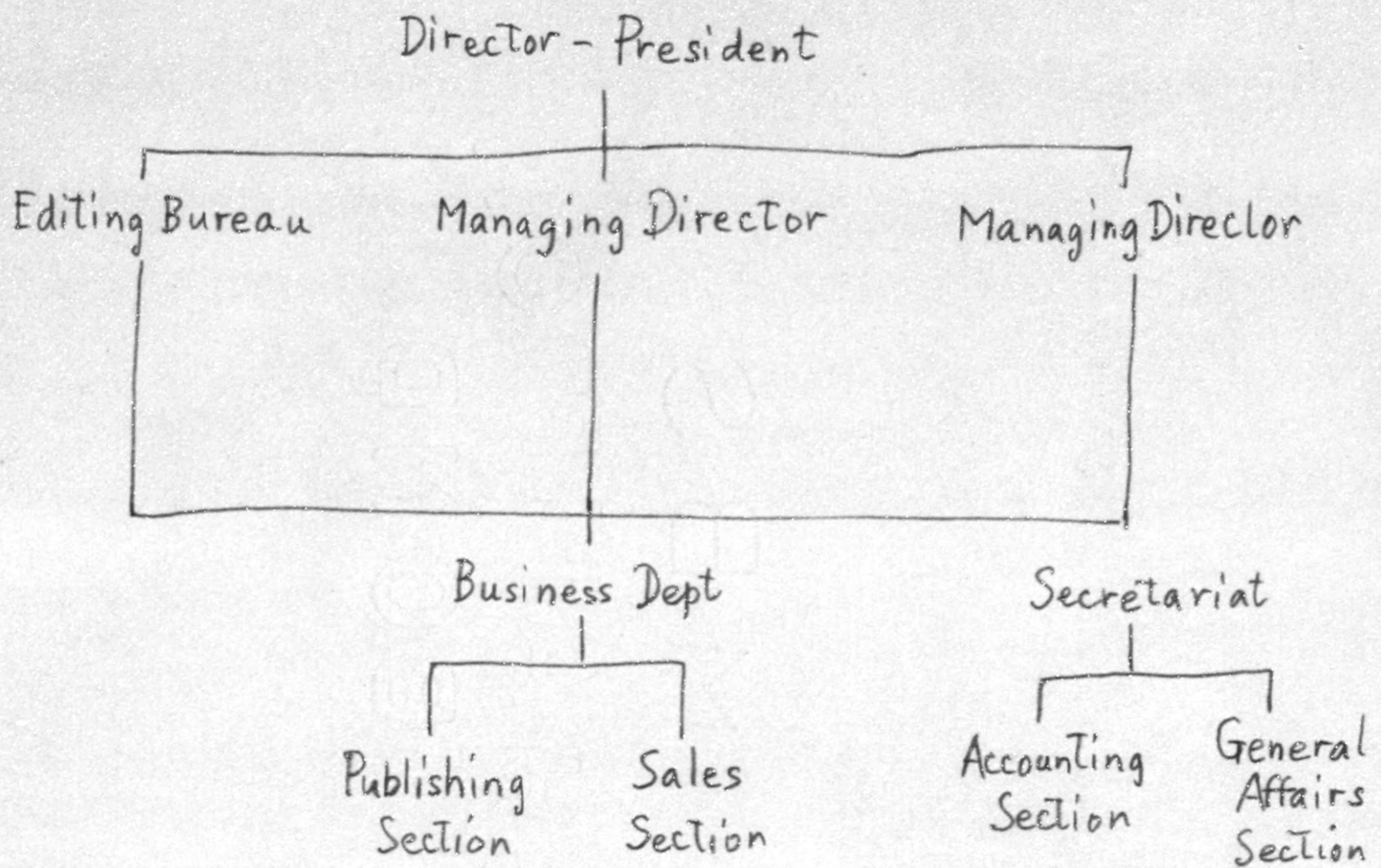
Official Structure of

- 1) The President is in charge of the general management and operation of the company.
- 2) The Editing Bureau controls the editing of books and periodicals which is the chief business of the company's activity.
- 3) The Managing Directors are respectively in charge of the practical control of the Secretariat and of the Business Department.
