Two Photo Liberators flown by Lieutenant H. L. SALYER, flight leader, and Lieutenant (jg) W. L. FITZSIMMONS took off from Yontan Airfield, Okinawa at 0705 Item, 13 May 1945 for Photo Reconnaissance of Koshiki Retto. The target was reached at 0900 Item and flight lines were run until 1000 Item. Complete cloud free vertical photo coverage was obtained from 20,000 ft. altitude. No antiaircraft fire was encountered. As planes from a fast carrier task force were striking nearby Kyushu airfields at the same time, it is felt that this attack accounted for the absence of enemy interception. The flight returned to Yontan Airfield at 1235 Item.
