ORDINANCE REALIGNING PORTION OF THE CONTINUING PLANT, PROPERTY AND EQUIPMENT (PPE) APPROPRIATED FOR THE LEGISLATIVE DEPARTMENT OF THE LOCAL GOVERNMENT UNIT OF ALAMINOS CITY AMOUNTING TO TWO MILLION NINE THOUSAND PESOS (PHP 2,009,400.00) HUNDRED PURCHASE/PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR THE USE OF THE LEGISLATIVE DEPARTMENT OF LGU-ALAMINOS

WHEREAS, to increase mobility and strengthen the responsiveness of the functions of the Legislative Department of the Local Government Unit of Alaminos City, Pangasinan, this august body deemed it necessary to purchase/procure one (1) unit of Passenger Van (brand new) amounting to Two Million Nine Thousand Four Hundred Pesos (Php 2,009,400.00);

PORTION OF THE CONTINUING PLANT, PROPERTY AND EQUIPMENT (PPE) APPROPRIATED FOR THE LEGISLATIVE DEPARTMENT OF THE LOCAL **GOVERNMENT UNIT OF ALAMINOS CITY AMOUNTING TO TWO MILLION NINE** THOUSAND FOUR HUNDRED PESOS (PHP 2,009,400.00) BE REALIGNED FOR THE PURCHASE/PROCUREMENT OF ONE (1) UNIT PASSENGER VAN FOR THE USE OF THE LEGISLATIVE DEPARTMENT OF LGU-ALAMINOS CITY.
