Lieutenant (jg) F. W. CROOKS in a PB4Y-1P aircraft of Fleet Air Photographic Squadron ONE took off from Agana Airfield, Guam, M. I. on 31 May 1945 at 0845 to photograph enemy installations on Marcus Island. He arrived over the target at 1430 King and took vertical photographs of the entire island from an altitude of 17,100 ft. No enemy interception or antiaircraft fire was encountered. He returned to base at 2000 King.
