AT MADISON CONCERNING THEIR WILLINGNESS TO RECEIVE DIET DELEGATION OF SEVEN JAPANESE PLUS TWO SCAP OFFICIALS FOR THREE-DAY STOPOVER ENROUTE PROBABLY MIDDLE OF JULY TO OBSERVE AND STUDY THAT LEGISLATURE IN ACTION PD WISCONSIN IS ON DIRECT TOKYO-WASHINGTON DOG PD CHARLIE PD ROUTE AND ITS LEGISLATURE ONLY ONE PRESENTLY IN SESSION ACCORDING TO OUR INFORMATION PD CONTRAST BETWEEN RELATIVE SIMPLICITY OF STATE LAW MAKING BODY AND COMPLEX NATURE OF CONGRESS WILL BE HIGHLY INSTRUCTIVE TO DIET MEMBERS PD PARA PART THREE CLM ADVISE IF YOUR OFFICE WILL MAKE APPROPRIATE HOTEL RESERVATIONS AND ARRANGE ALL OFFICIAL CONTACTS FOR DIET DELEGATION AND ALSO ASSIGN TO GROUP AN OFFICIAL TO ASSIST GENERALLY DURING STAY IN WASHINGTON

DURING EACH OF FIVE SESSIONS OF NATIONAL DIET HELD SINCE EFFECTIVE DATE OF NEW CONSTITUTION IN MAY ONE NINE FOUR SEVEN CMA THE NEWER AND YOUNGER POSTWAR LEGISLATORS HAVE APPEALED TO THIS HEADQUARTERS FOR PERMISSION TO SEND DELEGATION OF DIET MEMBERS TO UNITED STATES FOR FIRSTHAND STUDY OF CONGRESS IN ACTION. PD APPEAL OF THIS NATURE SERIOUSLY CONSIDERED LAST YEAR BUT HELD UP PENDING ACCUMULATION OF MORE EXTENSIVE EXPERIENCE BY DIETMEN UNDER NEW CONSTITUTION AND MODERNIZED DIET LAW PD PARA OLD IMPERIAL DIET WAS MERELY IMPOTENT DEBATING SOCIETY CMA UNUSED TO EXERCISE OF POWERS COMMON TO WESTERN LEGISLATIVE ASSEMBLIES PD NEW DIET CMA CONSTITUTED AS HIGHEST ORGAN OF STATE POWER CMA IS SHOWING REAL PROMISE CMA CONTRIBUTING MATERIALLY TO ACHIEVING BASIC OCCUPATION OBJECTIVE OF REPLACING SHADOW GOVERNMENT WHICH FORMERLY RULED JAPAN UNDER CLOAK OF IMPERIAL SANCTION WITH A GOVERNMENT GENUINELY RESPONSIVE TO POPULAR WILL PD EXPERIMENT WITH NEW ORGANIZATIONAL MACHINERY CMA PROCEDURES AND PROCESSES IS MEETING WITH SUCCESS PD DIET STANDING COMMITTEES CMA BY JUDICIOUS USE OF SUBPOENA POWERS CMA SPECIAL INVESTIGATIONS CMA PUBLIC HEARINGS CMA DEBATES AND INTERPELLATIONS CMA ARE COMMANDING INCREASING RESPECT OF CABINET CMA BUREAUCRACY CMA JUDICIARY CMA PRESS AND GENERAL SECRETARIAL ASSISTANTS AND OTHER LEGISLATIVE

PD REQUEST THREE FIVE THOUSAND DOLLARS BE IMMEDIATELY EARMARKED FOR THIS
PROJECT PD PARA TWO REPRESENTATIVES OF SCAP WILL ACCOMPANY THE DELEGATION PD
HOWEVER REQUEST DEPT OF ARMY ARRANGE ACCOMMODATIONS AND SCHEDULE APPOINTMENTS
BASED ON STUDY PROGRAM TO BE FURNISHED BY SCAP
