2. 1. ESS is in favor of having the Liquor Distribution Kodan Law extended to July 1, 1949.

2. ESS is strongly opposed to any other amendments to the Liquor Distribution Kodan Law at this time. Specifically, ESS objects to any amendment to the law which will permit any change in the Kodan's methods of financing its operations. We are recommending that the life of all kodans, except the Petroleum Distribution Kodan and the foreign trade kodans, be extended to July 1, 1949. Problems concerning kodans are now being studied, and before July 1, 1949, final recommendations as to changes, if any, in the organization and operations of kodans will be made.



For 1949 only the filing and mentioned items of the April provisional return as referred to under Art.21, par.(1) of the Income Tax Law (Law No.27, 1947) shall be on the basis of the actual circumstances as of June 1st and the time-limit for filing shall be from the same date to 30th of the same month.
2. For 1949 only in Art.21, par.(6) "Mar. 31st" shall read "May 31st".
3. For 1949 only the first quarter period for payment as referred to under Art.30, par.(1) of the Income Tax Law shall be from June 1st to 30th of the same month.

Legal Section objects to the proposed new Article 9-(2) of this bill on the ground that no objective standards are provided by the Diet to guide the discretion of the head of the Ministry of Government Agency in question, or of the Minister of Finance in deciding the cases when delayed payments may be permitted, the term of such payments and the cases when exemption from hypothecation may be granted. Such decisions are left purely to the subjective judgment of the head of the Ministry or agency, except that he must consult the Minister of Finance if he intends to allow delayed payment or to exempt from hypothecation. Although it is clear that the Diet cannot lay down in advance rules to govern every case, the general principles or standard to guide executive discretion should be provided in the law itself if favoritism or corruption are to be discouraged. It is even doubtful whether exemption from hypothecation should be permitted in any case.

2. No other legal objection is made to immediate introduction of this bill in the Diet. The other provisions are intended to tighten control over disbursements and are sponsored by ESS.
