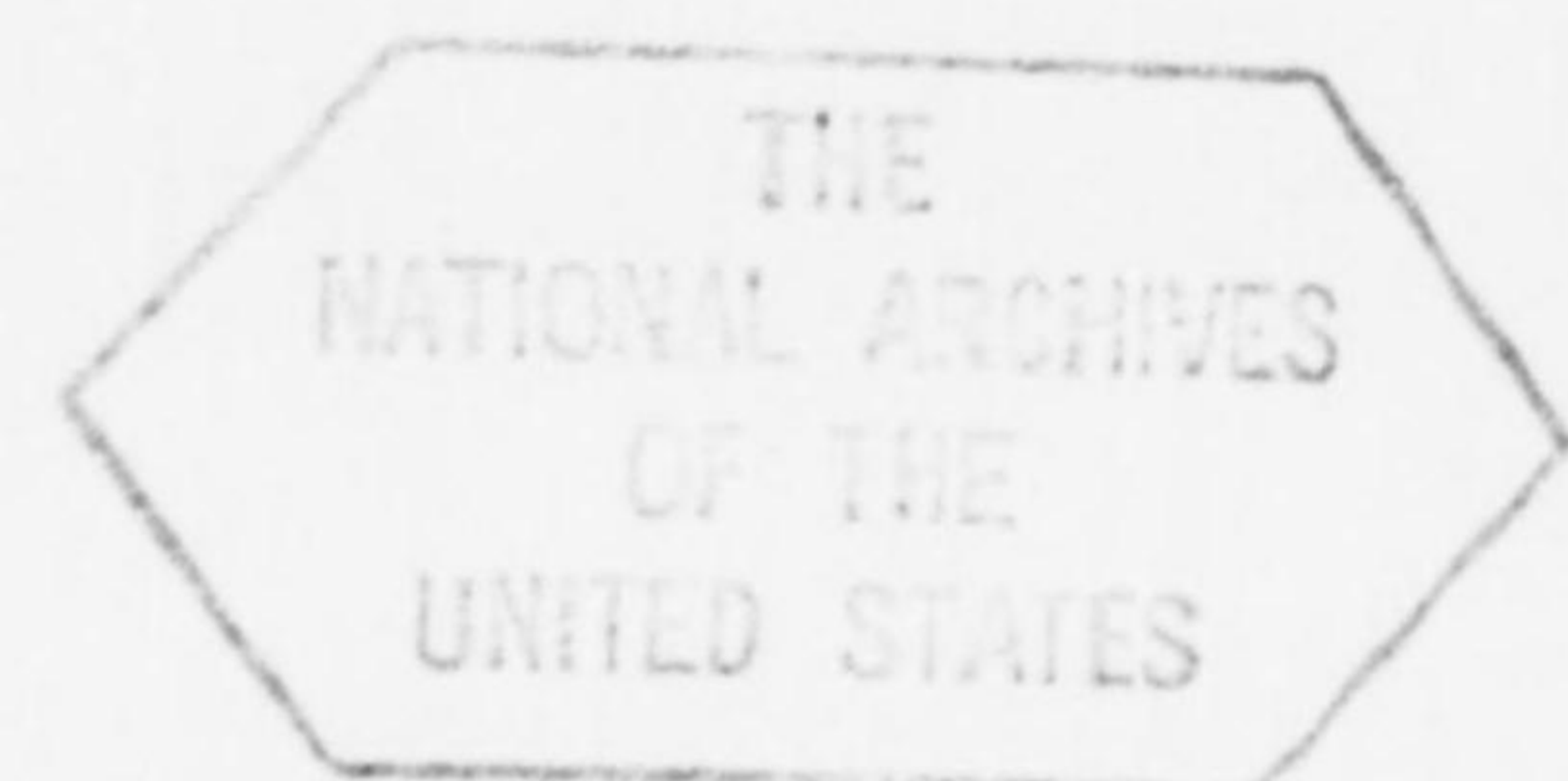

1. This Section recommends that the subject bills not be cleared for the reasons that:
 - a. They constitute unwarranted national interference in the field of local autonomy.
 - b. Far-reaching powers of city planning are already vested in the national government by the existing city planning laws. Additional power would be given to the national government under the subject bills.
 - c. They contain very little specific provisions as to the character, organization, etc. to guide authorities concerned in the proper execution of the purpose stated in Article 1.
 - d. The lack of specific provisions would make it impossible to carry out an intelligent plebiscite under Article 95 of the Constitution of Japan.
 2. Subject bills are identical in substance to several bills proposed at and enacted into laws by former sessions of the Diet to which LS has repeatedly objected. Reference is made to the check sheets to Government Section, dated:
