STOCKS OF OATS, RYE, AND FLAXSEED UP OTHER GRAINS BELOW YEAR AGO

Total feed grain stocks (corn, oats, barley and sorghum grain) at 63.8 million tons were down 6 percent from the 67.6 million tons a year earlier, according to the Crop Reporting Board. Decreased stocks of corn, sorghum grain and barley more than offset an increase in oat stocks.

Stocks of all wheat were 5 percent less than a year earlier. Durum stocks were down 19 percent. Rye stocks were a fourth larger than last year, and holdings of flaxseed were up 10 percent.

All wheat in storage October 1 totaled 1,782 million bushels, 5 percent less than a year earlier but 6 percent above the October 1, 1968 stocks. Off-farm stocks of 1,129 million bushels were 1 percent more than a year earlier, but farm holdings at 653 million were 13 percent below the record large total a year earlier. Disappearance from all storage positions July through September is indicated at 461 million bushels, compared with 407 million a year earlier. The Commodity Credit Corporation owned 297 million bushels of the total wheat stocks, and had loans outstanding on 534 million.

Durum wheat stocks in all positions on October 1 totaled 104 million bushels, 19 percent less than a year earlier and 5 percent below two years earlier. Farm holdings of 78 million were 26 percent below last year but off-farm stocks of 26 million bushels were up 12 percent. Disappearance during July-September is indicated at 23.3 million bushels, compared with 18.3 million a year earlier.

Rye stocks in all storage positions on October 1 totaled 47.7 million bushels, 25 percent more than a year earlier and 50 percent above October 1, 1968. Off-farm stocks at 27.9 million bushels were 27 percent more than a year earlier, and farm stocks were up 21 percent. Indicated disappearance during July-September was 9.7 million bushels compared with 9.1 million a year earlier. The Commodity Credit Corporation owned 17.6 million bushels of total rye stocks and had loans outstanding on 6.4 million.

Old crop corn carried over in all storage positions on October 1 totaled 999 million bushels, 10 percent less than a year earlier. Old corn stored on farms at 570 million bushels was 22 percent less than last year, but stocks in off-farm positions at 429 million bushels were up 12 percent. The Commodity Credit Corporation owned 255 million bushels of old crop corn, and had loans outstanding on 345 million bushels.

Indicated disappearance of old crop corn from all storage positions during the July-September quarter was 923 million bushels - 3 percent less than the 955 million-bushel disappearance a year earlier. Harvest of this year's corn crop advanced rapidly. More than the usual amount of new crop corn was likely used before October 1, reducing the disappearance of old corn during the last quarter.

Oats stored in all positions on October 1 totaled 1,076 million bushels, 5 percent more than a year earlier and 15 percent above holdings October 1, 1968. Off-farm stocks of 246 million bushels were 27 percent above a year ago. Farm holdings at 830 million bushels were about the same as last year. Disappearance during July-September was 306 million bushels, compared with 302 million a year earlier. The Commodity Credit Corporation owned 145 million bushels and had loans outstanding on 215 million bushels.

Barley stored in all positions on October 1 totaled 488 million bushels, 2 percent less than a year earlier. Off-farm stocks of 185 million bushels were 3 percent below last year, and farm stocks, totaling 303 million bushels, were down 1 percent. The Commodity Credit Corporation owned nearly 55 million bushels of total barley stocks and had loans outstanding on 97 million bushels. Disappearance during July-September was 155 million bushels -- up 30 percent from the 119 million bushels a year earlier.

Old crop sorghum grain stored in all positions on October 1 totaled 245 million bushels, 15 percent below last year. Off-farm stocks totaled 205 million bushels, 13 percent below that of a year earlier. Farm stocks at 40 million bushels were down 25 percent from October 1, 1969. Disappearance during July-September was 103 million bushels compared with 98 million in 1969. The Commodity Credit Corporation owned 173 million bushels of total sorghum grain stocks and had loans outstanding on an additional 28 million bushels.

Flaxseed stocks in all positions on October 1 totaled 44.0 million bushels -- 10 percent more than a year earlier. Flaxseed stocks in off-farm positions, at 28.3 million bushels were 64 percent of the total stocks and 7.3 million bushels more than October 1969. Farm stocks totaled 15.7 million bushels -- 3.4 million less than a year earlier. Current stocks indicate a disappearance during July-September of 8.9 million bushels, compared with 6.2 million a year earlier. Flaxseed supply is estimated at 52.9 million (carryover of 22.0 million plus production of 30.9 million bushels). Crushings during the quarter are estimated at 4.3 million bushels and exports about 1.5 million bushels.

The Commodity Credit Corporation owned 19.1 million bushels and had loans outstanding on an additional 3.2 million bushels of flaxseed.
