



# NOTE


INCE this work was published, five years ago, a number of important pictures by Hoppner have come to light, and a considerable quantity of fresh particulars have been gleaned concerning the artist and his paintings, sufficient to justify the publication of the present Supplement. There is no finality in a monograph of this description, unrecorded portraits coming to light every season. Even after this Supplement was printed off, an exceptionally charming example of the master came into the possession of Messrs. T. Agnew and Sons, a half-figure portrait of MRS. MOWBREY, in grayish brown dress, her face in profile, her dark brown hair bound with a narrow blue ribbon, with a view of sky and tall trees seen through a window to left (on canvas 30 in. by 25 in.). Like other portraits, still untraced, it has remained in the family until the present time, and our regret is that this portrait was not discovered in time to be reproduced in this Supplement.

The body of the book remains the same as in the first edition, and the new matter takes the form of a Supplement. To add to the utility of the volume, and to facilitate reference, a comprehensive Index is given, so that every picture may be readily found, whether it is in the first portion of the work, in the Addenda, or in the Supplement. Half a dozen new plates have been added. Every engraving registered at the Printsellers' Association during the last five years is recorded here with the names of the engravers, the sizes, and dates of publication. Changes of ownership, so far as these can be traced, are also noted. In fact, everything that is possible has been done to bring the work up to date, and to make it worthy of the reputation of the great artist of whose accomplishments it may fairly claim to be the only approximately complete record.

It is scarcely necessary to add that, whilst every endeavour has been made to trace and describe every existing picture by Hoppner, particulars of those which have escaped notice will still be welcome.

# ALLINGHAM, MRS., AND SON



ARY TAYLOR, wife of Thomas Allingham, Esq., of the city of London (and mother of Mrs. Catherine Dickinson, of Farley House, Berks); died in 1803. Mr. and Mrs. Taylor had four sons and four daughters; the boy in the picture is probably one of the younger sons.

NEARLY whole-length portrait of Mrs. Allingham seated to right in red chair, directed to left, in low white dress with short sleeves, and looking down at an open

book which she holds with her left hand; right arm across the boy's shoulders, hand resting on his arm, fair curly hair falling over forehead. Boy leaning against his mother, in brown dress, with broad white lace collar, fair wavy hair, looking at spectator, left hand resting on book, right hand holding a rush. Background dull brown curtain and pillar; landscape in distance to left. Canvas,  $36 \times 28\frac{1}{2}$  in.

# AMELIA, H.R.H. PRINCESS (p. 3)

The Sanderson portrait is presumably identical with the picture now in the collection of Mrs. Simpson, Fifth Avenue, New York.

#### ANGUISH PORTRAITS (pp. 329 and Supplement 32)

The Anguish family was for a time of Somerleyton, one of the most imposing mansions in Suffolk. The estate had been purchased in 1702 by Admiral Sir Thomas Allin, Bart, and on the death of the last of that line in 1794, passed to his distant kinsman, Thomas Anguish, the elder brother of the three ladies whose portraits are described on p. 329, and of the Countess of Leeds (Supp. 32). On the death of their younger brother, the Rev. George Anguish, in 1843 (when the family became extinct) the estates passed to the son of Catherine, Countess of Leeds. The family motto was "Latte anguis in herba." An account of the Anguish family of Somerleyton was published in Neale's "Views," vol. iv (1821), but a much more interesting and fuller account appeared in "The Art Journal," and was reprinted in Jewitt and Hall's "Stately Homes of England," pp. 203-224, Second Series, 1877.


#### ARBUTHNOT, MRS. (p. 5)

No. 2. This picture, at one time in the collection of Sir Henry Hawley, Brighton, was exhibited at Messrs. Knoedler's galleries, Fifth Avenue, New York, January, 1912, and is reproduced in the catalogue of that exhibition. It belonged to the late Mr. M. C. D. Borden, after whose death it was No. 32 in his sale in New York, 13-14 February, 1913, when it was purchased for 60,500 dollars by Messrs. Scott and Fowles. Apparently No. 4, stated on p. 5 to be in Mr. Borden's collection, was not there, for it did not occur in the Borden sale; the latter portrait is reproduced in "The Masterpices of Hoppner," 1912, p. 33.

# BASSET, BARONESS



John Basset, Esq.

NLY daughter of Sir Francis Basset, Bart., who was created Baron de Dunstanville, 7 June 1796, and Baron Basset of Stretton, with remainder to his only daughter and her issue male, 30 Nov., 1797; born I May, 1781; succeeded her father in the Barony of Basset, 14 Feb., 1835; died unmarried, 22 Jan., 1855, when her estates passed into the possession of her nephew,

HALF figure, directed and looking to left, in dark brown dress cut low, fair curly hair falling over forehead. Canvas, 30 × 25 in. An excellent portrait painted about 1802.

# BAYLY, LADY

A portrait with this title was at the Marquess of Anglesea's residence, Plas Newydd, Wales, in the early part of the last century, according to Neale's "Views," vol. v. It may possibly be the "Portrait of a Lady," identified as Miss Bailey, at the Royal Academy of 1784, No. 70 (see p. 11).

# BEAUFORT, DUCHESS OF



HARLOTTE SOPHIA, daughter of Granville, 1st Marquess of Stafford; born 11 Jan., 1771; married 16 May, 1791, Henry Charles, Marquess of Worcester, afterwards—in 1803—6th Duke of Beaufort; died in August, 1854.

Exhibited at Graves's Galleries, October-November, 1911, No. 8.

#### BECKFORD, WILLIAM

UTHOR and collector, son of Alderman Beckford. Born at Fonthill in 1759; wrote "Vathek" in French; M.P. for Wells and Hindon; formed a splendid collection of objects of art at Fonthill, which he sold *en bloc* with its contents for  $\pounds_{330,000}$  in 1822; lived in retirement at Bath until his death, 2 May, 1844.

THREE-QUARTER length, as a comparatively young man, life size, seated in armchair directed and looking to right; dark crimson coat buttoned up, gray breeches and white stockings; white neckerchief, powdered wig; legs (only partly seen) crossed; folio of illustrations open on lap; background, fluted stone column. Canvas,  $50 \times 40$  in. The colours are fresh and beautiful, and the condition perfect.

#### BEDFORD, DUCHESS OF (p. 19)

A three-quarter length of this lady  $(50 \times 40 \text{ in.})$ , seated to left, white low dress, brown hair tied with white ribbon, two red roses in left hand, was lent by Mr. Henry Graves to the Loan Exhibition, Edinburgh, 1884, No. 438. A portrait of the same, as "Lady Georgiana Gordon," was one of the three English pictures in the collection of the late Mr. Benjamin Altman, of New York.

#### BELOC, MRS.



ALF figure, in white muslin dress, with lace frill round the neck; black lace shawl over her right arm; blue sash and blue ribbon in her powdered hair; landscape and red curtain background. Canvas,  $29 \times 24$  in.

# BERIDGE, MRS.

OROTHY, daughter and co-heir of John Tanfield of Carthorpe, Yorks; married, as his second wife, 29 June, 1793, the Rev. Basil Bury Beridge, Rector and Patron of Algarkirk; died 5 Nov., 1840.

THREE-QUARTER length, seated on a sofa, in white dress, cut low at the neck, with gold trimming and sash; powdered hair with gray satin ribbon tied in a bow under chin; landscape and red curtain background. Canvas, 50 × 40 in.

# BERKELEY, EARL OF (p. 22)

The picture of "The late Lord Berkeley," referred to in the note as having been exhibited at the B.S.A. in 1833, No. 174, by Mr. Childe, is adversely criticised in "Lo Studio" (vol. i, p. 211): "Bold but vulgar. If the latter be nature's fault (for she sometimes slights the great) the painter might have lied a little, and about as much as lords and ladies like, and have sent his sitter forth 'agreeable i' the extern The right leg is laughably stuck to his side. However, 'tis only drawing."

#### BILLINGTON, MRS. (p. 24)

WHREE-QUARTER length, seated in a chair on a balcony, directed to left, head turned and looking to right; white dress, cut low with upright muslin collar, and short sleeves; ornamental waistband; right arm resting on arm of chair, hand holding a piece of partly-opened music; left hand resting on lap; coral earring; dark hair, close-fitting blue hat with feather, gauze shawl passing around shoulders and on lap; pillar background, with tree, etc.; hilly landscape seen to left. Canvas, 50 × 40 in.

#### BINGHAM, MISS

LIZABETH JEMIMA, second daughter of Joseph Blake, Esq., of Ardfrey, co. Galway; married, first, 25 Jan., 1790, George, 14th Earl of Errol (who died s.p. 14 June, 1798); and secondly, 12 Sept., 1816, the Right Hon. John Hookham Frere (q.v.); died 17 Jan., 1831.

NEARLY whole-length of a young lady about twenty years of age; directed to right, head turned and looking at spectator full face; red hunting-habit, large black hat with white ostrich feather; riding-whip held in her gloved right hand; landscape background. Canvas, 60 × 40 in.

# BOUVERIE, MISS "FANNY"

ENRIETTA ELIZABETH, eldest daughter of the Hon. Edward Bouverie, M.P., of Lavington Manor, Wilts (younger brother of the 1st Viscount Folkestone); born in 1771; married in 1790 Sir James St. Clair Erskine, who, in 1805, succeeded his uncle as 2nd Earl of Rosslyn; died August, 1810.

PORTRAIT of a little girl of four or five in white dress, white poke-bonnet, red coral necklace, and red shoes, seated on a donkey, holding bridle and small whip in her right hand, and looking to the left; landscape background. Canvas, 30 × 25 in.

F Babworth, Notts; younger son of Sir Henry Bridgeman, who was created Baron Bradford in 1794; born 13 May, 1763; married, first, 3 June, 1784, Henrietta Frances, only daughter of Sir Thomas Worsley, Bt.; and secondly, 27 Nov., 1793, Grace, daughter of Samuel Estwicke (see p. 237); took the name and arms of Simpson in 1785; died 5 June, 1850.

Canvas, 36 × 28 in.

HOLE-LENGTH, seated near a balcony in red armchair and looking to right; white dress cut low, white lace fichu, red coral necklace; fair hair dressed over forehead and ears; right arm resting on chair; feet on low stool; sleeping baby of one or two years of age on lap, resting its head

on the mother's left arm; background, pillar, red curtain, and trees; hilly landscape to left. Canvas,  $96 \times 58$  in.

#### CAVENDISH CHILDREN, THE (p. 47)

This group was lent by Lord Chesham to the National Loan Exhibition at the Grosvenor Gallery, Nov., 1913, Feb., 1914, No. 105, a note in the Catalogue stating that it "has always been regarded as a Lawrence by the owner and his family." Lawrence and Hoppner occasionally came very close together, and this is an instance in which one artist's work might easily be mistaken for that of the other. We have again carefully examined the picture, and from its technique and general treatment we regard it as undoubtedly by Lawrence. Probably the 70 gs. which Lawrence received in 1792-6 from Lord George Cavendish was for this group and not for an untraced portrait of himself mentioned in Sir Walter Armstrong's "Lawrence," 1913, p. 121.

ENGRAVED in mezzotint by L. Busière,  $19\frac{3}{8} \times 15\frac{1}{2}$  in., 1914, and printed in colours as a companion to the Sackville Children.

#### CAVENDISH, WILLIAM



LDEST son of Lord George Augustus Henry Cavendish, third son of William, 4th Duke of Devonshire, who was created Earl of Burlington, 10 Sept., 1831; born 10 Jan., 1783; married, 18 July, 1807, Louisa, a daughter of 1st Viscount Lismore; died, v.p., 14 Jan., 1812. His eldest son succeeded as 2nd Earl of Burlington in May, 1834.

There is a copy of this portrait at Hardwick Hall; see Lord Hawkesbury's "Catalogue," 1903, p. 36. The original has not been traced.

# CAWDOR, LADY



SABELLA CAROLINE, eldest daughter of Frederick, 5th Earl of Carlisle; born 3 Sept., 1771; married 27 July, 1789, John Campbell, who was created 21 June, 1796, Lord Cawdor of Castlemartin, co. Pembroke; died 8 March, 1848, buried at Streatham.

# DARNLEY, COUNTESS, AND LADY E. BLIGH (p. 63)

Exhibited at Messrs. Knoedler's Galleries, Fifth Avenue, New York, January, 1912, and illustrated in the Catalogue.

#### DASHWOOD-KING, LADY

ARY ANNE, daughter of Theodore Henry Broadhead, Esq.; married in 1789 Sir Thomas Dashwood-King, 4th Bart., of West Wycombe, Berks; died 19 Jan., 1844. The 3rd Bart. took the name of King after that of Dashwood in 1742, and the double name was retained by the 4th Bart., but later generations appear to have dropped the second surname.

HALF-LENGTH in a landscape, directed and looking to right, face seen to little more than in profile; white low dress; dark flowing hair falling in curls over forehead, elaborate white turban-like headdress, the ends of which fall over her neck; arms hanging down by side, hands not seen; to right trees, spire of church slightly indicated, with hill in the distance. Canvas,  $30 \times 25$  in.

NOTE.—A very fine picture, painted about 1794-5, in the matter of costume strikingly similar to the Duke of Northumberland's portrait of the Viscountess of St. Asaph engraved by Wilkin. The "Lady King" in the Hoppner sale of 1823 (lot 11) was probably a sketch for this picture, which was bought in 1911 by Messrs. Agnew from a well-known collector. It is interesting to note that Lady Dashwood-King's eldest daughter Mary married the third son of Frederick, Earl of Berkeley: both the Earl and Countess were painted by Hoppner (see pp. 22-3).

# DAVIDSON, COLONEL



F Pinnacle Hill.

HALF figure, in red coat, white vest and stock; powdered hair. Canvas,  $30 \times 25$  in.

#### DE DUNSTANVILLE, BARONESS



USANNA, daughter of John Hippesley Coxe, Esq., of Stone, Easton, Somerset; married, as his first wife, 16 May, 1780, Sir Francis Basset, afterwards Baron De Dunstanville; died 14 June, 1823.

THREE-QUARTER figure, walking to right in a landscape and under a tree; deep orange-coloured dress cut low, with short sleeves, blue waistband, dark hair falling over forehead; white muslin head-dress; light blue shawl over shoulders and end held in right hand; running brook to right. Canvas, 50 × 40 in. A very fine picture, forming an excellent pendant to the famous portrait of Lady Louisa Manners.

# DEE, MISS. See NUGENT, LADY

# DENISON, MRS. (p. 64)

This portrait was again exhibited at Messrs. Agnew's June-July, 1907, No. 25, and was sold at the dispersal of the collection of Mr. Norman Forbes Robertson, of 42 Bedford Square, at Christie's, 19 May, 1911, lot 107, when it was purchased by Messrs. Wallis. It is illustrated in the sale catalogue and in "The Masterpieces of Hoppner," 1912, p. 37. The exact date of the marriage of Charlotte Estwick with John Denison is 9 January, 1797.

# DENT, JOHN ("DOG" DENT)



ALF-LENGTH portrait of a middle-aged man, facing front, head slightly turned and looking to left; brown coat, white waistcoat, white stock, powdered hair. Canvas,  $30 \times 25$  in.

The present Earl of Camperdown, in his life of his great ancestor, 1898, says (p. 266) that when the Admiral reached his own home in Forfarshire, he received an enthusiastic welcome, and on 13 November, 1797, the Commissioners of Supply of the County of Forfar voted 200 gs. for a piece of plate, and resolved to have the Admiral's portrait painted by Hoppner and hung in the County Hall. At the foot of the picture is an inscription which corresponds with Lord Camperdown's story ("Morning Post," 28 October, 1912). The version No. 3 (p. 70) was lent by the Earl of Camperdown to the Glasgow Exhibition, 1911, No. 182.



The excesses of Lady Guildford's mother and those of her father-in-law and husband form the topic of a long chapter in that somewhat scandalous publication, "The Whig Club," 1794 (pp. 181-192). The Prince of Wales described Miss Hobart (Lady Guildford) to be "the only modest woman of position that he was acquainted with."



Both portraits were included in the Eugène Fischof sale in Paris, 12 June, 1913, that of Keith Jopp was lot 7 and realized 10,500 francs; that of Mrs. Jopp was lot 6 and was bought for 61,000 francs by M. Paul André. Both are illustrated in the sale catalogue.

OHN, younger son of William Lemon, of Carclew, and brother of Sir William Lemon, 1st Bart.; born at Truro, 6 Nov., 1754; a Colonel of the Cornwall and Devon Miners; M.P. for Saltash, 1778, and for Truro, 1798-1814; Lord of the Admiralty, 1804; died at West Looe, 5 April, 1814.

HALF figure of a stout, full-face, middle-aged man, directed and looking to right, seated in red plush-covered chair; blue coat, yellow vest, white stock or neckerchief. Canvas,  $30 \times 25$  in.

#### LINLEY, MR. (p. 155)

Now in the collection of M. Paul Lebaudy, Paris, and reproduced in "The Masterpieces of Hoppner," 1912, p. 49.

#### MACKAY, MRS.

LINA JONES, wife of Alexander George Mackay.

THREE-QUARTER figure, seated in an armchair, directed to front and looking at spectator; white dress cut low and trimmed with muslin, dark waistband, patterned cloak thrown round back, the ends round the arms, which rest on lap; fair curly hair bound with dark riband.

This portrait, which was on Loan at the National Gallery, Melbourne (the owner, Mr. E. H. Mackay, being a grandson of the sitter) is evidently the work of a good artist, but, judging from a photo, its florid style does not suggest Hoppner, to whom it is ascribed.

NOTE .-- The version at Ham House, referred to on p. 162, is probably the work of Constable, who was engaged by the Earl of Dysart to make copies of various family portraits, chiefly after Sir J. Reynolds. Hoppner himself had made some copies, which Constable described as "wretched." See Leslie's "Memoirs" of Constable (Everyman's Library edition, pp. 16, 27, 28-9).

No. 1 is reproduced in "The Masterpieces of Hoppner," 1912, p. 51.

For "right hand and arm covered with long glove" read "right hand and left hand and arm gloved."

NOTE.-This is probably another portrait of Lady Caroline Lamb (p. 147), and the Lady Ponsonby of the Hoppner sale of 1823, lot 20 (see p. 209) doubtless refers to this picture. In her biography on p. 147 for "see previous entry" read "see next page." As Lady Caroline Lamb died a few months before her husband succeeded to the peerage as Lord Melbourne, she was never Lady Melbourne, but for the sake of convenience the portrait is retained here under that title.

#### MEYRICK, WILLIAM HENRY



ZON of General Thomas Meyrick and Elizabeth, natural daughter and heiress of Admiral Lord Keppel; born 29 March, 1790; married 24 Feb., 1823, Lady Laura Vane, third daughter of the Duke of Cleveland; a colonel in the army and at one time in the Scots Fusilier Guards. His son succeeded in 1848 the famous antiquary, Sir Samuel Rush Meyrick, in the family estates at Goodrich Court, co. Hereford.

NEARLY whole length, seated in a landscape, directed to right, looking to left, face seen in profile; low white dress, dark felt hat with large feathers, holding branch of pink flower in left hand; trees in distance. Canvas, 30 × 25 in.



### MORRIS, MR. (p. 175)

The "Mr. Morris of Swansea" referred to on this page is probably Sir John Morris (1745-1819) of Clasemount, Co. Glamorgan, who was created a baronet in May 1806. In the will of Mrs. Emily Matilda Morris, of Porthcawl, published in "The Times" of 8 October 1913, her "picture of Sir John Morris by Hoppner" is bequeathed to her son Charles Smith Morris, but no particulars are available.

#### MORTON, EARL OF

EORGE DOUGLAS, Earl of Morton, K.T., and Vice-President of the Royal Society; born 3 April, 1761; succeeded his father as Earl of Morton in Sept., 1774; married 13 August, 1814, Susan Elizabeth, daughter of Sir Francis Buller of Lupton; Lord Chamberlain to Queen Charlotte; died s.p. 17 July, 1827, when his Scottish honours devolved on his cousin. Burke states that he was the 18th Earl, but Foster ranks him as sixteenth in the Earldom.

WHOLE-LENGTH, life-size, in the dress of the Scottish Society of Archers, standing in a landscape by a running brook, plaid coat, cream-coloured vest and breeches; right hand holding bow, left holding hat with feathers; powdered wig. Canvas,  $94 \times 58\frac{1}{2}$  in.

Exhibited at Messrs. Agnew's Gallery Nov.-Dec., 1913, No. 10.

NOTE.-This remarkable and very attractive portrait is included here "without prejudice." It was until recent years at Dalmahoy House, the residence of the Earl of Morton, who possessed, as may be seen from the entries on pages 334, 336, and 337, several family portraits by Hoppner. Many excellent authorities accepted without question the whole-length portrait of the Earl of Morton as by Hoppner. But at the Royal Academy of 1790, No. 125, Sir William Beechey exhibited a "Portrait of a Nobleman in the dress of the Scotch Society of Archers" which the contemporary press described as of Lord Morton. For many years the portrait had been regarded as by Raeburn, but it bears no resemblance to the work of that artist. It is clearly one of those portraits in which Hoppner and Beechey came very close together in technique and general treatment, so much so that it is not always easy to distinguish one from another. There is no reason why the Earl should not have been painted in the same costume by Hoppner as well as by Beechey. In any case we leave the problem an open one in the case of this portrait of the Earl of Morton.

#### MUNRO, MRS.

#### MURRAY, SIR GEORGE, G.C.B., P.C.

OUNGER son of Sir William Murray, 5th Bart., of Ochetyre; a General in the army, Colonel of the 1st Royals, Governor of Fort St. George; born 6 Feb., 1772; married in 1826, Lady Louisa Erskine, sister of the Marquess of Anglesea and widow of Lieut.-Gen. Sir J. Erskine; died 28 July, 1846. (See "Dictionary of National Biography.")

### NELSON, HORATIO, VISCOUNT (pp. 18, 23)

A copy by Morton of one of Hoppner's portraits is mentioned in the 3rd Viscount Nelson's will published in "The Times," 18 Aug., 1913.

A copy of No. 1, by Miss Belle Cornelius, was presented to the Maritime Club, 110 Fenchurch Street, London. See "The Times," 23 Jan., 1912.

#### NUGENT, MRS.

EBORAH CHARLOTTE DEE, married, first at Lisbon 31 January, 1782, Commodore Johnstone (1730-1787), a former governor of West Florida and a prominent politician, by whom she had one son; and secondly at St. George's, Hanover Square, 2 July, 1790, by special license, Charles Edmund Nugent (1759-1844), the distinguished naval officer, who was appointed Rear-Admiral 1797, Vice-Admiral 1801, Admiral of the Fleet 1833, and was knighted in 1834.

HALF figure, three-quarter face, looking up to left; brown dress cut low with white fichu tied in a bow; powdered hair bound with black ribbon; right arm resting on stone ledge; brown eyes; a two-row gold chain round neck; red curtain background. Canvas,  $30 \times 25$  in.

NOTE.—A fine portrait, painted about 1795. The witnesses of the second marriage were Leonora Dee and two others. The only issue of this marriage was Georgiana Charlotte Nugent, who married in 1822 the Rt. Hon. George Bankes, and their sixth son, Wynne Albert Bankes, afterwards of Wolfeton House, Dorchester, inherited the picture of his grandmother; it remained in the family until 6 March, 1914, when it was purchased by Messrs. Colnaghi and Obach.

## O'BEIRNE, MRS. (p. 187)

This lady died at the residence of Mrs. Stuart, Bolton Row, London, 27 September 1837, in her eighty-third year. "Since the Bishop's death," said a writer in the "Gentleman's Magazine" of Nov. 1837, p. 546, "Mrs. O'Beirne had resided at Warfield Lodge, Berkshire; she enjoyed the friendship of the most distinguished and talented of her day."

## O'HARA, MRS. (p. 188)

The first of these two portraits was offered at Christie's, 16 Dec., 1911, lot 111; an illustration of it appeared in the sale catalogue. The general impression about the picture was that it is an old copy of Mr. Harland-Peck's.

## OXFORD, COUNTESS, AND CHILD (p. 192)

A smaller version of No. 1 ( $40 \times 34$  in.) is the property of Mr. Asher Wertheimer, who acquired it in 1913. It shows the Countess to three-quarter length, and the whole figure of the child, a curtain and pillar forming the background. It is a replica done for a member of the family, in which it remained until recently.

### PAGET, MASTER



EARLY whole-length of a boy in a landscape holding his hoop and stick; blue dress with white lawn collar, flowing hair; white stockings. Canvas, 36 × 28 in.

This portrait is at Plas Newydd, according to Neale's "Views," vol. v.

### PAGET, LADY, AND CHILD (p. 196)

WO whole-lengths. Lady Paget standing, directed to left and looking to front; white low dress, almost entirely covered with black mantle or overdress, short sleeves, dark hair falling over forehead; child about three years of age in white dress, yellow sash, white stockings and black shoes, left hand holding her mother's right; pillar and dull reddish curtain background, landscape to right. Canvas, 96 × 58 in.

### PARKYNS, MR. (p. 198)

This portrait was lot 899 in the sale at Bunny Park, 22-25 Feb., 1910, and was bought by Major Paget for 900 gs.

### PARKYNS, MRS. (pp. 198-9)

There are two versions of this splendid picture, and both remained at Bunny Park until the contents of that mansion were dispersed, 22-25 February, 1910. The engraved picture was lot 900,  $50 \times 40$  in (an illustration appeared in the sale catalogue), and was purchased for 8,800 gs. by the late Mr. Charles Wertheimer. It is now in the collection of Mr. C. P. Taft, of Cincinnati, and is reproduced in "The Connoisseur," June, 1913.

The following lot (901),  $49\frac{1}{2} \times 39$  in., was in a neglected condition, but a careful removal of the coating of dirt revealed what proved to be the earlier of the two versions, a picture of superb quality and of the highest value. There are minor variations in the two pictures. In the earlier she is not wearing the heavy black lace shawl, but a light and much more elegantly disposed drapery flows over her shoulders and at her back; nor is she wearing the pearl necklace of the better-known picture; moreover, her appearance is much less matronly. This hitherto unrecorded version eventually came into the possession of Messrs. Agnew, who exhibited it at their galleries, Nov-Dec, 1910, No. 25. It was engraved in mezzotint by Norman Hirst,  $17\frac{3}{4} \times 14\frac{3}{8}$  in, 1911, and is reproduced in "The Masterpieces of Hoppner," 1912, p. 29.

### PEARETH, WILLIAM JENNENS



ON of William Peareth, Esq., of Usworth, Gateshead, and Washington, co. Durham; born in 1784; matriculated Christ Church College, Oxford, 22 Oct., 1801; died at Penzance, 1804.

HALF figure of a youth, to front, looking to right, in buttoned black coat and white stock; long curly hair falling over shoulders and forehead. Canvas, probably  $30 \times 25$  in.

### PILKINGTON, LADY (p. 204)

This portrait was lot 25 in a sale at the Hôtel Drouot, Paris, 26 April, 1907, and is illustrated in the sale catalogue.

#### PITT, WILLIAM (pp. 205-8)

A portrait of William Pitt, oval, "purchased by Mr. Seguier at Hoppner's sale," was lot 32, in William Seguier's sale at Christie's, 4 May, 1844, and then realized 41 gs.

### POYNTZ, MISS (p. 212)

ENGRAVED in mezzotint by H. Scott Bridgwater, 16 × 13# in., 1910.

### PRINGLE, MARK



NLY son of John Pringle, Esq., of Crichton; inherited the estate of Fairnilee through his mother, and those of Haining and Clifton on the death of his great-uncle, John Pringle; educated for the Scottish bar; M.P. for Selkirk, 1790-1802; married in 1795, Ann Elizabeth, daughter of Robert Chalmers; died at Bath 25 April, 1812.



### ROBINSON, MRS. (pp. 217-8)

A somewhat similar picture to No. 2, from the Walter Pleydell-Bouverie Collection of Market Lavington, Wilts, was purchased from Sir William Bennett on the advice of Mr. Frank Gibson and Mr. Charles Ricketts for the National Gallery at Melbourne. At the Pleydell-Bouverie sale it was catalogued as a portrait of Mrs. Abinger by Romney, neither of which is correct. A long article by Mr. Sylvestre Bonnard on the picture appeared in the Melbourne "Argus," 2 March 1912. In the opinion of both Mr. C. J. Holmes and Mr. Humphry Ward the portrait is undoubtedly by Hoppner.

### ROMNEY, LADY



THE HON. FRANCES WYNDHAM, daughter of Charles, Earl of Egremont; born 9 July, 1755; married 30 Aug., 1776, Charles, 3rd Baron (and afterwards 1st Earl) of Romney; died 14 Jan., 1795.

HALF figure in an autumnal landscape, directed and looking to left, face seen nearly in profile; old gold dress, white gauze flowing scarf; fair hair dressed high and falling over neck. Canvas,  $30 \times 25$  in.

Sold at Robinson and Fisher's, from the collection of Douglas Wyndham Lydgytt, Esq., 27 June, 1912, lot 170; purchased by Messrs. Wallis.

NOTE.—A particularly interesting and fine early example of the master, painted about 1779, and embodying a "scheme" frequently repeated later on—that of Lady Langham, for instance. The picture is in excellent condition. Hoppner painted a portrait of Lady Romney's younger brother, Percy Charles Wyndham.

### SACKVILLE CHILDREN (p. 225)

ENGRAVED in mezzotint by L. Busière,  $19\frac{3}{5} \times 15\frac{1}{2}$  in., 1914, and printed in colours. A companion print to the Cavendish Children (q.v.).

## SACKVILLE, VISCOUNT (p. 226)

HARLES GERMAIN, born 27 August, 1767; succeeded as Viscount Sackville, 26 August, 1785, and as 5th Duke of Dorset, 14 Feb., 1815; died unmarried, 29 July, 1843, when all his honours became extinct.

This portrait originally came from Buckhurst. Reproduced in "The Masterpieces of Hoppner," 1912, p. 23.

### ST. AUBYN, SIR JOHN



LDEST son of Sir John St. Aubyn, Bart., of Clowance, Cornwall; born 17 May, 1758; succeeded his father as 5th Bart., in Oct., 1772; an F.R.S., F.S.A., F.L.S.; M.P. for various Cornish constituencies; a great collector of fossils, minerals, and engravings; died at Lime Grove, Putney, 10 August, 1839, buried at Crowan, Cornwall.

HALF figure of a handsome young man about twenty-five years of age, facing to front; dark coat with high collar, waistcoat with yellow lappels, white stock; powdered wig. Canvas, 30 × 25 in.

## ST. CLARE, MISS (p. 226-227)

It would seem that her maiden name was Ann Vowells, and that she was known as "Madame St. Clair" as well as "Miss St. Clare." A small portrait of her by W. Hamilton, R.A., was sold at Christie's 2 July, 1909, lot 31, whilst lot 32 was another portrait of her by an unknown English artist.

### ST. JOHN, LADY LOUISA (p. 228)

The original of Barney's mezzotint has not been discovered, but the three-quarter length picture referred to by Lord St. John in the letter quoted in the Note on p. 228, was among the pictures sold at Christie's, 4 July, 1913, by the executors of the late Lord St. John, and removed from Melchbourne Park, Sharnbrook. It was lot 132, and was purchased by Mr. Asher Wertheimer. Lady St. John is seated on a pink window-seat near an open casement, in white muslin dress cut low, with short sleeves and white waistband; golden-red curly hair falling over forehead, lace scarf held with both hands on lap. Canvas, 49 × 39 in. The portrait is illustrated in the sale catalogue. Her portrait as "Hebe" by Sir Thomas Lawrence was sold on the same occasion. Her second husband was Sir *John* Vaughan, not Sir *Henry* as stated on p. 228.

#### SALT, HENRY, F.R.S.

ON of a Lichfield doctor; born in June, 1780; studied art under Joseph Farington, 1797, and John Hoppner, 1800; with George Viscount Valentia visited India, Ceylon, Abyssinia, etc., 1802-6; sent by Government on a mission to the King of Abyssinia, 1809-11; British Consul-General in Egypt, 1815-27; discovered the famous Abu Simbel inscriptions, 1817; collected Egyptian antiquities, which he sold to British Museum and French Government, the residue sold at Sotheby's, June, 1835, after his death, which occurred in 1827.

BUST portrait of a good-looking young man about twenty years of age, directed slightly to left, full face; blue coat, white stock, brown hair falling over forehead. Canvas,  $30 \times 25$  in.

The property of Mr. J. Baker, of Ledbury, Herefordshire, who acquired it direct from the Salt family in 1913.

NOTE.—Salt's "Life" was written by his friend and fellow artist, J. J. Halls, and published in two volumes in 1834. It contains many interesting details concerning Hoppner and his wife, with whom it is evident Salt was on intimate terms. He copied some portraits for Hoppner, with whom he remained about eighteen months, but without making much progress as a painter

## SHEFFIELD, ANNE, COUNTESS OF



ECOND daughter of Frederick, 2nd Earl of Guildford; born 8 Jan., 764; married, as his third wife, 20 Jan., 1798, John, 1st Earl of Sheffield; died 18 Jan., 1832.

THREE-QUARTER figure, in white dress with short sleeves, blue riband in her hair; landscape and foliage background. Canvas, 49 × 39 in.

Earl of Sheffield sale at Christie's, 11 Dec., 1909, lot 85; purchased by Messrs. Agnew.

#### SHERIDAN, R. B. (p. 235)

Another portrait, showing Sheridan in dark blue coat with brass buttons, red vest showing at the neck, powdered hair, canvas  $29 \times 24$  in., was in the J. Ruston sale at Christie's, 4 July, 1913, lot 118, and was purchased by Messrs. Wallis. Vet another portrait of Sheridan, half figure, directed to left, head turned and looking at spectator full face, in apparently a grayish coat with large buttons and deep collar, elaborate white frilled shirt front or neckerchief, and wig  $(30 \times 25 \text{ in.})$ , is in the Hitroff Collection at St. Petersburg. It was exhibited in that city during 1913, and is illustrated in the "Staryé Gody," the Russian art magazine, of December, 1912.

## SHERIDAN, MRS., AND CHILD (p. 235)

This exceedingly puzzling picture was sold at Christie's on 16 July, 1909, lot 136, as by an artist of the Early English School, and was bought by Messrs. "The Times" described it as a remarkable portrait, "sketchily and rapidly painted, the portrait almost recalls Frans Hals in the vigour of its handling, and is worthy to hang beside Hogarth's 'Shrimp Girl' as an example of what the English 18th century painters could do when they were content to be what we should now call impressionist." The portrait is probably by Hoppner, but it is quite unlike any portrait of Mrs. Siddons known to us. It was purchased by M. Charles Sedelmeyer, who lent it to "Les Modes à Travers trois Siècles," at Bagatelle, Paris, 1911, No. 78, in the catalogue of which it is reproduced. 
