

Subject: Discoveries of Explosives.

1. Following shown here is a report to your office on discoveries of explosives made December 3, 1948 in the jurisdiction of the Takeno District Police Station of National Rural Police.

2. A)

- i) Date of Discovery: December 3, 1948, at around 11:00
- ii) Geographical Location: North-western coast of Kyoto-fu, Kinki Districts, Honshu Japan.
- iii) Precinct Police Station: Takeno-District Police Station of National Rural Police.
- iv) Location of Explosive: On a rock of the shore, about 100 meters off from a house, Sunakata, popularly known as Ryugu Beach, Taida-cho, Takeno-Gun, Kyoto-fu.
- v) Kind and Quantity of Discovered Explosive: One floating-mine; not known whether a U.S. Military property or a former Japanese Navy one.
- vi) Action Taken by the Police: Fastened in cooperation with the Police and Civilians to the ground with wires so as not to float away.

B)

- i) Date of Discovery: December 3, 1948.
- ii) Geographical Location: North-western coast of Kyoto-fu, Kinki Districts, Honshu, Japan.

- iii) Precinct Police Station: Takeno District Police Station of National Rural Police.
- iv) Location of Explosive: Taido Police Booth for Police Sergeants, Takeno-Gun, Kyoto-fu.
- v) Kind and Quantity of Discovered Explosive: One U.S. Army grenade-thrower; 10 cm in length and 7cm. in diameter.
- vi) Action Taken by the Police: In custody of the previously mentioned Police Booth for Police Sergeants ever since the date of receiving the information from a discoverer.



1. The retention of 39 nickel plated Samurai type swords appears to be a violation of Imperial Ordinance 300, 1946 and Operational Directive 75, 1946, as amended. Retention of the Chinese broadswords made of soft metal is a technical violation of the Imperial Ordinance in the same sense that painted bamboo or wood swords would be. However, there are provisions whereby certain weapons may be retained as indicated in attached English version of Imperial Ordinance 300.

2. It is therefore recommended that the swords in possession of the Dai-Ei Cinema Studio be disposed of in accordance with Japanese legal procedures.
