



SECTION I--INTRODUCTION

CURRENT ANNUAL REPORT

This report presents statistics on patients in public institutions for mental defectives and epileptics. The data are based on schedules received for the 31st Annual Census of Patients in Mental Institutions, the 10th such census to be conducted by the National Institute of Mental Health.

The tabulations are comparable to those in earlier publications. They consist of a book-keeping account of the flow of patients into and out of public institutions and of statistics on certain characteristics of first admissions and resident patients, and on personnel and expenditures.

The generous cooperation of the various State governments and of the superintendents and staffs of the individual public institutions is gratefully acknowledged. Without their assistance this report could not be made.

PREVIOUS REPORTS

A detailed historical account of the development of the Annual Census of Mental Patients can be found in "Patients in Mental Institutions: 1947" pp. 1-4, U. S. Government Printing Office, Washington 25, D. C.

The first annual enumeration of patients in institutions for mental defectives and epileptics was made in 1926. Equivalent data have been published in each succeeding year.

Public Health Service Publication No. 632 is divided into four parts as follows:

- Part I - Public Institutions for Mental Defectives and Epileptics
- Part II - Public Hospitals for the Mentally Ill
- Part III - Private Hospitals for the Mentally Ill and General Hospitals with Psychiatric Facilities
- Part IV - Private Institutions for Mental Defectives and Epileptics

SECTION II--SCOPE OF THE DATA

PURPOSE

This annual survey is designed to provide basic data on the number and characteristics of patients first admitted to and resident in the public institutions for mental defectives and epileptics. In order to fill certain administrative needs the survey also provides data on movement of patient population, expenditures, and personnel employed.

COVERAGE

The period covered in this report is the fiscal year ending in 1956. Most of the institutions reported for the year ending June 30th. The exceptions to this are as follows:

Reporting of population movement data was complete for 99 of the 100 public institutions (See Table A). Reporting was less complete for the more detailed data. The number of hospitals reporting is indicated at the top of each table and the number of patients for whom detailed data were not reported is

SECTION III--DEFINITIONS

TYPE OF INSTITUTION INCLUDED

Included in this survey are all known public institutions for the care and treatment of mental defectives and epileptics. All of these institutions are under State control except one, the Wayne County Training School, Northville, Michigan.

In 1956, Arkansas and Nevada had no public institutions but mental defective and epileptic patients received care at the state mental hospitals.

DATA ON MOVEMENT OF PATIENT POPULATION

Data on the movement of population represent a formal accounting of the flow of patients into and out of public institutions during the year. The classification covers patients on the books at the beginning of the year, admissions, separations, and patients on the books at the end of the year. It should be pointed out that these data include some duplication of patients since the number of transactions is counted rather than the number of patients. Each of the categories used, together with its subclasses, is listed and defined below.

1. Patients on the books at the beginning of the year. All patients on the books of the institution are classified by actual location as follows:
 - (a) In institution. Patients physically present, or accounted present, in institutions (that is, those considered "resident patients").
 - (b) In extramural care. Patients on the books of the institution but not in actual residence (that is, subject to institution control but residing in a location other than the institution proper). These patients are further classified as follows:
 - (i) In family care. Patients placed in the community in private families other than their own, under State supervision. The expense of maintenance may be borne by the State, the patient's estate, relatives, public assistance programs or some other agency or person.
 - (ii) In other extramural care. Most patients in this category are out of the institution on various types of leave, to their own home or to an employment situation. These types of extramural care not only test the ability of the patient to cope with normal community life, but also test the ability of the community and family to cope with problems presented by this type of patient. Since the patient is retained on the

books of the institution, he can be returned to the institution for his own protection, for that of the community, or because he is unable to get along outside of the institutional environment. The provisions under which patients are placed on home leave vary widely from State to State. Moreover, factors such as the degree of overcrowding, the development or extension of methods of training and therapy, and the number of social workers available for follow-up may affect the number of patients on home leave at any given time. In addition to patients on home leave, this category includes escaped patients and patients absent from the institution for reasons not classified elsewhere.

2. Admissions. All patients entering an institution during the course of a year are sub-classified as follows:
 - (a) First admissions. All patients admitted to a public institution without a record of previous care (that is, a record of an admission and a formal discharge) in such a public or private institution anywhere. The term is usually applied exclusively within a given type of institution; thus, a patient going from a hospital for mental disease to an institution for mental defectives and epileptics, or vice versa, is considered a discharge from the first institution and a first admission to the second rather than a transfer or a readmission.
 - (b) Readmissions. Patients admitted with a record of previous care as indicated above.
 - (c) Transfers in. Admissions representing patients shifted within the same State from the supervision of one public institution to that of another without a formal discharge. Since transfers in do not represent additions to the total patient population of institutions within a given State system, and since they presumably have already appeared at some previous time in statistics on admissions, they are not given detailed consideration in this report.
3. Separations. All patients removed from the custody of the institution are sub-classified as follows:
 - (a) Discharges. Patients formally removed from the books of the institution. Such patients may be discharged directly from the institution or from extramural care.
 - (b) Deaths. Patients who die while in the institution or while on extramural care.

- (c) **Transfers Out.** Patients shifted within the same State from the supervision of one public institution to another, without a formal discharge.

CLASSIFICATION OF PATIENTS WITH BOTH MENTAL DEFICIENCY AND EPILEPSY

Patients are classified according to the primary cause for admission as follows:

1. If the case history shows that the patient was primarily mentally defective and that epilepsy developed at a later date, the patient was reported on the schedules for the mental defectives.
2. If the case history shows that the patient was first epileptic and that mental deterioration developed at a later date, the patient was reported on the schedules for epileptics.
3. In all cases where epilepsy was definitely present, and where the patient's previous mental status was undetermined, even though mental deficiency was now established, the patient was reported on the schedules for epileptics.

Patients reported as "neither mentally defective nor epileptic" are indicated in Table 1 under the heading "Other" and are not included in any other table.

CHARACTERISTICS OF FIRST ADMISSION AND RESIDENT PATIENTS

Tables are presented for both of these patient categories, for the United States and each State by clinical diagnosis, mental status, age and sex. For first admissions, age is computed as of the date of the last birthday prior to admission. In the case of resident patients, age is computed for the last birthday as of the end of the reporting year.

Mental Defectives. Mental defectives admitted to institutions may be characterized both by clinical diagnosis and by mental status. The diagnostic classification is based on that prepared by the American Association on Mental Deficiency in cooperation with the National Association for Mental Health, Inc., and was published by the latter in 1946 in the "Statistical Manual for the Use of Institutions for Mental Defectives".

Mental status is indicative of the degree of intellectual impairment and is classified as follows:

- (a) **Idiot.** A mentally defective person usually with a mental age of less than 3 years

or, if a child, an intelligence quotient of less than 20.

- (b) **Imbecile.** A mentally defective person usually with a mental age of 3 to 7 years, or, if a child, an intelligence quotient of from 20 to 49.
- (c) **Moron.** A mentally defective person usually with a mental age of 8 to 11 years, or, if a child, an intelligence quotient of 50 to 69. However, this upper limit may be disregarded where medical, social and other factors clearly indicate that the patient is mentally defective.

Epileptics. The diagnosis for epileptic first admissions are based on those adopted by the National Epilepsy League¹. The major categories are as follows:

- (a) **Symptomatic.** Cases in which the epileptic seizures are symptoms of a definite disease process, toxic condition, or structural defect.
- (b) **Idiopathic.** Cases in which the seizures are not associated with a disease process, toxic condition, or structural defect.

CHARACTERISTICS OF DISCHARGED PATIENTS

Beginning with this report tables on discharge by condition on discharge and sex are neither presented in the annual report nor are they collected in the annual census. There are two main reasons for this:

1. Discharge from the books of an institution is used by different institutions in different ways. Some institutions discharge a large proportion of patients directly while others usually have a period of home leave, parole, convalescent leave, etc., prior to discharge. In many States discharge from home leave, etc., is administrative and does not require that the patient return to the institution. Therefore, since the definition of "discharge" is not consistent among States, the interpretation of discharge data is quite complex.
2. The methods and standards for determination of condition on discharge are not uniform among the States. Thus, a valid interpretation of this statistic for single institutions or for comparisons between institutions or State systems cannot be made.

SECTION IV.--LIMITATIONS OF THE DATA

INSTITUTIONAL PATIENT DATA AS MEASURES OF PREVALENCE AND INCIDENCE

It might be expected that interstate differences in resident patient and first admission

rates for the public institutions would provide a basis for inference as to variations among the States in the prevalence and incidence of mental deficiency or epilepsy which is sufficiently serious to require institutionalization.

However, based on present knowledge, there are a number of reasons why such inferences should not be made. Not all persons with serious mental deficiency or epilepsy are admitted to public institutions. The number of persons in the community who, under examination, would be diagnosed as mentally deficient or epileptic, is unknown. Furthermore, there are many factors other than the person's mental condition which determine whether or not care will be sought for him, such as (a) availability of family and willingness to keep the person at home, and (b) community attitudes toward the person's behavior.

In cases where care or training is sought, there are other factors determining whether or not these cases will be admitted to public institutions.

- (a) In many communities, private institutions, special training schools, and other specialized agencies are used for the training of persons with less severe forms of mental deficiency. In the absence of such facilities, these persons might have been admitted to the public institutions. There is considerable variation among States in the availability of these facilities and in the ways they are used by the communities they serve.
- (b) Within a State system, existing facilities may expand, new facilities may open, or other changes may occur that would have the effect of increasing or decreasing the number of patients that could be accommodated.
- (c) Because of space limitations in some institutions, patients may be admitted

from a waiting list. A prospective patient may remain on this list for as long as several months or more before being admitted, depending, of course, on the severity of his case and the urgency for institutional care.

- (d) There are no public institutions for mental defectives and epileptics in Arkansas and Nevada. Hence, mental defective or epileptic persons in these States are admitted to the State mental hospitals. Even in States that have public institutions, mentally defective or epileptic persons occasionally may be admitted to the State mental hospitals.

Therefore, since the number of persons in public institutions does not reflect the entire problem or even a known proportion of the problem of "serious" mental deficiency or epilepsy, rates of admission to or residence in public institutions are not valid measures of incidence and prevalence of "serious" mental deficiency or epilepsy.

Data on overcrowding are not presented in this report. Methods determining the rated capacity, from which overcrowding is computed, vary such that comparison among States of percent overcrowding may be misleading.

Data on personnel vacancies also are not presented in this report. Some institutions have established tables of organization which would indicate the number of vacancies, but other institutions which do not budget for specific positions could show only unexpended funds for salaries and wages. Therefore, interpretation of data on personnel vacancies would be difficult.
