Having first duly sworn an oath as on attached sheet and in accordance with the procedure followed in my country I hereby depose as follows.

Affidavit

I, TAKAHASHI, Michitoshi, state under oath as follows: My present address is no. 40, 3-chome, Showa -dori, Nakano-ku, City of Tokyo.

I was on my post in Berlin as the Secretary of Protocol for the Japanese Ambassador in Berlin from about September, namely, immediately before OSHIMA, the ex-Ambassador to Germany, took his post, until January 1939.

During this period all the conversations of Ambassador OSHIMA with high German officials were arranged beforehand by me as the Secretary of Protocol as to their date, time,

place, etc.. As far as I remember, there has never been any case in or about January 1939 that Mr. Himmler requested of an interview with the ex-Ambassador OSHIMA. No request was also made by ex-Ambassador OSHIAM to see Mr. Himmler.
