

Impact of COVID-19 on national censuses of agriculture

(Status overview)

The Statistics Division of the Food and Agriculture Organization of the United Nations (FAO) is coordinating the **World Programme for the Census of Agriculture 2020** (**WCA 2020**), which supports national agricultural censuses conducted during the 2016–2025 round. As the COVID-19 pandemic continues to spread across the world's regions, countries have increasingly declared states of emergency and implemented physical distancing, restrictions on movement and other safety practices. These measures have had a clear and direct impact on agricultural census activities (see http://www.fao.org/3/ca8605en/CA8605EN.pdf).

FAO is monitoring this impact and provides an overview of the pandemic's effects on ongoing agricultural census activities. A rapid appraisal and informal consultations with national agricultural census authorities are presented below. This information is updated regularly as updates from governments are received.
