SYNOPSIS OF FACTS: The subject organization has filed incorporate papers in the State of Massachusetts under the name "The Moorish Science Temple - The Divine and National Movement of North America Incorporated." Incorporate papers reviewed. Officers, directors and addresses set forth. The subject estate located at Becket, Massachusetts, suffered a \$1,000 damage caused by fire on May 18, 1944. An account of the fire is set forth.

DETAILS: This case is being re-opened to report the information pertaining to the organization incorporating in the State of Massachusetts.

[REDACTED] The writer received a call from the Office of the Corporation on 5/17/44 stating that they had received the incorporate papers with an attached check of twenty-five dollars as the incorporate fee, requesting that this organization be incorporated under the laws of the State of Massachusetts.

The writer reviewed the corporate papers and the following information was obtained: The name of the organization is to be known as "The Moorish Science Temple - The Divine and National Movement of North America Incorporated. The principal office in Massachusetts is located in the town of Becket. The purpose is for the purpose of uplifting fallen humanity, to teach our people to obey the laws of our government, also their nationality and religion and to promote good American citizenship.

through charitable and religious educational programs. The first meeting of the organization was held in Room 33, 1214 Main Street, Springfield, Massachusetts, on May 8, 1944 at 10 A.M. [REDACTED]

All members hereinafter designated as directors and officers were present at this meeting.

Some of the by-laws other than the usual routine by-laws were listed as follows: the name is the same as mentioned above, principal office - Becket, Massachusetts, Hampshire, County. The seal of the corporation will be circular in form and shall contain the name of the corporation, the year of its incorporation and the word "Massachusetts." The fiscal year of the corporation shall end December 31. The purpose is the same as previously mentioned. The officers shall consist of President, clerk, treasurer and board of ten directors. Each officer is to hold his office for the term of one year unless removed by death, resignation or expulsion. Meetings of the corporation shall be held the second Wednesday of each month. The annual meeting will be the 15th of September and all officers will be elected that day. The membership fee shall be set by the Board of Directors.

The letter forwarding the incorporate papers together with a check for \$25 signed by Attorney Lloyd S. Bardach drawn on the Third National Bank and Trust

Company, Springfield, Massachusetts, was dated May 13, 1944.

A newspaper clipping appearing in the Berkshire Eagle, Pittsfield, Massachusetts, dated May 13, 1944 reports the reference fire at the subject's estate in Becket Massachusetts:

"The Fire Department was called at 3 yesterday afternoon to fight a fire at the Moorish Science Temple property, formerly the Berkshire Homestead Farms and Edwin A. Carter's Dally-hole place.

"A rubbish pile became ignited and the fire quickly spread to two nearby buildings, an ice house and a root cellar. Both were totally destroyed with a loss of about \$1000. The department responded promptly but was unable to save the buildings. Water for the big pumper was drawn from the private pond more than 1000 feet up a steep grade, the pumper throwing two strong streams on the burning buildings. Firemen were able to control the fire and prevent it spreading to the large farm barn and the near-by farmhouse.

"Several young women assisted the firemen in controlling the large grass fire that burned over an acre or more of land."

The following is a summary of the information obtained from the Local Board's at Richmond, Virginia, on April 24 and 25, 1944, concerning the EL's and BEY's registered at these boards:

[REDACTED] EL: This individual is registered at Local Board #5, Richmond. His Order Number is [REDACTED] and his Serial Number is [REDACTED]. At the time of his registration he listed as his address [REDACTED]. At the time of his registration he was un-employed.

He was inducted into the Army on [REDACTED] 1942, and received an honorable discharge on [REDACTED] 1943. While in the Army he was given Serial Number [REDACTED]. He was a Corporal assigned to the Headquarters of the [REDACTED] California. Upon his discharge from the Army he resided at [REDACTED] California, and was employed as a shipwright by the [REDACTED].

[REDACTED] His Social Security Number is [REDACTED]

Listed as dependents were his mother [REDACTED] EL, [REDACTED] EL, Richmond, and a son, [REDACTED] EL, [REDACTED] Richmond.

In the file it was noted that [REDACTED] EL claimed to be a minister of the Moorish Science Temple. He stated that he was ordained on July 27, 1943, by the Prophet NOBLE CROWN ALI, at Chicago, Illinois. A letter in the file from the subject stated that his parents were born in Morocco and that he should be classified as a Moor rather than a negro.

He registered on [REDACTED] 1942, and at that time he was employed at the [REDACTED] Richmond, Virginia. He was recently classified 1-AH on [REDACTED] 1943. In his Selective Service Questionnaire he stated that his Social Security Number was [REDACTED]. He listed his employer as being the [REDACTED] Richmond, Virginia. However, he pointed out that he was serving temporarily as a minister that was not ordained at the Moorish Science Temple of America, 13 East Charity Street, Richmond, Virginia. His wife is employed [REDACTED] in Richmond.

[REDACTED] BEY: This individual is registered by Local Board #3, at Richmond. He was given Order Number [REDACTED]. In this file it was noted that he was born in [REDACTED] and that he is employed by the [REDACTED] Richmond, Virginia, as a car washer. This individual could not read nor write and the Board filled in his questionnaire, in which he claimed to be living with his mother [REDACTED] BEY, age 56, and his sister [REDACTED] BEY, age 21, [REDACTED] age 5, and his niece [REDACTED] BEY, age 3.

[REDACTED] BEY: This individual registered on [REDACTED] 1940, and was assigned Serial Number [REDACTED] and Order Number [REDACTED]. This subject was remembered by [REDACTED] of the Local Board, because he claimed that he was not a negro and objected to being inducted with the negroes and examined by a negro doctor. The Local Board sent him to Baltimore to be examined at an Induction Center there. A letter was received by the Local Board dated March 19, 1943, from Local Board #18, 110 West Lexington Avenue, Baltimore, Maryland, advising them that they had handled the subject's examination at the Induction Center and that [REDACTED] BEY had been rejected.

In an interview with [REDACTED] stated that this individual had refused to comply with the Board when they requested him to appear for his blood test. He refused to comply on the grounds that he was not a negro and therefore should be examined by a white doctor. However, the Board threatened to classify him as a delinquent and report him to the United States Attorney if he refused to appear for his examination. Therefore, the subject appeared for the examination.

His occupational questionnaire dated June 23, 1944, indicated that he was employed as a baker by the [REDACTED] Baltimore. At one time this individual was living at [REDACTED] Baltimore.

Another letter was dated June 23, 1942, to Local Board #4, at Richmond, from Local Board #18 in Baltimore, which indicated that BEY was ordered to report for his blood test at the Provident Hospital. He refused to allow his examining doctor to be a negro and walked out of the Hospital rather than to be examined by one. The letter stated that the reason he did this was that he claimed to be a Moorish-American rather than a negro.

On February 2, 1942, the Department of Public Welfare for the City of Richmond, directed a letter to Local Board #4, requesting that Board to furnish them with the address of the subject. They were checking this information because the subject was not supporting his children. The Local Board stated in their reply that this individual had moved to Chicago and could be reached c/o Mohammedan Church in that city.

The Clerk of the Local Board advised that [REDACTED] the Social Service Bureau for Richmond, Virginia, was interested in this individual.

[REDACTED] was interviewed on the same date, and she advised that this individual had applied to her for assistance from the City. During the interview with her, BEY stated that he was suffering from a severe case of heart trouble and was not able to work. [REDACTED] believed that there is a warrant out for his arrest as a wife deserter.

Present with [REDACTED] BEY was [REDACTED] IL, who claimed to be an ordained minister of the Moorish Science Temple of America. [REDACTED] IL accompanied [REDACTED] BEY as an advisor and assisted him in answering all the questions which [REDACTED] asked. [REDACTED] stated that BEY indicated that he had joined the Moorish Science Temple about eight years ago.

[REDACTED] of Local Board was interviewed in connection with the subject's request for classification of Conscientious Objector. She indicated that she was not familiar with the grounds upon which he based his request, inasmuch as the subject had been classified 4-F and the Board had not considered him to be delinquent. He stated that this was a religious organization which formerly believed in peace and did not support any war. When questioned as to whether or not he would prefer to see the Japanese win the war by the United States taking a peace stand, he stated that he did not want either the Japanese or the Americans to win the war. However, when questioned again in the same vein, he stated that he was in favor of the United States winning the war with the Japanese, and also hoped the United States would be victorious over Germany. He stated that in Richmond at the present time about thirty people attend the meetings of the Moorish Science Temple. This is in contrast to about one hundred people who attended the meetings about two years ago. He stated that many have drifted away from the religion. However, this Church is still quite active.

b7E

He stated that at no time as far as he could remember have any white persons or Japanese spoken before the Temple at Richmond. He mentioned NOBLE DREW ALI of Chicago, and KIRKMAN BEY as being the only two outsiders whom he ever remembered having spoken before the group here in

Richmond.

He stated that it was also the belief of the religion that the members were of Spanish ancestry. Their ancestors migrated to Morocco where they were made slaves and brought to the United States several hundred years ago. They do not want to be classified as negroes and claim that they are either Orientals or Moroccans.

When asked to produce his credentials showing that he was a Moor rather than a negro, he stated that he did not have it on him, and as a matter of fact never did have one. ██████████ EL, it is to be noted, appeared to be very cooperative though ignorant.

Clerks of all the Local Boards at Richmond, when questioned concerning the individuals listed above, advised that none of them were delinquent at the present time, and that none of them had ever appeared to object to entering the Armed Forces if the Board so requested.

b7c concerning [redacted] has been incorporated in a separate report. The following additional information concerning KIRKMAN and his organization was obtained in the interview:

KIRKMAN claimed to be an interpreter for the Prophet NOBLE DREW ALI while he was alive. He claimed that his education was as follows:

4 years - Delhi University, Delhi, India

4 years - Cairo University, Cairo, Egypt

2 years - Campbelle College, Mississippi, where he majored in agriculture.

b7c He was married while in Cairo to an Egyptian girl. Three children were born of this marriage but when he returned to the United States she would not accompany him whereupon he brought the youngest child with him and left his wife and two children in Cairo. Upon his return to the United States he married [redacted] by whom he has seven children among which are [redacted] and [redacted] who are presently serving in the Armed Forces. As proof of the fact that his sons were in the [redacted] he proudly exhibited pictures of them in uniform.

b7d Concerning [redacted] EL, who operates a separate branch at [redacted] KIRKMAN stated that he was of the opinion that [redacted] was very ill and not expected to live. Were it not for this fact, KIRKMAN stated that he would institute court action and prohibit [redacted] from conducting meetings inasmuch as he was operating fraudulently without the sanction of the governing body. In connection with this, KIRKMAN also stated that he was instituting court action against [redacted] EL in New York City for infringement. He stated this hearing was being held on [redacted] 1944 in New York City. The attorneys representing KIRKMAN were indicated as [redacted] New York City, New York.

According to KIRKMAN, he advocates that all members of his organization interest themselves in farms and farming; that they should attempt, whenever possible, to move onto farms. He stated that he has several more or less cooperative farms in which members can go to live, one of these being located at Prince, Georgia and the other near Hope, Indiana. He claimed that he uses his previous agricultural training in school to further the interest of these farms. He claims that he buys cattle and hogs from Michigan and Indiana and ships them to these farms. He stated that he had several International Trucks which he had formerly used for the furtherance of the transportation and shipping needs of the farms but that recently, due to the restriction on gasoline, he had been forced to discontinue the use of trucks. He also stated that there are plans under way to establish a similar farm in

berkshire, Connecticut. He stated that regular meetings are being held at 1032 Orleans Street on Sundays; that formerly they held meetings on Tuesday and Friday evenings but due to the fact that the hall is being utilized by the Masons during week days, they were unable to rent the hall. He claimed that the membership of Temple No. [REDACTED] is around four or five hundred members, the Grand Sheik of this Temple being [REDACTED] EL.

In connection with the organization, KIRKMAN was asked if at any time there had been any affiliations with the Japanese and was further questioned as to whether or not the Japanese had ever contacted him or any members of his organization in view of using the organization as a propoganda organ for the Japanese Government. KIRKMAN denied that the organization had ever harbored any Japanese propensities or that Japanese agents had ever contacted him or any members of his organization. He did state, however, that he had heard that the Japanese had contacted the Pacific Movement of the Eastern World many years back and that it was his understanding that the Pacific Movement was a pro-Japanese organization which was an organ of the Japanese Government. He denied having any specific knowledge or ever having any affiliations with the Pacific Movement of the Eastern World, however.

On April 13, 1944, [REDACTED] BEY [REDACTED] who is Assistant Grand Sheik of the [REDACTED] Branch, was interviewed by the reporting agent at his place of employment which is the [REDACTED]

BEY claimed that KIRKMAN and all others were operating fraudulently without authority; KIRKMAN had in fact organized his own organization by modifying the original charter which was known as the Moorish Holy Temple of Science to the Moorish Science Temple of America, Incorporated. He claimed that [REDACTED] EL was at the present gravely ill and unable to see any visitors. He further claimed that the organization was in no way un-American or pro-Japanese; that they merely taught the five principles of love, truth, peace, freedom and justice. Along this line, he stated that one member of [REDACTED] Branch had attended the Arabic School on South Wabash. He was of the opinion that this school was un-American and that the member had gone again to this school against his will but he was unable to stop him. From the description given by [REDACTED] of the Arabic School, it is believed that the school in question was a mosque located at 4448 South Wabash under the tutelage of [REDACTED] who is the leader of the Ahmadiyya Movement in Islam. At the present time, this mosque is apparently closed.

 boot black in the barber shop of [REDACTED] BEY, Field Representative of
 instant organization. This barbershop is located at [REDACTED] and
 is alleged to be the meeting place or headquarters of [REDACTED] [REDACTED] Indiana.
 Reporting agent did not reveal his identity but engaged [REDACTED] in a conversa-
 tion while [REDACTED] was shining agent's shoes. While waiting his turn reporting

 Moorish people. Furthermore he could trace back his ancestry ten thousand
 years. He advised the agent he was a member of the Moorish Science Temple,
 indicating the crescent and star displayed in the store, and also the
 various group pictures and emblems of the organization. He carefully
 pointed out his own picture among the various members of a national con-
 vention of the organization, asserting he played in the band. He indicated
 a picture of the organization's flag, namely the Moroccan flag, and advised
 that the local members of the organization met in the rear of the barber

On June 9, 1944, [REDACTED] second floor, who owns the building at that address, wherein subject [REDACTED] EL resides, was contacted by thereporting agent. She related the following story:

The group has been unusually quiet and very little is heard or seen of their activity. They always talk in whispers or very low voices. Occasionally they are heard to sing as a group, indicating that they are conducting regular meetings within the building. They receive a very large volume of mail. Very often they receive special delivery packages. They buy food on a wholesale basis and it is believed that they have a form of cooperative buying whereby they may effect a savings by buying in large quantities.

One of the members was overheard to make the remark in a grocery store nearby that the group was in full accord with the principles of MAHATMA GHANDI and in fact followed principles set forth by GHANDI. The total membership of the group living in the vicinity totals approximately 50 members. No subversive activity has been noted on the part of the organization by the informant.

In view of the fact that no subversive activity has been noted, this case is being closed and any further activity of the subject organization will be included under the heading of the main subject file, "The Moorish Science Temple of America, Incorporated."

The Miami and Detroit Field Divisions, who have outstanding leads in this matter, were advised to discontinue investigation by teletype dated July 6, 1944.

On this day fifty thousand members would rise up to assist the Japanese. During the course of a conversation after a neighbor had passed her home [REDACTED] remarked that this individual's name was [REDACTED] retired, who resided a block or so away.
