## INTRODUCTION.

---

I examined most of these works while engaged in studying the development of Banking in Ireland during the eighteenth century, and extracted a large number of notes from such as had any bearing on that subject. Finding myself obliged to leave London, before I had time to incorporate the substance of these notes in a monograph, and it being unlikely that I should have an opportunity during the next few years to complete the work, I decided to print simply the Titles with the notes attached, in the hope that they would prove of some use to other students of Irish Economic History.

As the time at my disposal was very short, I have been obliged to omit entirely, or reduce to very small proportions, the notes which I had taken from the better known works. Time was also lacking to re-write the notes, and, therefore, in many cases they appear as originally jotted down.

The Libraries were examined in the following order :—

The British Museum.

Trinity College, Dublin.

The Halliday Collection to 1735.

The Bradshaw Collection in the Library of the University of Cambridge.

The Halliday Collection from 1735 on.

Most of the tracts to which the Press-Mark of the British Museum is attached, are also to be found in the Halliday Collection.

After having examined these libraries, I fortunately discovered a few tracts, which I had not seen previously, in the possession of E. R. McClintock Dix, Esq., the Irish Bibliographer, who very kindly gave me permission to examine them.

I beg to tender my thanks to the officials of Trinity College Library, Dublin, The Royal Irish Academy, and the Library of the University of Cambridge, for the assistance which they have very kindly given me in making these researches.

# IRISH ECONOMICS: A BIBLIOGRAPHY.

## 1700-1783.

1. SEASONABLE PROPOSALS For a perpetual FUND OR BANK IN DUBLIN. For the Improvement both of LANDS and TRAFFICK, suitable to the *Trade, Money, and Business* of IRELAND, both in Relation to *England* and other Foreign Parts: Maturely Calculated, both for the present Juncture, and the General Good of the said City and Kingdom, and Particular Advantage of all the Subscribers; who now, if they please may securely make above 20 *per Cent. per Ann.* clear Profit of their Money. The intended Methods are Drawn and Improved, both from a true Experience, and by the best Examples of all the *Banks* in *Europe*: It is therefore humbly proposed by *Richard Holt*, of *London*, Merchant, and others, to proceed as followeth, *viz.*

I. THAT at *Dick's* Coffee House in *Skinner Row*, near the *Exchange* in *Dublin*; a Book pursuant to the following Proposals, shall be speedily prepared and lye open daily, from Nine till Twelve, and from Three till Six of the Clock, for the space of one Month, or until One Hundred Thousand Pounds, or more, be Subscribed by any Persons whatsoever, who please to subscribe themselves, or order the Subscribing thereof by others; at which Place these printed Proposals may be had Gratis; also Attendance shall be there given, to Answer Objections which will be made by a few Goldsmiths and Scriveners, and perhaps by some Merchants who deal by Exchange, and have not yet duly consider'd these Matters.

II. That no Person shall Subscribe less than 50 l. nor above 5000 l. in this Fund, until the last Six Days of the limited time; and each Person having 100 l. Interest therein in his own proper Right, shall have one Vote in all Elections, and other Matters hereafter to be Debated; and no Person whatsoever shall have more than one Vote.

III. That no Person shall be capable of being a Trustee, or Director in this Bank, who hath not 500 l. Interest, or more on his own Name, and in his own proper Right, during all the time he shall so Act.

IV. That within Six Days after the said Fund shall be compleated to the Satisfaction of the Subscribers, of which at least Three Days Publick Notice shall be given, and fixed upon the Exchange; there shall be a General Meeting of the Subscribers Qualified to Vote; who by Balloting, shall choose from amongst themselves a Committee of Fifteen such Persons, as by the Majority of Votes shall be Esteemed fittest to be Trustees, or Directors for the Trust and Management of the said Fund, until the first Day of *May* 1697, or until others shall be Elected and Invested into the said Trust, by the said General Assembly; which Election shall always hereafter be in the Month of *April* every Year.

V. That within Three Days after the said Election shall be made and declared, the said Directors shall Meet and Elect out of themselves, a Chairman; and always afterwards at every General Meeting of the said Directors, a Chairman out of the Majority

of them shall be Elected, and always by Balloting all Elections shall be made whatsoever.

VI. That the Trustees and Directors for the time being, or the Majority of them together, shall by the Majority of Votes, have Power to Decide all Questionable Matters relating to the said Bank, or Compa, and every, or any part thereof, and full Power of the whole Management of the Joynt-Stock; to Buy, or Purchase, or Lend on Securities, for the said Compa; and to prepare Rules, Orders and Methods, and to choose all other Officers and Servants, and to pay them their respective Salleries: But all, or any of the said Officers, Servants Rules, or Orders, shall, or may be Approved, Confirmed, Altered, or Rejected by a General Assembly of the Proprietors, which at any time the Directors (or if they refuse then any Five of the Proprietors Qualified to Vote) shall have Power to call together: and the said General Assembly shall Limit, and Appoint what Salleries the several Directors shall have; and shall have Power also, if to them it shall seem meet at any such General Meeting to displace any of the said Directors, or Trustees, and to choose others in their Rooms.

VII. That all Persons whatsoever, who shall be concerned in this Joynt-Stock or Fund, shall be True and Faithful to the Joynt Interest thereof, and shall Acquies in, and perform all Determinations, Rules, and Orders of the Majority of the said Proprietors, under the Penalty and Forfeiture of such part of His, Her, or Their Interest in this Fund, as the said Directors for the time being shall think meet; all which Forfeitures and Penalties, shall be to the Use and Benefit of this Bank.

VIII. That the Subscribers shall Transfer to the said Trustees and Directors their respective Interests, in Trust for the said Proprietors, in such manner, and to such fit and proper Uses, as the Nature and Improvement of this Bank doth require; which Trust, the said Trustees and Directors are also to except; for which purpose, a Draught of a Deed of Settlement in due time shall be prepared for their Approbations; by which all needful Provisions shall be made, and especially these two which next follow, *Uiz.*

IX. That the said Directors and Trustees in their own particular Persons and Estates, shall be effectually Secured and Indemnified for their Acting; except for willful Fraud, or Breach of Trust; in which Cases, the Person Guilty only shall be Chargeable.

X. The said Directors and Trustees, or the said Subscribers, or Owners of the said Fund, in their Persons or Estates, shall not be liable for more, or further than their own respective Proportions in the said Fund, nor shall at all be concerned one for another.

XI. That within one Month next after the Election of the said Trustees and Directors, the said Subscribers shall pay in unto them the said Trustees, or unto whomsoever they shall Direct or Appoint, ten pounds *per Cent.* of all their said Respective Subscriptions, and 15 l. *per Cent.* more, within Four Months next after the said Election, except the said Second Payment be longer deferr'd by the General Assembly; and the other remaining Three Quarter Parts shall be paid afterwards at Three or more Payments successively, and all within Twelve Months after the said Election, at such set times, and in such manner as the said Directors for the time being, shall appoint and call in the same.

XII. That if any of the said Subscribers shall fail, or make default of Payment of His, Her, or Their first Payment of 10 l. *per Cent.* within the said time of one Month, as is hereby limited; it shall be lawful for any other Person or Persons approved by the said Directors, immediately after the Expiration of the said one Month, to pay in the same, and to receive and take the Benefit of His, Her, or their Subscriptions; but if within the time limited there be not above 50000 l. Subscribed, then the said Subscriptions shall be void, or not obliging to any Subscriber.

XIII. That there shall be always made two Dividends of the Profits of the said Bank every Year; but that nothing except the clear Profits, or Revenue of this Fund shall ever be Divided; so that the whole Original Joynt Stock as it shall be now Subscribed, and hereafter Invested, or Secured, shall always remain Full and Intire, or be by the same Proprietors augmented and improved to such further and greater Fund, as shall from time to time by them be thought fittest, for the Joynt-Interest of the said Bank, Accommodation of Trade, and Security to all Persons who shall give Credit to the same.

XIV. That if all the Monies paid in by the Subscribers, shall (*Communibus annis*) produce above 10 l. *per Cent. per ann.* clear Profit; the above Named *Richard Holt,*

for his Pains in the Composure of these Proposals, and for his Advice, Time, and Charges, in and about the same, shall have and enjoy, to him and his Heirs, &c. one Shilling out of every 20 Shillings of clear Profits, which shall be Gained by, or Arise from this Fund, or any part thereof, to any Person or Persons whatsoever; and also the benefit of the Transfers, so long as the said Fund, or Bank shall continue to produce the Profit as aforesaid; and that all Dividends and Ballances of Accounts, as they shall stand Stated in the Bank Books, shall always be Conclusive, and without any further Account to be given, either in Law or Equity.

XV. That whatsoever herein shall be found short Expressed or Imperfect, may from time to time be added unto, Explained or Amended, pursuant to the true Interest and Meaning thereof, by a General Assembly of the Trustees, Directors, and Owners of the said Fund, or as by Learned Council shall be reasonably advised, or devised; and that humble Application may in due time be made to the High Court of Parliament, to encourage and establish this Undertaking, in such manner as in Their Great Wisdom, shall thereupon be thought most fit.

XVI. That to prevent Delays, and to incourage the first Beginners to Subscribe; the first Subscriber shall have 5 *per Cent.* the second 4 and half *per Cent.* the third 4 *per Cent.* allow'd and repaid him; and so on to the 10th Subscriber, who also shall have half *per Cent.* repaid him, and all out of the first Payment only, but no further.

*"It may seem a Paradox, that this Bank should lend Money Cheaper, and yet Gain above 20 per Cent. per Ann. But whosoever enquires into all the Three Banks lately set up in London, will find, they lend Money at 3, 4, and 5 per Cent. and yet every Subscriber in any of the said Three Banks, has already Gained; or may have, when he pleases, above 50 per Cent. clear Profit for all his Money Paid in.*

Besides the account of the Petition presented to the House of Commons and printed in the proceedings of that session, nothing more seems to be known about this project. It was referred to a Committee of the House, which apparently never made any report. The idea is evidently taken from that of the Bank of Scotland, and it is quite likely that some of the promoters of the Bank of Scotland were interested in this scheme as well.

The Richard Holt referred to in this Proposal is probably the same Holt that was interested in the Patent for Tin Farthings in England some years previously.

Letter dated *Wicklow, May 8, 1718*, says the City of Dublin is much alarmed by a Report that the Gold Coins were to be reduced in proportion to Silver in order to keep the Silver in the Kingdom, and that a Proclamation would be issued to enforce the Weighing of Gold Coin as formerly.

Quotes Petty and Temple against raising money, and adopts Locke's arguments about equal quantities of silver — always equal quantities of silver. Assumes silver as the measure of value. Says "Credit is the expectation of money within some limited time." Dislikes to see the silver go, because the scarcity will give rise to the necessity of half-pence, and speaks of the prodigious currency of light and deceitful money. Well-written tract.

This Tract which was written in the latter part of 1720, makes mention at the end of a project for a Bank. The author intimates that he is going to attack the project of which he says he understands one half the money will be real and the other half only Gascounade. The Tract made a great sensation, and brought about a vigorous and persistent prosecution of Waters, the printer. It is, I believe, the earliest Tract of Swift's relating to the Economic affairs of Ireland and is reprinted in all collections of his Works. Swift frequently refers to this Tract in his correspondence. It was answered by the following and also by "A Defence of English Commodities, being an Answer to the Proposal for the universal use of Irish Manufactures: with an Elegy upon the Death of Mr. De Mar, the famous rich man, who died at Dublin, July 6, 1720," published in 8vo, Dublin, 1720. This Tract is also attributed to Swift by Lowndes, but without any good reason, although the Elegy may be by him.

Some doubt has been thrown on the authorship of the Essay on English Bubbles. It was accepted by Faulkner and is now generally ascribed to Swift. I have never seen the separate original Imprint nor the original Dublin Edition of "The Swearer's Bank." I think it is quite possible, that the Essay on Bubbles may have never been published separately but only as an introduction to "The Swearer's Bank."

The commonest Editions of this Tract are the 3rd, printed by Thomas Hume, Dublin, 1721, and Curll's Reprint, London, 1721, in 23 pp. Svo.

I discovered the original of this Tract in a Letter printed in Mist's "Weekly Journal," September 30, 1721. The Letter is introduced by a few remarks to the effect, that it was written "by an eminent Dublin Trader in the Woolen Affair, to a rich Gentleman of distinction settled in London," and is signed "S. T.," and dated "Dublin, March 15, 1720-21."

The Time of this reprint is doubtful, although printed as 1721. Sarah Harding was certainly not printing regularly until after the death of John Harding in the early part of 1725, and the General appearance of this Broadside would indicate that it was printed 1726-7. The initials signed to the Letter have been changed from "S. T." to "J. S.," with the evident object of ascribing it to Jonathan Swift; and the date has been changed from the original date to the date of printing in Mist's Journal.

The Tract was discovered by Sir Walter Scott, evidently reprinted in 12mo. It appears in the appendix to Vol. I of Scott's Works, and was also reprinted in Temple Scott's edition of Swift, and was without

date or publisher. Scott probably ascribed it to Swift on account of this signature, which he considered to be a good evidence. But the reasons which he gives turn out to be entirely mistaken ones, inasmuch as the Tract was really written in 1721, and, indeed, his reasoning on the subject was very far-fetched, as the Letter has extremely little resemblance to Swift's Letter to the Earl of Peterborough.

It is not impossible, however, that this Tract was really written by Swift, as it contains many of the ideas which Swift was continually bringing before the Public from 1720 on. In a Tract published in 1740, there is a reference to it as having been printed about 3 years before, which was probably the date of the appearance of the 12mo reprint, which Sir Walter Scott saw.

This Tract of Maxwell's, besides containing the Case for the Bank, is devoted to a discussion of the Economic effects of reducing the rate of interest, and devotes some attention to the industrial state of Ireland, and the land question. Maxwell contends that the price of commodities is entirely independent of rent, and governed by the market only, and that the price of land does not govern the price of its unmanufactured products, but that the reverse is the fact.

The attempt to organize this Bank failed, probably owing to the discredit into which—at the moment—all Corporations had fallen. There is not much information about it, except what is contained in the following Pamphlets and the proceedings of the Irish Parliament. A Summary of the arguments for and against the Bank, as published by Maxwell and Rowley, is given by Monek Mason. Lawson, in his History of Banking, gives an account of the affair, with very full extracts from proceedings in Parliament.

Rowley strives to raise all the prejudices possible, but some of his objections are well taken. The strongest objection was that the money would probably all be loaned on real security.

A great jealousy of monied corporations still existed, as is enviously shown by his assertion, that "in England merchants seldom borrowed from the Bank, but usually from the Goldsmiths."

This is a very able, well-written tract, and possibly written by a private Banker or money-lender in Dublin. Refutes Rowley's arguments (being an answer to Rowley's Answer to Maxwell). Insinuates that the movement was brought on by the Treasury Dept., which, owing to lack of specie, was obliged to receive private bills in payment of customs.

Therefore thinks the proposal to issue paper money will have this effect. Chief reasons for objecting seemed to be the unsettled condition and danger of invasion. Also danger of a large and powerful corporation.

On the 29th of September the Commons did Resolve in favour of the Bank. Says the fund to secure the Public must be sufficient, valuable, permanent and accessible. The Bonds proposed to be given only bind the Party during his Life, and the security is, therefore, not permanent.

Fears either the temptation will prove too great for servants of the Bank, in spite of the Regulations, or the English Government will wish to borrow the Cash, in which case the chief men in the Bank—being also in Posts under the Government—will not be able to refuse. If private Bankers fail, only a few are hurt, but the fate of the whole Kingdom will lie in the hands of this Bank.

Says the coins are made out of Irish copper, sent to Bristol and not refined. A smelting company are the real undertakers, and they have ingrossed all the mines and ores in Ireland to be sent to England for smelting and refining.

This is very early, as a note at end says a large quantity has now been landed and part already got into circulation, some accepting and some declining, part lighter than the rest and badly made, so as to invite counterfeiting. In a Tract printed 1728 Maculla claims that he was the first person to discover the ill consequences that Wood's Coins might have in Ireland.

## NOTE AS TO WILLIAM WOOD.

William Wood, according to Philip Nelson's "Coinage of Ireland," was born in 1671 and resided at the Deanery, Wolverhampton, from 1692 to 1713, and died in London 1730.

Besides this Copper Coinage for Ireland, he also executed a Copper Coinage for the American Colonies, which experienced a somewhat similar fate to the Irish Coinage.

Wood was extensively engaged in Mining and Smelting operations, and it is highly probable that these Coinage schemes were entered into as an adjunct to that business. From a notice published in *Mist's Weekly Journal* of June 18, 1720, it seems that Wood had secured a lease on the property of the Governor and Societies of the Mines Royal and Mineral and Battery Works in certain counties—in all, in fact, except Devonshire and Cornwall. No doubt among these properties were the Smelting Works of Neath Abbey, belonging to the Mines Royal Company, and this, therefore, explains the statement made by Grant Francis in his "Smelting of Copper in the Swansea District," that "the copper used by Wood for the Coinage was made in the Neath Abbey Works."

Copper had been discovered in Cornwall about 30 years before to be in marketable quantities; but in the early stage of the business the ore was considered of no value, and was bought in Cornwall as low as £2 10s. per ton for 7 to 10 per cent. ore. The business was largely in the hands of the Quakers of Bristol, and before 1720 there were certainly Works near Bristol.

The large profits made out of this business were probably the inducement which brought Wood into it, as in a Broadside, entitled "The Present State of Mr. Wood's Partnership," published about 1720, Wood proposes "to give better prices for ores than hitherto and also sell the metal cheaper," and states that "they have already bought ores in Cornwall."

The latest and best information regarding Wood's coins and the manufacture of them, is contained in Philip Nelson's "Coinage of Ireland," 1905, but the matter is referred to at length in almost all the late editions of Swift's Works, and the affair is dealt with in great detail both in Coxe's "Memoirs of Sir Robert Walpole" and Monck Mason's "The History and Antiquities of St. Patrick."

He would have to sell the coin at a discount of 5 per cent. to allow—as he says—for exchange, leaving a profit of only 1½d. per lb. over and above the costs as given above,—which, however, he admits also carried a profit in the manufacture.

This Position is also repeated and insisted on in Walpole's Correspondence, as given by Coxe, and, indeed, it seems highly probable, that considering there was also an import duty in Ireland on the coin, that Wood's profit—after paying £1,000 a year to the Crown and the Comptroller, and reimbursing himself for the original outlay of £10,000—would have been very small, if the terms of the Patent had been strictly complied with. Under the terms of the Patent 60 halfpence were to be coined to the pound, while in the English coinage at the time 1 lb. of copper was struck into only 46 halfpence. But this difference was defended on the ground of the general lower value of Irish currency, and the increased expenses of putting the coins into circulation.

The arguments in favour of Wood's coinage may be reduced to the following propositions:—Ireland wants copper coin; the Quantity would be no inconvenience; they are better than any hitherto—or probably ever will be; the King will lose nothing, the Public will gain, and the Kingdom will have £100,000 additional current cash.

"Ireland's Case" is reprinted in Temple Scott's Edition of Swift. Mr. Scott thinks that the compilation was gotten out in Wood's interest, but I cannot agree to this, as—in my view—the evident intention of the Pamphlet is to discredit Wood.

The ducats brought 3 guilders 3 stivers, and occasionally 3 guilders 5 stivers, depending on the East Indian demand. Common Exchange rate is 24½d. Irish for a guilder. So he got 6s. 5d. for each ducat.—Cobs brought 50-52 stivers, and after remittance 5s. 1¼d. and 5s. 3½d.

Several hundred cobs lately brought from Spain were bought for exportation to England at 5s. 10d. per oz., which he says is the real value of sterling in Ireland. So the pieces cost 5s. and ½d. each and weighed slightly over 17 dwts. each; therefore, why should these cobs pass at 4s. 9d., when by taking them to Skinners Row they will bring 5s. Even merchants sometimes pay more than 5s. 10d. per oz. for sterling silver.

Exchange runs 2-4 per cent., sometimes 5-6 per cent. above the real difference in the currency of the money in England and Ireland.

Advocates raising the silver coin to its bullion value, namely 5s. 10d. per oz.; to lower the gold is to begin at the wrong end.

Thinks the practice of weighing current coins a loss and obstacle to trade, but there is no reason to weigh French, Spanish and Portuguese, and not those of England.

The larger the piece of gold the more it is over-valued, owing apparently to not weighing to half grains.



Asserts that English silver is so scarce, that the linen manufacturers have to give a premium of 3d. to 6d. per pound for it.

The regulations should be 5s. 10d. per oz. for silver, and 86s. 8d. per oz. for gold, or 4s. 4d. per dwt., no matter where it comes from.

As bullion is a commodity we purchase with our goods, we ought to fix such a price on it so to be able to export it without loss, in case any redundancy falls into our hands; too much money being an insupportable evil.

I have given large extracts from this because many details are given of actual transactions, which show better the actual value of the coins current at the time than any of the Cambists or Negotiators of the day.

As the tract is nothing but an amplification of no. 139, it is certainly by the same author, probably Sir John Browne.

Denies the assertions about the quadruple moidore, and says very few were under value. The matter was misrepresented, and being lowered to £3 11s. were all exported, and he got 2s. 6d. premium on a considerable number he exported. Exportation a proof that they were now under-valued. Intimates that Exchange has been against Ireland frequently for past 20 years, leading to export of guineas and generally a run on the Banks.

Mitchell owed £70,000 and gave to Trustees £147,000 in Securities. Mitchell was a nephew of Hugh Henry, who gave him £300 a year to set up with. Also had the best remittances in Ireland at 1 per cent. profit, which would give him £6,000 per annum. Therefore nothing strange that he should collect £68,000 in 25 years.

According to this writer, Clements, Malone and Gore must have been possessed of large estates (he estimates them at £593,500) but apparently in land, offices, &c.

Dillon alone imported 300,000 guineas in 2 years, by which he lost £5,000, and they were exported as fast as imported. Says he kept bad

accounts, neglected his affairs, and sent £40,000 to his brother in London and £5,000 to another in Holland. (Apparently first failure).

Willcocks' Bank of great use to the public for 40 years, and he lost £70,000 by a servant, with whom several men in trade had suspicious connections.

Lenox held forth in a public-house the night before his failure, and expressed great surprise at Willcocks, and canted an hour in favour of himself and a Banker's duty. Pretended he had lent £24,000 to a certain merchant, and that he was not possessed of a true worldly spirit of keeping, but his friends did not believe this.

What induced Malone and others to go into banking was the success of Lord Besborough and Mr. Gardiner on a former occasion. But then there was plenty of foreign coin in the kingdom, which could not be exported, until Exchange got to 12 per cent., which was rarely. Traders did not keep weighable money, and the Banks were full of money, and Besborough and Gardiner in particular had plenty, till they thought proper to pay off the public.

 The "Gentleman's Magazine" of 1783 (p. 706), contains a short article describing the Arms and Seal of the Bank as the device of Georges Edmond Howard, who—the writer says—first proposed the Bank to the Government, and afterwards directed the plan on which it was founded.  
 A letter in the same Magazine of November 14, 1793, admits that it is questionable whether the advice was designed by Howard or not, but denies that he was the parent of the Bank. On the contrary, it was moulded after the Bank of England, and the regulations and establishment of it were due to David La Touche and the Right Honourable John Foster, with the Assistance of a Mr. Hoffman, an ingenious merchant of Dublin, and Mr. Howard had even nothing to do with drawing up the Charter.  
 The Bank was chartered by the Act of 21-22 George III, Chapter XVI, and started business on the 1st of June, 1783, in St. Mary's Abbey.
