

ARMED FORCES

One of the most important steps to take to ensure that you will receive an absentee ballot is to provide election officials at home with your correct, current mailing address.

Many election officials across the country have indicated to the Department of Defense that Armed Forces voters should notify them immediately when military addresses (or home mailing addresses) are changed.

This is particularly important if a Service voter moves to a different station, unit, or installation after voting by absentee process in a primary election. To obtain a general election ballot from the new location, the new address must be indicated on the Federal Post Card Application (FPCA) requesting the ballot (Item 7).

When an address is changed, indicate to your election official in the "Remarks" section (Item (6)) of the FPCA, "Notification of Change of Address."

CHECKLIST

The checklist below has been developed to assist Armed Forces voters to meet their home States' absentee registration and voting requirements by mailing a Federal Post Card Application

(FPCA—Standard Form 76) to appropriate election officials.

STEP I. Contact your voting officer or counselor, obtain an FPCA, and complete it by following the instructions in the *Voting Assistance Guide* (DoD GEN-6E). Be sure to type or print the information required so that it may be read by election officials.

STEP II. Comply with registration requirements if specified by State law. Refer to the State pages in the guide for absentee registration procedures prescribed by your State.

STEP III. Mail the completed FPCA as follows:

- To the appropriate election official indicated on the pertinent State page of the guide.
- Within the time period recommended by a State, but always far enough in advance of the election so that election officials can mail the ballot to you in time for it to be voted and returned to reach officials before the absentee voting deadline.

STEP IV. Vote the ballot in accordance with instructions which are generally included in or on the envelope with the ballot.

STEP V. Return the voted ballot to State election officials in time to be received before the absentee voting deadline. Refer to the appropriate State pages

in the guide for each State's ballot deadline.

'TUESDAY . . . '

The traditional "Tuesday next after the first Monday in November"—set by Federal law as general election day in even-numbered years—falls on November 5, 1974.

On the Federal scene, candidates will be chosen to fill 34 seats in the Senate and 435 seats in the House of Representatives. In addition, the District of Columbia, the Territory of Guam, and the Territory of the Virgin Islands will each elect one Delegate to the House of Representatives. These officials, along with the members of the Senate whose terms do not expire this year, will constitute the 94th Congress which convenes January 3, 1975.

At the State and Territorial levels, 37 Governors will be chosen, along with other officials in the executive, judicial, and legislative branches of government. Numerous county and local officials will also be elected.

Absentee registration and voting procedures that should be followed to obtain a general election ballot are listed for each State, Territory, and the District of Columbia on pages 4 and 5. For additional details, Service voting officers

or counselors should be contacted.

Particular attention should be paid to the absentee ballot deadlines listed for each jurisdiction, in order that sufficient time may be allowed for an interested voter to request, obtain, vote, and return his or her absentee ballot.

PRIMARIES

More than a third of those States that have scheduled primary elections in 1974, along with the District of Columbia, will conduct them in September or October.

Nevada and North Dakota will begin the September-October primaries by holding their elections September 3. Hawaii, the last State to hold a primary this year, will conduct its election October 5.

The remaining jurisdictions will hold September primaries as follows (date is shown in parentheses): Delaware (7); Arizona (10); Colorado (10); District of Columbia (10); Florida (10); Maryland (10); Massachusetts (10); Minnesota (10); New Hampshire (10); New York (10); Rhode Island (10); Utah (10); Vermont (10); Wisconsin (10); and Washington (17).


ARMED FORCES VOTERS DAY

On November 5, approximately 140 million U.S. citizens will be eligible to cast their ballots in the general election to choose a variety of officials at Federal, State, and local levels. Among this electorate will be more than two million members of the Armed Forces -- the majority of whom will be absent from their home voting districts.

While active duty Service members generally have little chance to join their fellow citizens in person at the polls, they do have the right and opportunity to register and vote by the absentee process if and as they wish. A major purpose of the Federal Voting Assistance Program -- implemented by the Department of Defense -- is to ensure that this right and opportunity will be guaranteed to all eligible voters in uniform.

September 24 has been designated Armed Forces Voters Day. This is a time for eligible Service voters and their family members to focus attention on the general election and on prescribed procedures that will enable them to obtain absentee ballots if they wish to do so from a State, Territory, or the District of Columbia. Military Service voting officers and counselors are prepared to assist interested, eligible voters to exercise voluntarily this most important function of citizenship.

I urge each member of the Armed Forces who wishes to vote to contact his or her voting officer or counselor to determine procedures to obtain an absentee ballot. By allowing sufficient time to apply for a ballot, vote it, and return it to election officials in advance of election deadlines, the individual will be assured that his or her vote will count in the general election.
