## INFORMATION FOR VOTERS

- (1) Requirements for a citizen to qualify as a voter:

Citizen of the United States.  
Twenty-one or more years of age.  
Resided in the state at least six months.  
Able to read and write English.  
Registered as an elector with the County Clerk or official registrar at least 30 days before election.

- (2) Voting by absentee ballot.

You may apply for an absentee ballot if:

You are a registered voter. ("Service voters" are automatically registered by following the service voting procedure.)

You have reason to believe you will be absent from your county on election day.

You live more than 15 miles from your polling place.

You are unable by reason of physical disability to go to the polls.

You are a "service voter". You are a "service voter" if you are:

In the Armed Forces or Merchant Marine of the United States.

A civilian employee of the United States, serving outside the country.

A member of a religious group or welfare agency assisting members of the Armed Forces.

A spouse and dependents of a "service voter" who have been Oregon residents and are temporarily living outside the county in which the last home residence in this state of the "service voter" is located.

How a voter may obtain and use an absentee ballot.

You may apply for an absentee ballot if:

You will be temporarily absent from your county on election day.

You live more than 15 miles from your polling place.

You are physically unable to go to the polls.

Application for the ballot may be filed with, or mailed to the County Clerk at any time within 60 days before the primary election, March 16—May 14 (Service voters, after January 1 of election year). Application includes:

Your signature.

Address or precinct number.

Statement of reason for application.

Applications filed less than five days before election, May 10-14, require additional statement that:

Voter is physically unable to get to the polls, or

Voter was unexpectedly called out of the county in the five-day period.

Emergencies on Election Day:

Physical disability must be certified by licensed practitioner of healing arts or authorized Christian Science practitioner. Involuntary public services such as firefighting to be certified by person in charge.

Ballot, when voted by elector, must be returned to County Clerk not later than 8 p.m. on election day.

- (3) A voter may obtain and use a certificate of registration if he:

Changes residence within the state 30 days preceding an election. (Certificate is presented to election board in precinct to which he has moved.)

Is absent from his county on election day. (Certificate may be presented to the election board in any county in the state. Elector may vote only for state and district offices.)

- (4) If you have moved from the precinct in which you were registered to another precinct within the same county, you may vote in your old precinct if you apply for reregistration at the time of voting.

- (5) A voter is required to reregister if he:

Changes address by moving within his precinct or moving to another precinct or county.

Changes party registration.

Changes name.

**Measure No. 1**

**Authorizing Bonds for Education Building Program**

Proposed by the Fifty-second Legislative Special Assembly by House Joint Resolution No. 8, filed in the office of the Secretary of State November 22, 1963, and referred to the people as provided by section 1, Article XVII of the Constitution.

**Explanation**

**By Committee Designated Pursuant to ORS 254.210**

The Fifty-second Legislative Assembly (Special Session) has submitted to the people for approval or rejection an amendment creating a new article to the Constitution of the State of Oregon. Article XI-G would amend the Constitution of the State of Oregon to authorize:

**BONDED INDEBTEDNESS**

The pledging of the State's credit and incurring bonded indebtedness until June 30, 1969, in an amount which shall not exceed at one time \$30,000,000 of direct general obligation bonds of the State in such form, maturity and interest rate as the Legislative Assembly provides. At any time the bonds so issued may be refinanced with bonds of a like obligation.

**USE OF BOND PROCEEDS**

(a) The expenditure of funds in the amount of \$25 million with which to construct, improve, repair, equip and furnish those buildings and structures, and to purchase or improve sites therefor, except self-liquidating and self-supporting buildings or projects constructed pursuant to section 2, Article XI-F(1) of the Constitution of the State of Oregon, that are designated by the Legislative Assembly for higher education institutions and activities; and

(b) The expenditure of funds in the amount of \$5 million with which to construct, improve, repair, equip and furnish those buildings and structures, and to purchase or improve sites therefor, that are designated by the Legislative Assembly for community colleges and education centers or that are community colleges and education centers authorized by law to receive state aid.

**PAYMENT OF BONDS**

A property tax levied annually on all taxable property within the State of Oregon would provide the funds for the payment of both the interest and principal due on the bonds. The Legislative Assembly may use other revenues to offset in full, or in part, the required tax levy.

**Measure No. 1 Authorizing Bonds for Education Building Program****Argument in Favor**

Submitted by Legislative committee provided by Subsection (3) of  
 ORS 255.421.

A "Yes" vote on Ballot Measure 1 will provide constitutional authorization, subject also to legislative limitation, for education building bonds:

1. Ballot Measure 1 does not propose an increase in taxes or any change in Oregon's tax structure.
2. It will provide a means, beginning in 1964, for meeting the crucial need for classroom, library, laboratory and similar buildings for Oregon's many young men and women who will attend the state's colleges, universities and community colleges.
3. Oregon's share in federal building funds for state-supported higher education can be obtained if Ballot Measure 1 passes.
4. Ballot Measure 1 will establish a sound, economical form of financing for higher education construction.
5. Passage of Ballot Measure 1 will avoid paying higher construction costs which can be anticipated if buildings are delayed.
6. State-wide citizen groups known as "Colleges for Oregon's Future Committees" with membership of approximately 1,000 respected lay leaders, including former Governors Holmes, Smith and Sprague, actively support passage of Ballot Measure 1.

Out of the total of \$30 million bond borrowing authorization under Ballot Measure 1, \$12.5 million—about one-half of the critically needed buildings authorized by the 1963 Legislative Assembly—will be expended for college and university construction, and \$1.4 million for community college buildings this biennium.

The balance of the buildings will be programmed for Higher Education and community colleges over a six-year period, as demanded to meet expanding needs, both with Legislative approval.

Passage of Ballot Measure 1 is considered to be of the utmost importance to the entire citizenry of this state.

CONSTITUTIONAL AMENDMENT

Be It Resolved by the Legislative Assembly of the State of Oregon:

The Constitution of the State of Oregon is amended by creating a new article to be known as Article XI-G and to read:

ARTICLE XI-G

**Section 1.** (1) Notwithstanding the limitations contained in section 7, Article XI of this Constitution, and in addition to other exceptions from the limitations of such section, subject to subsection (2) of this section, the credit of the state may be loaned and indebtedness incurred in an amount not to exceed at any one time:

(a) \$25 million to provide funds with which to construct, improve, repair, equip and furnish those buildings and structures, and to purchase or improve sites therefor, except self-liquidating and self-supporting buildings or projects constructed pursuant to section 2, Article XI-F(1) of this Constitution, that are designated by the Legislative Assembly for higher education institutions and activities; and

(b) \$5 million to provide funds with which to construct, improve, repair, equip and furnish those buildings and structures, and to purchase or improve sites therefor, that are designated by the Legislative Assembly for community colleges and education centers or that are community colleges and education centers authorized by law to receive state aid.

(2) Except for refunding bonds issued to provide funds with which to redeem bonds issued pursuant to this Article, no additional indebtedness shall be incurred pursuant to this Article after June 30, 1969.

**Section 2.** Bonds issued pursuant to this Article shall be the direct general obligations of the state and shall be in such form, run for such periods of time, and bear such rates of interest as the Legislative Assembly provides. Such bonds may be refunded with bonds of like obligation.

**Section 3.** Ad valorem taxes shall be levied annually upon the taxable property within the State of Oregon in sufficient amount to provide for the prompt payment of bonds issued pursuant to this Article and the interest thereon. The Legislative Assembly may provide other revenues to supplement or replace, in whole or in part, such tax levies.

**AUTHORIZING BONDS FOR EDUCATION BUILDING PROJECTS**  
**1** **GRAM**—Purpose: Constitutional amendment authorizing general obligation bonds for building projects. Up to \$25 million for higher education and \$5 million for community colleges and education centers.

**ESTIMATE OF FINANCIAL EFFECTS:** Article XI-G of the Constitution would authorize the issuance and sale of general obligation bonds with a limitation on the amount outstanding at any one time of \$30,000,000, of which \$25,000,000 will be for higher education building projects and \$5,000,000 for community colleges and education centers. It is estimated that the average annual cost over a 30-year period to retire the bonds and to pay interest thereon would approximate \$1,650,000.

## AN OPEN LETTER TO THE VOTERS OF OREGON FROM ALF CORBETT

In nearly 14 years of serving the public, I have arrived at strong convictions about the manner in which government should be conducted, and want to use my experience to put these convictions into practice.

1. The public is entitled to know the facts, the unpleasant along with the palatable. False hopes lead to chaos in government, to justified revolt by taxpayers.

2. The best bargain in government is action close to home. I have backed home rule amendments, and more flexibility in metropolitan planning.

3. Foresight, not hindsight, is needed in government. Water resources place a ceiling over growth. I was a co-sponsor of the Oregon Water Resources Board, and ground water laws which are the envy of other states. I support competition, not monopoly, on oil leases.

4. Oregon has a higher percentage of older people than the nation as a whole. I have supported the Council on Aging, was chief sponsor of the laws barring discrimination in employment based on age, and co-sponsor of the homestead property tax exemption for older people.

5. Correctional programs should start at school age. We need an "early warning system" to identify potential delinquents and to initiate counseling, vocational training to give incentive when needed, and youth camps to provide opportunity. I was chief sponsor of the Metropolitan Youth Commission legislation, and co-sponsored our Youth Work Camp law.

6. Treatment of mental problems should be at community level. I have been a leader in financing out-patient clinics, and in expanding community mental health clinics.

7. The retarded and handicapped need special concern. I sponsored workshops and training programs, and support special programs in schools.

8. Fiscal responsibility demands high standards, and insistence on full value for tax dollars. I initiated improved administration of welfare, higher education classroom use, charges by Secretary of State.

9. Oregon must build upon the assets we have: Agriculture, timber, recreation and tourism. We must expand jobs through more complete utilization of wood products, through more local processing and manufacturing, and by planning ahead for the tourist business so that Oregon's livability will not be destroyed even as we acquire business.

10. To bid successfully for science-based industry, we must have a Graduate Research Center in the Portland metropolitan area. Nearly \$2 million in veterans' funds were taken recently for Boardman, with a lease that failed to guarantee permanent jobs. A Graduate Research Center would attract hundreds more jobs of the kind we want.

11. Education is at the heart of democracy, and it is also the force which brings improvement in living, in job opportunities and higher income. I have worked 20 years toward improving our schools, technical and community colleges, and institutions of higher education.

12. Unfortunate citizens in need deserve a hand up, not a hand-out, and I have worked to improve our welfare laws, on the one hand to provide counseling and assistance in getting skills and jobs, and on the other to eliminate chiselers.

13. Consumer rights are often pushed aside by special-interest groups. Pure food, clean air and unpolluted water are vital to us all.

14. Respect for the individual, and equality of opportunity are basic to our democratic way of life as they are to our religious beliefs. I have co-sponsored civil rights and fair employment legislation.

15. Government belongs to each citizen. He is entitled to impartial administration of election laws and a sympathetic ear for his problems.

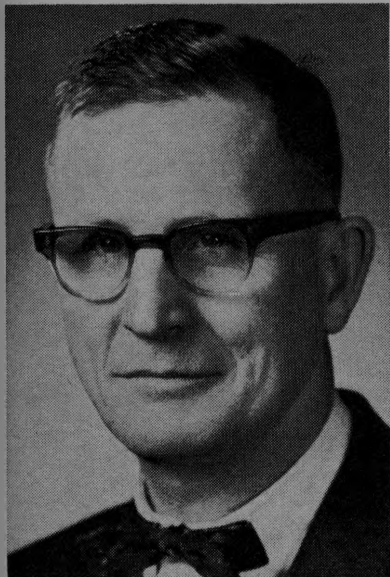

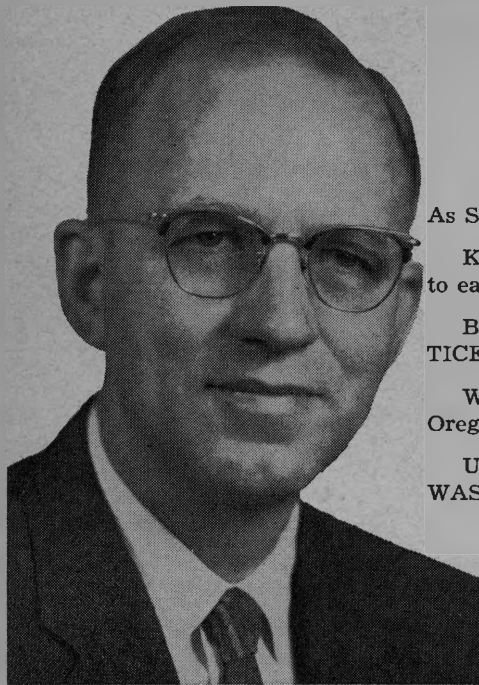

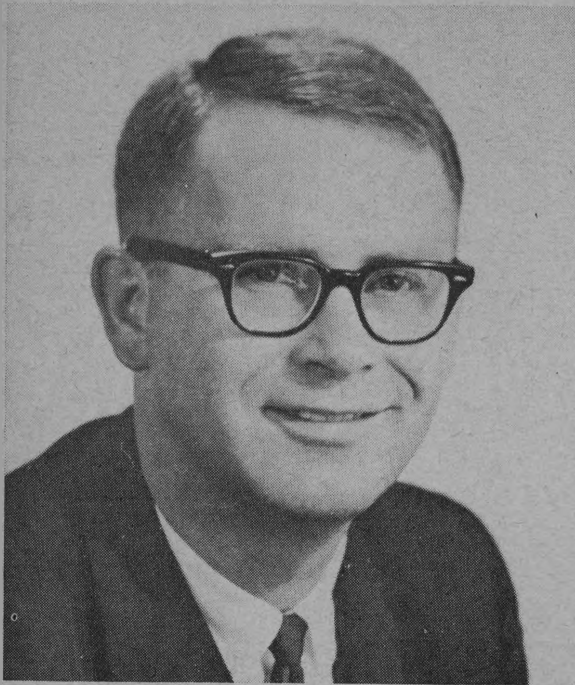

**Measure No. 2 Home Rule Charter for Marion County****Explanation****By Committee designated pursuant to ORS 254.210**

The purpose of the proposed county home rule charter, as stated in the Preamble, is to "avail ourselves of self-determination in county affairs under the Constitution and laws of the State." It would give the County power to handle its problems at the county level rather than seeking authority from the State Legislature.

The present 3-man full-time board will be replaced by a 7-man board, consisting of a full-time chairman elected at large and 6 part-time members elected from districts defined in the proposed charter. The Chairman's salary is \$10,000 per year; other board members receive \$25 per meeting but not to exceed \$100 per month. The Chairman is elected from the County at large and is directed to be accessible to residents to hear all requests, comments and suggestions. He is a nonvoting member of all county boards and commissions.

The board shall meet at least twice each month. No legal action can be taken unless at a public meeting in the Courthouse. Legislative power is exercisable only by the board. With the consent of voters in the area, the board can establish and govern new local service districts and contract with existing districts. It may make public improvements and assess their costs to benefited properties.

Six administrative departments, each headed by a director, are established. Three department heads are elected: Director of Finance, Director of Public Records, Director of Law Enforcement, to be known as Sheriff. Three department heads are to be appointed by the board: Director of General Services, Director of Public Works, Director of Health and Sanitation.

Functions of the six administrative departments are as follows:

**FINANCE**—functions of present treasurer, assessor, sheriff's tax collection and duties, and clerk's payment of county obligations.

**PUBLIC RECORDS**—functions of present recorder and remainder of clerk's duties.

**LAW ENFORCEMENT**—functions of present constables and sheriff, except tax collection.

**GENERAL SERVICES**—accounting, budgeting, purchasing, personnel, data processing, and pooling of personnel and equipment.

**PUBLIC WORKS**—functions of present surveyor, engineer and building inspector.

**HEALTH AND SANITATION**—functions of present health officer, sanitarian, medical investigator, and board of health.

The main responsibility for the administration of the affairs of the County rests with the Board. The Chairman shall exercise whatever additional functions the Board prescribes for him. He is an elected head of county government—not a Board-appointed business manager.

All elective county offices are to be filled by nomination and election by the partisan political procedure as at present. All directors and board members have 4-year terms. Terms of board members are staggered. Existing civil service system as to all other employes would continue.

All the State provisions for initiative, referendum and recall are maintained.

The existing court system is not altered by this charter.

If adopted, the charter will come into full effect January 4, 1965.

**Measure No. 2 Home Rule Charter for Marion County****Argument in Favor****Submitted by Marion County Charter Study Committee**

The proposed MARION COUNTY HOME RULE CHARTER is a step toward modernizing Marion County government.

It gives the people the power to manage their county affairs under the Constitution and the laws of Oregon.

It streamlines Marion County government to make it more economical and efficient.

In operation, the Charter gives significant improvement in these important areas:

1. It will no longer be necessary to ask the State Legislature to pass special legislation affecting Marion County because the people through the initiative and the Board of Commissioners by ordinance may legislate in matters of county concern, in accordance with the provisions of the Constitution of the State of Oregon.

2. The proposed seven-member BOARD OF COMMISSIONERS, elected by the people on a partisan basis and responsible directly to the people, conducts the county's legislative affairs and by their direction its administrative affairs. It should be noted that the RIGHT OF THE PEOPLE TO ELECT THE MAJORITY OF THEIR OFFICIALS in the county government has been maintained. The Charter provides for the election of SEVEN COMMISSIONERS, responsible directly to the people, and THREE DEPARTMENT HEADS (finance, public records and law enforcement). Appointment of the remainder of the administrative heads by the Board of Commissioners will PROVIDE GREATER EFFICIENCY by allowing professional selection of technically trained county employees. Election of the commissioners by districts brings the courthouse closer to the people. Twice-monthly meetings, as stipulated in the Charter, keep commissioners in close touch with county affairs and citizens' needs.

3. Consolidation of offices and closer management control should result in REDUCTION OF ADMINISTRATIVE EXPENSE in overall operation of the County.

4. This Charter provides for PROMPT AND DECISIVE ACTION AND CLOSER COORDINATION BETWEEN THE Board of Commissioners and department heads in meeting the increasingly complex problems and costs of the governmental operation of Marion County, but the people, through the initiative and referendum retain the POWER TO AMEND the Charter and are given final control over all phases of county government. The present arrangement tends to diffuse this power among several elective offices.

5. The Board of Commissioners may establish and govern local service districts, for the purpose of providing one or more services of special benefit to persons and property in the area, BUT ONLY WITH THE CONSENT OF THE PEOPLE CONCERNED. Existing special service districts are not affected by this charter.

SAFEGUARDS which citizens have enjoyed in operation of Marion County are maintained. Restrictions on taxation, budget procedures and recall are carried over into the new Charter.

THE BEST FEATURES OF THE PRESENT FORM OF GOVERNMENT are retained by this new Charter.

**Measure No. 2 Home Rule Charter for Marion County**

**Argument in Opposition**

**Submitted by Charles W. Creighton, Jr.**

I oppose the "Home Rule Charter" for these reasons:

FIRST. Marion County is now governed by its elected officials with no interference from the State. We already have HOME RULE.

SECOND. The Charter establishes a Board of one full time Director elected from the County at large and six part time, unsalaried members elected from districts of the County; it must meet twice a month. IN THEORY, it is a Board of seven; IN PRACTICE, it is a Board of one. This is no improvement over a Board of three full time County Commissioners. OAKS OF BUREAUCRACY FROM LITTLE ACORNS GROW.

THIRD. The County Officials are now elected by the people and are directly responsible to them just as, in private business the employe is directly responsible to his boss. The Charter interposes between the citizens and the public officials a part time board and makes the official responsible to the board rather than to the voter. No one would urge this as an improvement in private business; it isn't an improvement in government either.

FOURTH. The Charter deprives the citizens of the right to vote for the Director of General Services, The County Assessor, The County Surveyor and The County Recorder. Democratic government is not improved by depriving the citizens of their right to vote. The Citizens' right to vote is a great restraining influence on government officials. When citizens lose control of government, government becomes ruthless and ruthlessness is not efficiency.

FIFTH. No one has pointed out just how the charter government will be more efficient. Economy of operation usually follows efficiency and yet no argument has been advanced that the proposed charter will result in reduced taxation. The absence of such arguments is strong indication that no such economies are to be expected.

SIXTH. Chapter IV of the Charter provides for six county officers—three elective and three appointive. It also states:

"The Board of county commissioners may . . . change the functions of an officer . . . except that no change in the function of a department headed by an elective officer may be made without the consent of either the officer or the legal voters of the county."

The Board is free to offer the elected officer an increase in salary if he consents or to penalize him in countless ways, if he does not. Once he consents, the function can be changed and the voters are through. THIS IS THE CONCEALED HOOKER OF THE CHARTER.

The voters of Marion County will do well to make sure that this Trojan Horse of Government never gets within the walls of the Marion County Courthouse.

## Measure No. 2

**HOME RULE CHARTER FOR MARION COUNTY**

Proposed by Marion County Charter Study Committee pursuant to  
ORS 203.710 et seq.

## PREAMBLE

We, the people of Marion County, Oregon, in recognition of the dual nature of the county as an agency of the state and as a unit of local government, and in order to avail ourselves of self-determination in county affairs under the constitution and laws of the state and this charter, hereby confer upon the county the following powers, subject it to the following restrictions, and prescribe for it the following procedures and governmental structure:

## CHAPTER I

## INTRODUCTORY PROVISIONS

Section 1. NAME. The name of the county shall be Marion County, Oregon.

Section 2. NATURE AND LEGAL CAPACITY. In operating under this charter the county shall continue to be—

- (1) an agency of the state and
- (2) a body politic and corporate.

Section 3. BOUNDARIES. The boundaries of the county shall be the boundaries now or hereafter prescribed for it by or pursuant to state law.

Section 4. COUNTY SEAT. The seat of government of the county shall be in the City of Salem.

Section 5. FORM OF GOVERNMENT. The governmental structure of the county shall consist of—

- (1) a board of county commissioners, consisting of seven members,—
  - (a) one member to be a full-time chairman elected at large and
  - (b) the board as a whole—
    - (i) to be the principal legislative and policy-making agency of the county and
    - (ii) to bear the main responsibility for the administration of the affairs of the county,
- (2) the administrative departments and offices established for the county by or pursuant to this charter and
- (3) whatever courts now or hereafter have jurisdiction over matters of county concern by virtue of state law or this charter.

## CHAPTER II

## POWERS OF THE COUNTY

Section 6. POWERS OF COUNTY IN GENERAL. Except as this charter provides to the contrary, the county shall have all authority now or hereafter granted to it by the constitution or laws of the state or this charter.

Section 7. WHERE POWERS VESTED. Except as—

- (1) this charter or
- (2) the provisions of the state constitution regarding the initiative and referendum

provide to the contrary,—

- (1) the legislative power of the county shall be vested in, and exercisable only by, the board of county commissioners, and
- (2) all other powers of the county are vested in the board and may be exercised by the board or by persons acting under its authority.

Section 8. CONSTRUCTION OF CHARTER. In this charter no mention of a particular power shall be construed to be exclusive or to restrict the scope of the authority and powers that the county would have if the particular power were not mentioned. The charter shall be liberally construed, and the powers of the county under the charter shall be deemed continuing powers, except as the charter prescribes to the contrary.

Section 9. LOCAL SERVICES.

- (1) The board of county commissioners by ordinance may establish local service districts for the purpose of providing one or more services for the special benefit of persons and property in particular areas.
- (2) The board shall be the governing body of each such district that it establishes.
- (3) Such a district may be established in such an area only with the consent of—
  - (a) a majority of the legal voters in the area expressed by petition or other written statement, or
  - (b) a majority of the legal voters participating in an election in the area on the question of establishing the district.

By ordinance the board shall prescribe procedures by which the voters may thus express this consent.

- (4) The board shall fix the boundaries of each such district on the basis of the territorial extent of the special benefit derived from the service.
- (5) The special benefit provided by a local service district may be financed only by taxes, assessments, and charges specially levied in the district or by funds specially allocated by the State or the United States or given by some other donor for one or more purposes of the district.
- (6) The Board may, by contract with a special district operated pursuant to State law, assume the functions of the district and may contract with an existing district or any political subdivision to have all or any part of such functions carried out by such district or any other district or political subdivision.

Section 10. PUBLIC IMPROVEMENTS.

- (1) The board of county commissioners by ordinance may make, alter, vacate and abandon public improvements.
- (2) The procedure for making, altering, vacating and abandoning a public improvement of the county shall be governed—
  - (a) by the charter and general ordinances of the county or,
  - (b) to the extent not so governed, by the applicable general laws of the state.

- (3) To the extent that the board of county commissioners finds that a public improvement specially benefits property in the vicinity of the improvement, the cost of the improvement shall be defrayed by special assessments levied on the property, and to the extent that the board finds that a public improvement is of benefit to the county generally, the cost of the improvement may be defrayed by revenue derived from other sources.
- (4) An order regarding a public improvement of the county shall indicate—
- (a) the extent to which the cost is to be defrayed by special assessments on property to be specially benefited, and
  - (b) the extent to which the cost is to be defrayed by revenues of the county derived from other sources.
- (5) Action by the board on a proposed public improvement—
- (a) to be financed in whole or in part by county revenues not derived from special assessments and
  - (b) not declared by all members of the board to be needed at once to meet an emergency
- shall be subject to the referendum in the same manner as ordinances of the board.
- (6) Action by the board on a proposed public improvement—
- (a) to be financed in whole or in part by special assessments and
  - (b) not declared by all members of the board to be needed at once to meet an emergency
- may have legal effect only with the approval of the voters in the area to be affected by the special assessments, in the event that owners of more than one-half of the land to be specially assessed for the improvement remonstrate against the improvement. To have legal effect, the remonstrance must be written and delivered to the board within 15 days after the action is ordered. The word "owner" shall mean the record holder of the legal title, except that in case there is a purchaser of land according to a recorded land-sale contract, the purchaser shall be deemed the owner.
- (7) The procedure for levying, collecting, and enforcing the payment of special assessments to be levied against real property on account of public improvements or other services shall be governed by the charter and general ordinances of the county.

### CHAPTER III

#### BOARD OF COUNTY COMMISSIONERS

Section 11. ELECTION OF MEMBERS. Except as this charter provides to the contrary,—

- (1) the chairman of the board of county commissioners shall be nominated and elected from the county at large, and
- (2) the other six members of the board shall be nominated and elected to offices by districts as follows:
  - (a) one commissioner to Office No. 1 by the voters of District No. 1, which shall consist of the following voting precincts as bounded July 1, 1962: Nos. 69, 78, 80, 82, 83, 84, 86, 88, 90, 92, 94, 96, 98, 100, 102, 104, 106, 108, 110, 112, 114, 126, 128.

- (b) one commissioner to Office No. 2 by the voters of District No. 2, which shall consist of the following voting precincts as bounded July 1, 1962: Nos. 116, 118, 119, 120, 124, 130, 132, 134, 135, 136, 138, 139, 140, 142, 144, 146, 148, 150, 152, 170.
- (c) one commissioner to Office No. 3 by the voters of District No. 3, which shall consist of the following voting precincts as bounded July 1, 1962: Nos. 55, 56, 59, 63, 64, 65, 66, 67, 156, 157, 158, 160, 161, 162, 164, 166, 168, 172, 174, 176, 177, 178, 179, 180, 182, 184, 186, 188.
- (d) one commissioner to Office No. 4 by the voters of District No. 4, which shall consist of the following voting precincts as bounded July 1, 1962: Nos. 43, 44, 45, 46, 47, 48, 49, 50, 51, 52, 53, 54, 57, 58, 60, 61, 62, 70, 71, 72, 73, 74, 75, 76, 77, 79, 81, 85, 154, 167, 169, 171, 173.
- (e) one commissioner to Office No. 5 and one commissioner to Office No. 6 by the voters of District No. 5, which shall consist of the City of Salem as bounded July 1, 1962, insofar as it lies in Marion County.

The Board, in accordance with the policy of representation hereinafter stated,—

- (1) shall allocate each new voting precinct hereafter established to one of the districts and
- (2) may change district boundaries by transferring voting precincts from one district to another.

#### Section 12. NOMINATION AND ELECTION OF FIRST COMMISSIONERS.

The first seven members of the board of county commissioners shall be nominated and elected to it as follows:

- (1) Candidates for offices on the board shall be nominated by petitions filed with the county clerk not later than August 15, 1964.
- (2) To nominate a candidate for the chairmanship of the board, a petition shall bear the signatures of 200 legal voters resident in the county.
- (3) To nominate a candidate for the office of commissioner from a district, a petition shall bear the signature of 100 legal voters resident in the district. No petition may nominate more than one such candidate.
- (4) On the ballot for the general election in November, 1964, the county clerk—
  - (a) shall enter the name of each candidate nominated in accordance with this section and
  - (b) shall identify the office that he seeks on the board.
- (5) Except as this charter provides to the contrary, at the general election in November, 1964,—
  - (a) the candidate for the chairmanship of the board who receives the highest number of votes cast for any candidate for the office may hold the office for four years, beginning January 4, 1965, and until his successor to the office qualifies for it;
  - (b) each candidate for an odd-numbered office on the board who receives the highest number of votes cast for any candidate for the office may hold the office for four years, beginning January 4, 1965, and until his successor to the office qualifies for it; and
  - (c) each candidate for an even-numbered office on the board who receives the highest number of votes cast for any candidate for the office may hold the office for two years, beginning January 4, 1965, and until his successor to the office qualifies for it.

### Section 13. SUBSEQUENT NOMINATION AND ELECTION OF BOARD MEMBERS.

- (1) Subsequent nominations for offices on the board of county commissioners as hereinafter specified shall be at primary elections on a partisan basis, in accordance with the procedure provided by state law for nomination of candidates for political parties.
- (2) At the general November election in 1966 and at each alternate general November election thereafter a commissioner shall be elected to each even-numbered office on the board.
- (3) At the general November election in 1968 and at each alternate general November election thereafter—
  - (a) a chairman of the board shall be elected and
  - (b) a commissioner shall be elected to each odd-numbered office on the board.

Section 14. REAPPORTIONMENT. The policy of the county regarding representation of districts from which commissioners are elected shall be that district boundaries be drawn, insofar as possible, so as to produce districts with maximum communities of interest as reflected by—

- (1) local governmental boundaries,
- (2) topography,
- (3) economic and social activities,
- (4) lines of communication and transportation, and
- (5) population.

Section 15. QUORUM. The quorum necessary for action by the board of county commissioners shall be a majority of the members of the board. A lesser number may, however, meet and compel the attendance of absent members in a manner prescribed by ordinance.

### Section 16. BOARD MEETINGS.

- (1) The board of county commissioners shall adopt rules for the government of its members and proceedings.
- (2) The board shall meet regularly at least twice each month at times and a place or places that it designates in the rules that govern its proceedings.
- (3) No action by the board may have legal effect unless—
  - (a) the motion for the action and
  - (b) the vote by which the motion is approved or rejected take place at a public meeting in the Courthouse.
- (4) The chairman of the board—
  - (a) upon his own motion may, or
  - (b) upon the request of three members of the board shall, by giving notice to all members of the board then in the county, call a special meeting of the board for a time—
    - (a) not earlier than six and
    - (b) not later than 48 hours after the notice is given.
- (5) Special meetings of the board may also be held at any time by unanimous consent of all board members then in the county.

Section 17. RECORD OF PROCEEDINGS. The board of county commissioners shall cause a record of its proceedings to be kept. Upon the request of a member of the board that the individual votes on a question before the board be recorded in the record, the votes shall be so recorded. The final votes on all ordinances before the board shall be individually recorded in the record.

Section 18. VOTE REQUIRED. Except as this charter provides to the contrary, no action by the board of county commissioners may have legal effect unless concurred in by four board members. An emergency ordinance may have legal effect only if approved by all board members present at the meeting at which the ordinance is adopted.

Section 19. ORDINANCES.

- (1) Ordinances shall be introduced by a member or members of the board, or by the board as a whole, and shall be in written or printed form. All ordinances shall be public records and shall be filed with the Clerk of the board not less than 48 hours prior to the first reading thereof.
- (2) The enacting clause of an ordinance enacted by the board of county commissioners and not referred to the voters shall read, "The Board of County Commissioners of Marion County ordains as follows:". The enacting clause of an ordinance referred to the voters shall read, "The people of Marion County ordain as follows:".
- (3) Except as this section provides to the contrary, every ordinance of the board shall, before being put upon its final passage, be read fully and distinctly in open board meeting on two different days.
- (4) Except as this section provides to the contrary, an ordinance may be enacted at a single meeting of the board by unanimous vote of all board members present, upon being read first in full and then by title.
- (5) Any required reading of an ordinance may be by title only—
  - (a) if no board member present at the reading requests that the ordinance be read in full or
  - (b) if—
    - (i) one week prior to the reading a copy of the ordinance is supplied each board member,
    - (ii) for one week immediately prior to the reading three copies of the ordinance are available for public inspection in the headquarters of the board, and
    - (iii) written notice of this availability is given immediately upon the filing of the copies in the headquarters of the board, by being posted in the county courthouse and at three other public places in the county or by being published in a newspaper of general circulation in the county.
  - (c) An ordinance enacted after being read by title only may have no legal effect if it differs substantially from its terms as it was filed prior to the reading, unless each section incorporating such a difference is, as finally amended, read fully and distinctly in open board meeting prior to being enacted by the board.
- (6) Upon the enactment of an ordinance, the person who serves as recording secretary for the board shall sign the ordinance and state

on it the date of its enactment and the title of his office or position. Within three days after the ordinance is enacted the chairman of the board shall sign the ordinance and state on it the date of his signature and the title of his office.

- (7) Unless it specifies that it shall take effect at a later date, in which event it shall take effect on that date, an ordinance shall take effect—
- (a) immediately upon its enactment, in case the board deems it necessary to meet an emergency;
  - (b) 20 days after its enactment, in case it is—
    - (i) not deemed by the board to be necessary to meet an emergency and
    - (ii) not referred to the voters; and
  - (c) immediately upon its approval by the voters, in case it is referred to them.

#### Section 20. BOARD CHAIRMAN.

- (1) The chairman of the board of county commissioners—
- (a) shall be the political and ceremonial head of the county;
  - (b) shall devote full time to the affairs of the county;
  - (c) shall maintain an office at which residents of the county may lay before him and whatever staff the board allows him their requests, comments, and suggestions regarding the government of the county;
  - (d) shall periodically make reports and recommendations to the board concerning the affairs of the county, including recommendations as to county legislation;
  - (e) shall be ex officio a nonvoting member of all appointive boards and commissions of the county;
  - (f) shall inquire, subject to the direction of the board, into—
    - (i) the operations of the departments, offices and agencies of the county and
    - (ii) the manner in which the obligations of contracts to which the county is a party are being met;
  - (g) shall preside over the deliberations of the board whenever in attendance at them;
  - (h) shall have authority—
    - (i) to preserve order at board meetings,
    - (ii) to enforce the rules of the board, and
    - (iii) to determine the order of board business under the rules of the board;
  - (i) shall have a vote, but no veto, on all questions before the board; and
  - (j) shall exercise whatever additional functions the board prescribes for him.
- (2) In the absence of the chairman from a board meeting the board shall designate one of its members chairman pro tem.

#### Section 21. INELIGIBILITY FOR APPOINTMENT. No member of the board of county commissioners may,—

- (1) during his term of office as such or
  - (2) for one year thereafter
- hold an appointive county office or position for which compensation is authorized.



CHAPTER IV  
ADMINISTRATION

Section 22. ADMINISTRATIVE DEPARTMENTS. For purposes of carrying out the policies of the county and administering its affairs, the following administrative departments are hereby established and shall have functions as follows, except as this charter provides to the contrary:

- (1) the department of general services, administered by a director appointed by the board of county commissioners, which shall have the following functions:
  - (a) auditing and establishment of uniform accounting procedures,
  - (b) budget planning and control,
  - (c) planning and installation of internal organization plans and work methods,
  - (d) personnel administration,
  - (e) purchasing,
  - (f) property management,
  - (g) central duplicating services,
  - (h) central data processing, and
  - (i) central pools of personnel and equipment;
- (2) the department of finance, administered by a director elected by the people, shall have the functions—
  - (a) of the county treasurer under state law,
  - (b) of the county assessor under state law,
  - (c) of the sheriff under state law pertaining to tax collection, and
  - (d) of the county clerk under state law pertaining to the payment of authorized county obligations;
- (3) the department of public records, administered by a director elected by the people, which shall have the functions—
  - (a) of the county recorder under state law and
  - (b) of the county clerk under state law that are not otherwise allocated by this section;
- (4) the department of public works, administered by a director appointed by the board of county commissioners, which—
  - (a) shall have the functions of the county surveyor under state law,
  - (b) shall be responsible for all engineering, planning, designing, constructing, maintaining, and inspecting of the public works of the county, and
  - (c) shall make the inspections involved in enforcement of the building and zoning regulations of the county;
- (5) the department of law enforcement, administered by a director known as the Sheriff and elected by the people, which shall have the functions of the sheriff and the constables under state law, except functions pertaining to tax collection; and
- (6) the department of health and sanitation, administered by a director appointed by the board of county commissioners, which shall have the functions of—
  - (a) the county health officer,
  - (b) the county sanitarian,
  - (c) the county board of health, and
  - (d) the county coroner or medical investigator under state law.

The board of county commissioners may at any time change the functions of an officer or agency of the county, except that no change in the function of a department headed by an elective officer may be made without the consent of either the officer or the legal voters of the county. A function of a county officer or agency not allocated to any county officer or agency by this charter shall be allocated to whatever department of the county the board from time to time determines.

The directorships required by this section to be filled by election shall be so filled at the general November elections in 1964 and every fourth year thereafter, except that if any person elected to one of the directorships fails to hold the office more than one year and nine months beyond the time he is elected to it, his successor to the office shall be elected at the immediately ensuing general November election.

## CHAPTER V

### OFFICERS

**Section 23. TERMS OF OFFICE.** The term of office of each elective administrative officer shall be four years beginning the first Monday in January immediately following his election. The term of office of each elective officer in office June 1, 1964, shall end January 4, 1965.

**Section 24. QUALIFICATIONS.**

- (1) No person may be a member of the board of county commissioners—
  - (a) unless he is a qualified voter within the meaning of the state constitution;
  - (b) unless he resides in the county and has resided there for three years immediately prior to the time that he is elected or appointed to the board; and
  - (c) in case he represents a district, unless he resides in the district and has resided there for one year immediately prior to the time that he is elected or appointed to the board.
- (2) To qualify for any other elective office, a person must be a registered voter in Marion County.
- (3) To qualify for an appointive office or position with the county, a person shall have whatever qualifications the board prescribes for the office or position, except that the director of public works shall be a registered civil engineer.

**Section 25. VACANCIES IN OFFICE.** An office shall be deemed vacant—

- (1) upon the incumbent's—
  - (a) death,
  - (b) adjudicated incompetence,
  - (c) conviction of—
    - (i) a felony,
    - (ii) unlawful destruction of public records, or
    - (iii) other offense pertaining to his office,
  - (d) resignation,
  - (e) recall from the office, or
  - (f) ceasing to possess the qualifications for the office;

- (2) upon the failure of the person elected or appointed to the office to qualify therefor within ten days after the time for his term of office to begin; or,
- (3) with reference to a member of the board of county commissioners,—
  - (a) upon his absence—
    - (i) from the county for 30 days or
    - (ii) from board meetings for 60 days without the consent of the board and
  - (b) upon a declaration by five board members of the vacancy.

Section 26. FILLING OF VACANCIES.

- (1) A vacancy on the board of county commissioners shall be filled in the manner now prescribed by state law for filling vacancies in county courts and boards of county commissioners, except that the filling of the vacancy may have legal effect only if concurred in by a majority of the remaining members of the board.
- (2) A vacancy in any other elective county office shall be filled by appointment by the board of county commissioners. The appointee shall serve until the next person elected to the office qualifies for it.
- (3) During an officer's or employe's—
  - (a) temporary disability or
  - (b) temporary absence from the countyhis office or position may be filled pro tem by the board.

Section 27. REMUNERATION.

- (1) Except as this charter provides to the contrary,—
  - (a) the compensation of the chairman of the board of county commissioners shall be \$10,000 per year and
  - (b) the compensation of each other board member shall be \$25 for each board meeting that he attends, but not more than \$100 per month.
- (2) The board may increase or decrease the salaries of its members, but any such change shall be subject to the referendum in the same manner as nonemergency ordinances enacted by the board.
- (3) A board member shall, on the basis of general rules that the board prescribes, be reimbursed from county funds for expenses that he necessarily incurs in serving as a board member.
- (4) The compensation for the services of the director of the department of finance shall be not less than the compensation being paid the County Assessor at the end of 1964. The compensation for the services of the director of the department of public records shall be not less than the compensation being paid the County Clerk at the end of 1964. The compensation for the services of the director of the department of law enforcement shall be not less than the compensation being paid the Sheriff at the end of 1964.
- (5) The compensation for the services of all other administrative officers and employes shall be whatever amounts the board fixes.

## CHAPTER VI

## ELECTIONS

Section 28. NOMINATION AND ELECTION OF COUNTY OFFICIALS. Except as this charter provides to the contrary, after the final effective date of this charter the manner of nominating and electing county officials shall be on a partisan basis in the manner now or hereafter prescribed by the laws of the state. In the general election of November 1964 the nominees for the office of Treasurer in the primary election of May 1964 shall be deemed the nominees for the office of Director of the Department of Finance, and the nominees for the office of Clerk shall be deemed nominees for the office of Director of the Department of Public Records. Each elective administrative officer elected in the general election of November 1964 shall take office January 4, 1965.

Section 29. RECALL. Elected county officials may be recalled in the manner, and with the effect, now or hereafter prescribed by the constitution and laws of the state.

Section 30. ELECTIONS ON COUNTY PROPOSITIONS. Except as—

- (1) this charter or
- (2) legislation enacted in accordance with it

provides to the contrary, the manner of conducting an election on a proposition concerning the county shall be the manner prescribed by the laws of the state for an election in the county on such a proposition.

## CHAPTER VII

## MISCELLANEOUS PROVISIONS

Section 31. INDEPENDENT AUDIT AND MANAGEMENT REPORT. The board of county commissioners shall provide for an annual independent audit and management report. No person or firm may make more than three successive such audits for the county.

Section 32. EXISTING LEGISLATION CONTINUED. All legislation of the county—

- (1) consistent with this charter and
- (2) in force when it takes effect

shall remain in effect as at present until amended or repealed.

Section 33. VALIDITY AND SEPARABILITY OF CHARTER PROVISIONS. If any provision of this charter or the application thereof to any person or in any circumstance is held invalid, the remainder of the charter and the application of its provisions to such person or other persons and in like or other circumstances shall not be affected thereby.

Section 34. EFFECTIVE DATE. This charter shall take effect January 4, 1965, except that it shall take effect June 1, 1964, insofar as necessary for the nomination and election of the officers to be elected at the general election in November 1964.
