MEMORANDUM FOR RECORD

SUBJECT: THOMAS, Carl H., Ensign
SYPHER, Mary H., Civil Service Employee, Navy

1. 1130 hrs, 20 Jan 52 in conference with Col Bratton, D/ACofS G2 FEC, Subjects' names were given me with instructions to determine and to obtain photographic evidence pertaining to the following:

a. Check Registers:

(1) Hotel Akakura, Taguchi-shi, Nagano-ken, dates : Feb 1951; 18-21 April 1951; 27-30 July 1951.

(2) Hotel Gohra, Gohra-machi, Kanagawa-ken, dates: Feb 1951; 18-21 April 1951; 27-30 July 1951.

(3) Hotel Nikko (Nikko Shrine), Nikko, Tochigi-ken, dates: June, July, August, 1951.

b. Determine:

(1) If Ensign Thomas registered at above hotels during periods indicated:

(a) With Mary H. Sypher, as man and wife

(b) Registered in own name and wife

(2) Sypher, Mary H. registration, if any

c. Obtain photographic evidence of hotel registers showing registrations determined in par 1, b, above together with certificate or affidavit from the Special Services Manager indicating any such registration to substantiate the photograph. Negative report required.

d. Determine from Special Services Hotel Division, JLC, any information pertaining to approval of requests for reservations at the hotels indicated in par 1, a, above by subjects during the periods stated above. Negative reports required.
