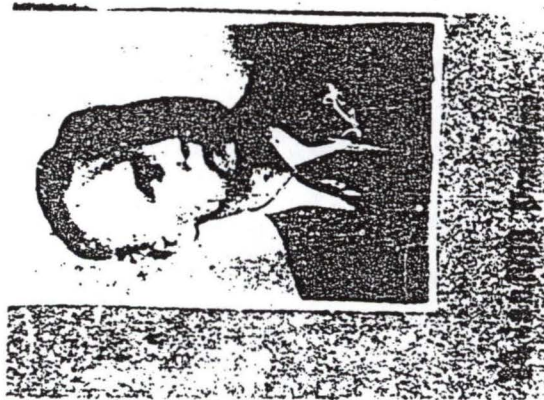

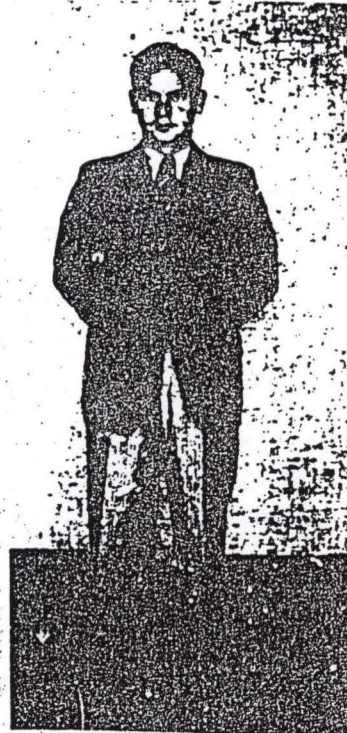
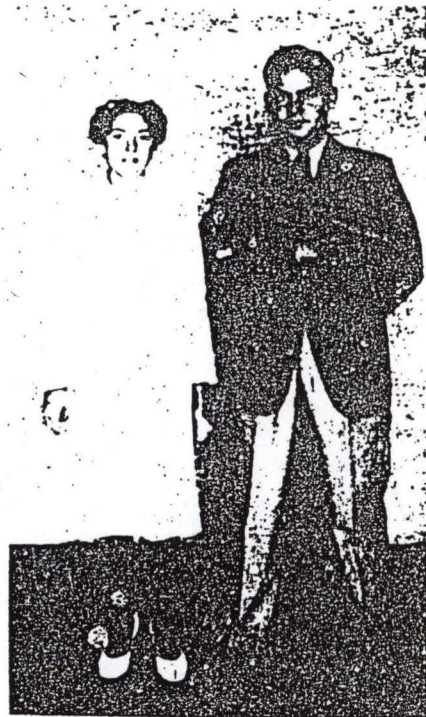

1. We note that reference has never been answered and regret the oversight.

3. He heads CASTIRRUP's Sachgebiet S (Begleitschutz und Sicherungsdienst) with the title of Referent and is assisted in his job by 27 officials. We recently learned from BUETTNER that he has developed a new type Filing Cabinet Safe which is light, but fitted with a "foolproof" alarm system which does not use ultrasonic methods. Ich habe bis zum 8.10. bei einem Einsatzkommando der Gestapo in Kongreßpolen gestanden und bin am 10.10. von dort in die Heimat zurückgekehrt. Mein Aufenthalt in Stettin ist mit Bestimmtheit nur von kurzer Dauer. Ich habe entweder als Krim.-Kommissar mit baldigem neuen Einsatz im Osten oder als Soldat der Res. II mit meiner Einberufung zum Westen zu rechnen. In der kurzen zur Verfügung stehenden Zeit möchte ich heiraten. Wegen der Kürze der verbleibenden Zeit bitte ich um möglichst sofortige Erteilung der Genehmigung. Sollten jedoch besondere Hinderungsgründe bestehen, wäre ich für entsprechenden Bescheid und deren Mitteilung dankbar.

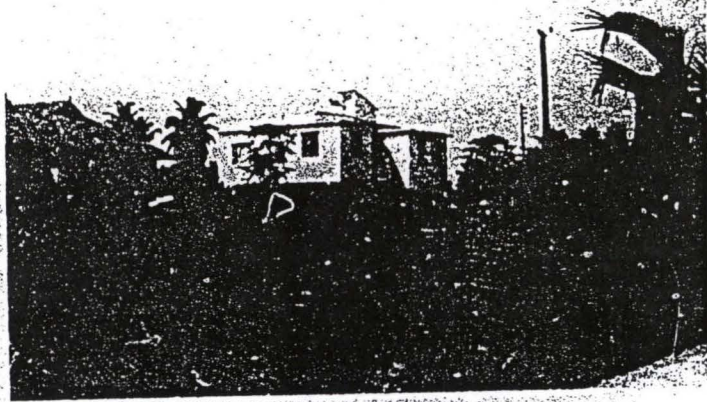

1. The following is a resume of our information on BUTTNER (spelling taken from his passport, copy of which was sent to Headquarters with ATLA-147, info Chief, WE) and his activities here. We are attaching copies of ATLA-147 for Munich, Frankfurt and Bonn.

2. BUTTNER, left Togo by air on 17 January 1963, a few days after the coup d'etat of 13 January. There were rumors circulating in Lomé that he had driven [] to Dahomey during the night of the coup but these rumors were subsequently proved false. We heard nothing further about him until 24 January. On that date, [] was in a hotel room in Lagos with [] when a representative of the West German Embassy in Lagos (who we presume to be the Press Attache) entered and told [] that BUTTNER was returning to Lagos the next day from Germany to see him. This was reported in [] with copy to Frankfurt. Apparently the Germans changed their minds about recontacting [] for [] indicates that BUTTNER has not appeared there. He has not shown up in Lomé (as of 15 February) though his family still is living here. For the record, we are attaching for Headquarters only, one photograph of the house BUTTNER rents in Lomé.

3. In [] , to Headquarters only, we reported that BUTTNER had brought a radio technician to Lomé, and he was working out of [] office. This information was expanded in ATLA-127. (If addressees interested in receiving copy, suggest it request same from Headquarters) We have not been able to find out the name of this technician, and apparently he left Togo after the coup.

4. The above comprises all we know about BUTTNER. If we hear of his return to Lomé, addressees will be kept advised.

1. On 23 July 1963, during a visit to Cotonou, Dahomey, [] was advised by [] that subject had remained in Cotonou from the time of the coup in Togo in January 1963 until June 1963. [] said that he had also seen him driving his car in Lomé several times during this period. The reason that [] is familiar with Subject is that he purchased some of the latter's furniture in Lomé, visiting his home there several times, and meeting Subject's wife and daughters. [] learned of the sale of Subject's furniture from the German Embassy in Cotonou. He said he met BUTTNER in Cotonou and was told the latter was connected with the German Embassy.

2. The above story is rather peculiar. Although this was our first meeting with [], we are impressed with his seriousness and intelligence and have no reason to doubt the facts as he related them. We had been under the assumption that Subject had returned to Germany shortly after the coup and had remained there, though his family stayed in Lomé until June. It is rather strange that the Germans would keep him in Cotonou for six months at a time when the Togolese authorities were looking for him, and it is stranger still that he drove to Togo on more than one occasion. Why the Germans, or BUTTNER, sold some of his furniture in Cotonou rather than in Lomé where it was located is also puzzling.
