Lieut. H. C. PAIGE in a PB4Y-1P aircraft of Fleet Air Photographic Squadron One took off from Agana Airbase, Guam, M. I. on 1 August 1945 at 0757 King to photograph enemy installations on Truk Islands. He arrived over the target at 1137 King and continued to photograph until 1247 King. Coverage of the major portion of the central islands was accomplished from an altitude of 20,000 feet using a Tri-K18-24 inch camera. The outer reef was photographed from an altitude of 10,000 feet using a K18-24" vertical camera. Neither enemy interceptor nor antiaircraft fire was encountered. Lieut. PAIGE returned to Agana at 1612 King.
