## SECOND ANNUAL MEETING

### Minutes

The second annual meeting convened at the National Agricultural Library on May 16 at 10:00 a.m., Angelina J. Carabelli, President presiding.

The business meeting dealt with both old and new matters. Reports were presented by committee chairmen or their delegates.

Membership: Miss Mildred Benton gave figures on enrollment. Since the Board of Directors meeting February 2, 1972 the Associates have received nine (9) new personal members and two (2) institutional members. Total enrollment stands at sixty-one (61) personal members and five (5) institutional members.

Membership renewal notices were sent out in June and membership cards will be issued for the first time this year.

Mrs. Ruth Pyne has suggested establishment of a category of life memberships. Dr. James Gwin recommended that life membership dues received be placed in a special interest-earning account for the benefit of The Associates



Dr. Charles E. Kellogg proposed foreign memberships. These suggestions will be placed before the Board of Directors in November. Meanwhile, let us have your comments.

Awards Committee: Dean Trivette reported the Committee is seeking contributors to fund the Awards Program.

Finance Committee: This report was presented by Dr. C. S. Shaffner. The "Statement of Receipts and Disbursements for the year ended December 31, 1971" was prepared by J. Hosley, Certified Public Accountant. A Financial Statement for Jan. 1 - May 15, 1972 was also presented. Both statements follow on page four.

Purchase Committee: Dr. James Gwin presented recommendations, as Chairman, for exhibits at international congresses based on the resources of the National Agricultural Library. Dr. Gwin was encouraged to set up a special committee to design the exhibit and to seek some financial support.

Program Committee: The Executive Secretary, in the absence of the chairman, reported on the status of various program activities.

1. The Volunteer Program has been approved by the Board of Directors, but not yet implemented.
2. A Sales Desk has been approved and will probably be a function of the Information Desk in the NAL Lobby after July 1. Projected items for sale will include publications of The Associates, slide sets on NAL, post cards, and Christmas cards.
3. Professional Activities Fund: Initial contact for a grant has been made with Rockefeller Foundation. The proposal is in the draft stage.

No action was taken on the following proposals:

1. Regional Agricultural History Collections.

LINCOLN EXHIBIT

The highlight of the meeting was the presentation to the Library by the Associates of a permanent exhibit on "Abraham Lincoln and His Legacy to American Agriculture". The date of the presentation fell within one day of the Organic Act establishing USDA, May 15, 1862.

We were especially fortunate in having Representative Fred Schwengel (R-Ia) as our guest speaker. Representative Schwengel is a noted Lincoln buff and a good friend to the Library. Chester O. Harris, who was instrumental in securing the bust of Lincoln for the exhibit, spoke on its provenance.

The exhibit, placed in the Lobby of the National Agricultural Library, includes a bronze bust of Lincoln sculpted by Leo Cherne. This bronze is an identical replica of the bronze presented by President Eisenhower to President Prasad of India in 1959. The Associates NAL are indebted to the National Park Service and the Lincoln Museum in the Ford's Theatre National Historic Site, Washington, D.C. for making this bronze available on indefinite loan.

Also included in the exhibit are framed facsimile copies of "An Act Establishing the Department of Agriculture, 1862; the Homestead Act of 1862; and the Land Grant Colleges, October 1862.

Miss Angelina J. Carabelli, President, formally presented the exhibit to John Sherrod, Director, NAL.

A monograph "Abraham Lincoln: His Legacy to American Agriculture" commemorates the event. Copies have been distributed to all members. Additional copies are available from the Executive Secretary at \$1.50 per copy.



HAPPENINGS AT NAL

National Commission on Libraries and Information Science

The Commission met at the National Agricultural Library on June 15, 1972. John Sherrod, Director, NAL, spoke to the group on the program, goals, and objectives of the Library. This was followed by a tour of the facilities led by Mrs. Irene White and Mr. Joseph Judy of the Staff. The Commission members reassembled to ask questions and to hear more details on NAL organization from key members. The Associates hosted the luncheon which followed.
