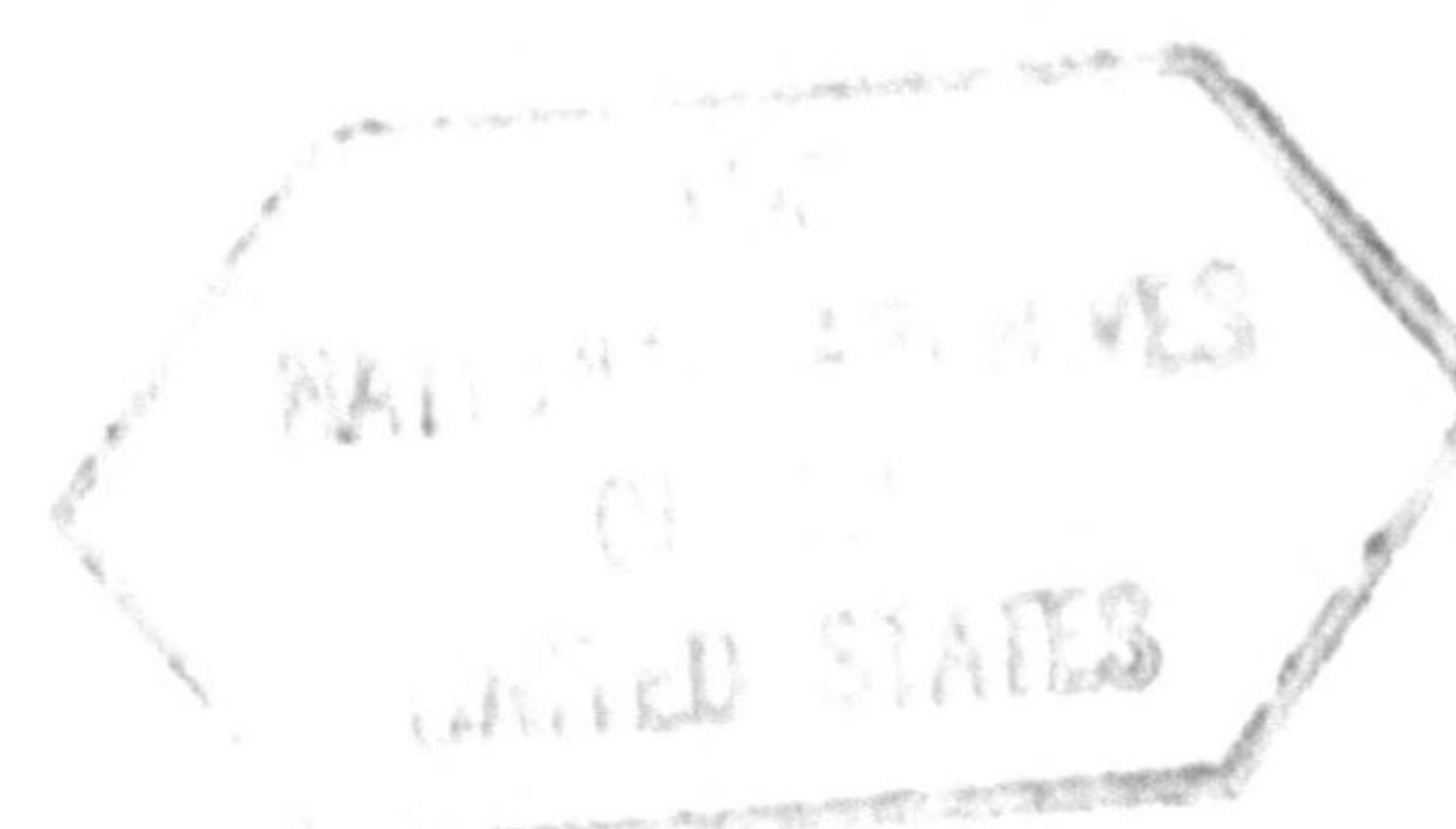

SUBJECT: Report on Restitution of Looted Property

TO: Joint Chiefs of Staff  
Washington 25, D. C.

1. After necessary identification, or upon approval by the Supreme Commander for the Allied Powers, of recommendations made by the Restitution Advisory Committee, the following properties removed from occupied areas were restored to their respective claimant governments during the period 25 January 1950 to 25 February 1950:

a. To the Government of the Republic of China

(1) 2,100 tons of alumina shale at Tokyo, Japan

✓ b. To the Netherlands Government

(1) 17,905 kgs of tin at Tokyo, Japan

(2) 1,006,303.3 fine grams of gold and 10,018,020.7 fine grams of silver at Osaka, Japan

c. To the Government of the Republic of the Philippines

(1) Diesel Shovel parts at Tokyo, Japan

d. To the Government of the United Kingdom

(1) 52 cars (5.2 meters long) at Kure, Japan

(2) 6 vehicles at Kobe, Japan

2. The original and one copy of the receipt forms executed in case of each restitution are being retained in the files of General Headquarters, Supreme Commander for the Allied Powers.
