A group of 12 F4U-7's - 4 each from the SHANROCK BAY, MAKIN ISLAND AND RUDYERD BAY & under the lead of Lt R.W. WYATT, VC-94, providing direct support over Okinawa at 0630 I, May 7, was directed to make a high speed attack against the town of Dakeshi in which enemy troops were entrenched. Individual runs were made by each plane starting at 3500 feet and releasing at 2000 with and indicated air speed of 250 kts. 2 of our planes made 2 runs; expending both bombs and AR on the second run; the other planes made 2 bombing runs and 1 rocket attack. 1 fire with dense black smoke was started in the town; all bombs and AR hit the town.
