## REQUEST OF BUREAU

Bureau requested to advise whether or not MARTIN JONES is an ex-FBI agent, noting whether or not he left the Bureau in good graces may be of significance in connection with possibly using him as source relative to MARK HAWES connections with the subject.

It is further noted that MARK HAWES is very close to the Florida Legislature which could be significant should any move be made to legalize gambling in the State of Florida.
