1. The attached letter requesting the return of a 23 jewel gold watch which was confiscated by the International Mail Parcel Post Section, Osaka Custom House, was received by this headquarters. Receipt of innumerable similar letters by this headquarters requesting return of confiscated items to the original sender is believed to be caused by ignorance of customs regulations by people sending the relied articles into Japan.

2. The following non-relief items were received by this headquarters and disposition is hereby requested:

TO: Commanding General, I Corps, APO 301

1. Regulations pertaining to relief parcels have been supplied all member nations of the Universal Postal Union and Diplomatic Missions in Japan. Information as to the permissible contents of relief parcels has been widely published in Japan. Gift articles such as watches, fountain pens electrical appliances, etc., are not permitted entry nor will they be returned to sender.

2. Items a, b, c, d, and e mentioned in paragraph 2 of basic letter should be turned over to the Japanese Customs for disposition in accordance with Japanese laws and regulations. Item f, American currencies, should be converted to yen at the nearest finance office. Yen so obtained should be delivered to a recognized relief agency to be used for relief purposes.

3. Pending publication of additional instructions from SCAP request for disposition of confiscated items will be forwarded to this headquarters.

SUBJECT: Report on 35,000,000 Yards of Incentive Cotton Cloth

TO: Osaka Liaison Office

1. You are directed to submit to this Headquarters weekly reports on the progress of dyeing 35,000,000 yards of cotton cloth which is to be distributed as incentive goods for farmers.
2. Included in the initial report will be the following:
 - a. List of warehouses in Osaka Prefecture storing 35,000,000 yards of cloth to be dyed for incentive goods purposes and number of yards in each warehouse.
 - b. The number of yards moved to the dyeing factories.
 - c. Number of yards dyed and ready for shipment.
 - d. Number of yards shipped to various prefectures for distribution.
 - e. Any obstacle retarding the rapid progress of the program.
3. The initial report will be submitted to this Headquarters by 9 October 1948. The succeeding reports will contain all the information as directed in paragraph 2b to e and due at this Headquarters each Saturday thereafter.

SUBJECT: Disposition of Confiscated Items
THROUGH: Commanding General, I Corps, APO 301
TO: Commanding General, GHQ, SCAP, APO 500

1. Under date, 21 January 1948, this headquarters requested information concerning the disposition of non-relief items confiscated from the International Mails.

2. By 2nd Indorsement, GHQ, SCAP, File No. AG 386.5 (21 Jan 48) ESS/FI, dated 20 February 1948 directed "non-relief items be released by the Osaka Military Government Team to recognized Japanese Relief Agencies to be sold and proceeds used for relief purposes."

3. It is believed by this headquarters that such disposition will require more minute surveillance than can be exercised in order to prevent the confiscated items from finding their way into the blackmarket.

4. It is requested that this headquarters be authorized to use said materials as incentive goods to be given or sold at an appraised price to the members of deserving organizations. For instance,

- a. To encourage the economic police
- b. To encourage tax workers in performing efficiently
- c. To encourage boys and girls in reformatories to be better boys and girls

5. It is believed by this headquarters that such a disposition of said confiscated items will aid in obtaining

1. Recently the Japanese Custom Service in Osaka delivered to this headquarters, a number of items extracted by said service from the International Mail Relief Parcels. A number of items extracted were classified by the Japanese officials as non-relief items, and this headquarters requests information concerning the disposition of the following items:

- a. Mechanical pencils
- b. Fountain pens
- c. Alarm clocks
- d. Cigarette lighters
- e. Electric irons
- f. Magazines and newspapers
- g. Umbrellas
- h. Cosmetics

2. Information is requested concerning the disposition of excessive American cigarettes, as well as the quantity of penicillin permitted to be received by an individual in any one parcel and the disposition of excessive quantities.

TO: Commanding General, Eighth Army, APO 343

1. All items except item f listed under paragraph 1 of basic letter should be released by the Osaka Military Government Team to recognized Japanese relief agencies to be sold and the proceeds used for relief purposes. It is recommended that magazines and newspapers, listed as item f, if approved by Civil Censorship Detachment, be distributed by the Civil Information and Education section of the Osaka Military Government Team to Japanese public reading rooms.

2. Cigarettes, tobacco, drugs, etc., which have been removed from relief packages because of excessive quantities should be released to recognized Japanese relief agencies for general distribution to the needy.
