### RIC ASSISTS ECONOMIC DEVELOPMENT IN RURAL AREAS

A Morrisville Vermont County Extension Service agent contacted RIC in November 1987. A handicapped, small-business client seeking a Small Business Innovation Research (SBIR) grant needed the names of electrical contractors who build variable small speed DC motors. He planned to use the motor on his specialized wheel chair invention. He had hit a deadend in his search for this information, without which he could not complete his SBIR grant application.

RIC identified an appropriate contact organization, placed a call to the Small Motors Manufacturing Association and obtained the name of a key contact person. The contact then provided the names of seven East Coast companies and agreed to act as a referral contact and to provide technical assistance.

The Vermont businessman recently learned that his SBIR development grant request for \$45,000 was approved.

### RIC PROCEEDS WITH ESTABLISHING A STATE LIBRARY NETWORK

RIC recently contacted the state library directors in thirty-eight states in which the RIC program has been networked with the Cooperative Extension Service. Other state library directors will be contacted as soon as the RIC Extension network is established in their state.

RIC is establishing this network with the State Libraries with the cooperation and approval of the Rural Library Services Committee of the American Library Association. RIC is asking each library to name a representative from their staff to coordinate with RIC and Extension staff. The library representative will assist extension staff in locating, at either the local or state level, those information resources that were identified by The Rural Information Center in response to a request from their respective state.
