ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF: PORTION OF C.P. GARCIA STREET BETWEEN PLAZA MARCELO OCHAVE AND CITY HALL BUILDING (FROM INTERSECTION OF QUEZON AVENUE TO CORNER OF QUINTOS STREET), FROM MARCH 5, 2018 TO MARCH 24, 2018 EXCLUSIVELY FOR PARKING AND OTHER AGRI-TRADE FAIR ACTIVITIES;

PORTION OF QUEZON AVENUE FROM THE INTERSECTION OF C.P. GARCIA STREET TO CORNER OF VERECIANO STREET AND PORTION OF MARCOS AVENUE, FROM THE INTERSECTION OF QUEZON AVENUE (IN FRONT OF ALAMINOS CITY HALL TO NEPO MART-ALAMINOS) TO CORNER OF M. MONTEMAYOR STREET FROM 8:00 O’CLOCK IN THE EVENING OF MARCH 18, 2018 TO 1:00 O’CLOCK IN THE AFTERNOON OF MARCH 19, 2018 FOR THE STREET DANCING COMPETITION; AND

PORTION OF QUINTOS STREET (NORTH SIDE OF PLAZA MARCELO OCHAVE) FROM THE INTERSECTION OF C.P. GARCIA STREET TO CORNER OF SAN JOSE DRIVE, FROM MARCH 1-31,2018 FOR FOOD STALLS (LEFT SIDE ONLY)

SECTION 1. ORDINANCE PROVIDING FOR THE TEMPORARY FULL CLOSURE OF:

MONTEMAYOR STREET FROM 8:00 O'CLOCK IN THE EVENING OF MARCH 18, 2018 TO 1:00 O'CLOCK IN THE AFTERNOON OF MARCH 19, 2018 FOR THE STREET DANCING COMPETITION AND;

PORTION OF QUINTOS STREET (NORTH SIDE OF PLAZA MARCELO OCHAVE) FROM THE INTERSECTION OF C.P. GARCIA STREET TO CORNER OF SAN JOSE DRIVE, FROM MARCH 1-31, 2018 FOR FOOD STALLS (LEFT SIDE ONLY)
