During June, 1982, [redacted] came forth and made known information regarding the Aryan Brotherhood (AB) prison gang, an all white violence prone group which has been in existence for approximately 15 years. The AB was organized in the California State prison system, but within the last several years they have become an influence within the federal penal system and their activities tend to be uncontrolled.

Source has provided accurate information regarding two murders, one at the U. S. Penitentiary (USP), Leavenworth, Kansas, and the other at USP, Lompoc, California. Both were prison gang related. Additionally, he responded to questioning regarding 58 individuals of a hastily prepared listing of suspected members or sympathizers of the AB, plus a few members of the Mexican Mafia (variously known as MM or EME) Mexican prison gang.

During debriefing, source has indicated that things are not currently going well within the AB as many members have become users of drugs, act in a petty manner, and do not live by their lifelong sworn code of conduct, which has been reported to be as follows:

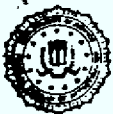

History

California State Prison System

In the late 1950's and until the early 1960's, there existed at California State Prison, San Quentin, a group of white inmates known as the Blue Bird Gang. As time went on, it became apparent to other white inmates that a more powerful gang was needed to protect white inmates from the Black and Mexican prison spawned gangs that were in power in the California Department of Corrections prison system at that time.

[REDACTED] the creed that was to become the guideline of the Aryan Brotherhood (AB):

I will stand by my brother,
My brother will come before all others,
My life is forfeited should I fail my brother,
I will honor my brother in peace and war.

In 1967, at San Quentin, the name AB was adopted, and the concept of the AB was formed, that is, "one is in for life and the only way out is by death."

Originally, one had to be part Irish in order to be a member of the AB. The AB wanted whites who could stand on their own feet, but they reached a point where they did not care about anyone except the ABs, and became a white racist group. They picked the name because it showed

white supremacy and the clover because it is the sign of the Irish and the original members had to be part Irish. They use the sign "666", which is the sign of the beast, and the swastika, which means one is an outlaw. The shamrock is symbolic of the AB and especially when there are three 6's in the shamrock.

[REDACTED] On July 3, 1972 [REDACTED] stabbed to death Jessie Renteria Castro (CDC Number B-31838), a La Nuestra Familia (NF), (a Mexican California prison spawned gang) member, at Deuel Vocational Institution, Tracy, California. The NF had been at war with the Mexican Mafia (MM/EME) since 1968 and EME members had been friends with AB members. When Castro was killed, the AB and EME formed an alliance to help each other and to fight the NF.

The AB grew in size in the California prison system and today, it is estimated that there are more than 100 members. They carry out murder contracts, sell narcotics, and control gambling and the sale of "punks" within prison walls. b7C [REDACTED]

In the mid-1970's, AB members began to be convicted of Federal violations [REDACTED]

The AB has utilized the tool of intimidation and backed this feeling of fear with some brutal murders.

The AB, in early 1980, formed a three inmate commission to run the AB in the Federal system

[REDACTED] There are now an estimated 100 - 160 members of the AB in the Federal system.

Recently, a Los Angeles source has come forth and provided information regarding the AB. Source has provided accurate information regarding two murders in the Federal prison system, and has also furnished information regarding 58 individuals suspected to be members or sympathizers of the AB and the EME, both in and out of prison.

It is a hard fact that most of the AB will be paroled or discharged at some future date, and in view of members' lifelong commitments, it would be naive to think he would not remain in contact with his brothers. The rule of thumb is that once on the streets, one must take care of his brothers that are still inside. The penalty for failure to do so is death upon the members return to the prison system. Some of the paroled members' duties

would be to supply his brothers inside with drugs, or to make hits on the street as commanded by his brothers.

A review of the atrocities attributed to the prison, gangs inside of our nation's maximum security prisons should shed some light on the potential of what these gang members can do with little or no supervision while out on the streets.

Source information indicates that the AB has a strangle hold on some of the top LCN members who are inside the prison system, so now it allows the AB access to the funding of organized crime.

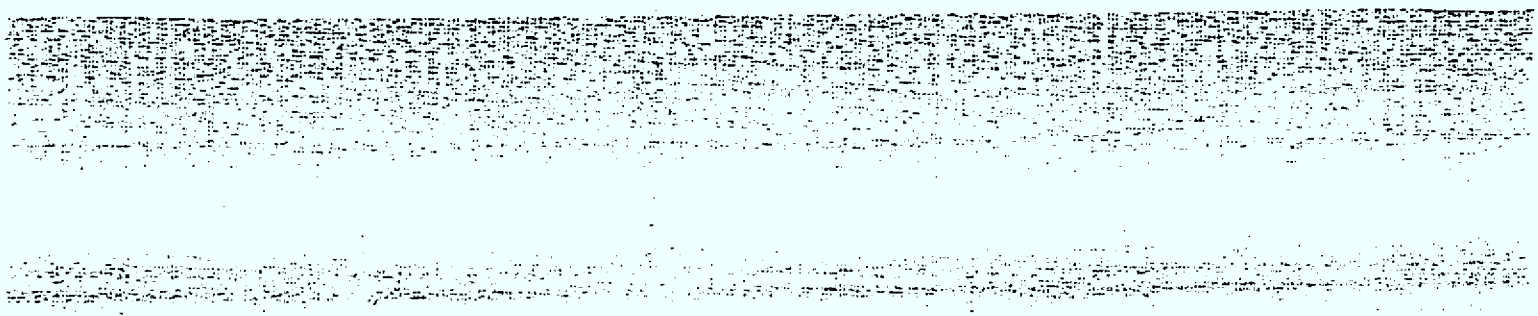

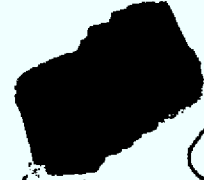

At approximately 9:30 a.m. on December 9, 1982, [REDACTED] U. S. Bureau of Prisons, U. S. Penitentiary (USP), Lewisburg, Pennsylvania (PA), while in the Institution's east corridor adjacent to the entrance grille of C-Block, heard what sounded like loud moaning and screaming coming from the second floor of that unit. [REDACTED] immediately proceeded to the second floor of C-Block and upon arrival at the stairway landing found inmate Neil Baumgarten, #20586-148, lying partially on the stairs and half-landing leading to C-2 recreation area entrance door. Inmate Baumgarten was bleeding profusely from the upper portion of his body.

puncture wounds to the upper chest, back and abdomen area. Due to the severity of Baumgarten's condition, he was immediately transferred to Evangelical Community Hospital, Lewisburg, PA, at approximately 9:55 a.m., and was pronounced dead at approximately 10:00 a.m.

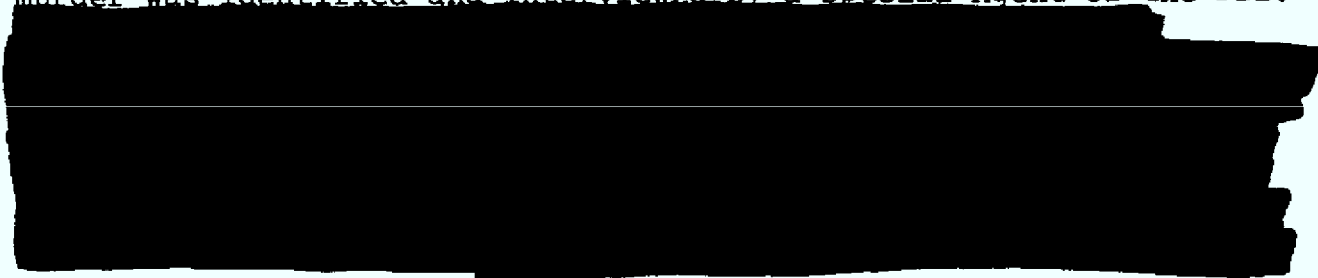
The crime scene was immediately secured and Special Agents (SAs) of the Federal Bureau of Investigation (FBI) responded to the Institution.

Institution authorities initiated a search of the A, B, C and D-Blocks of the Institution. In addition a search was conducted of the outside perimeter grounds in an attempt to locate any physical evidence. The above searches failed to produce any weapon(s), articles of clothing or any suspected physical evidence. Inmates located within the living quarters at the time of the incident were secured and ultimately checked for any possible cuts, bruises, blood stains or torn clothing. All of the above met with negative results.

During the crime scene search physical evidence (blood) was found on the folding gate restraining partition located within the recreation area connecting C-3 and A-3 Blocks. It was discovered that it is possible for an individual to crawl underneath this restraining gate if assisted by a second individual who would hold the gate up from the floor. Further investigation of the area revealed a blood stain on the C-3 recreation area door. This indicates that the escape route taken by the assailants was through the C-3 recreation area door, through the recreation area itself, underneath the partition gate and back into A-3 (A-Block, third floor).

During initial interviews of inmates located within the immediate area of the incident, an inmate eyewitness to the murder was identified and interviewed by a Special Agent of the FBI.

[REDACTED] felt that the murder of Baumgarten occurred in retaliation for the murder of Cadillac Smith which occurred at the USP, Marion, Illinois, earlier in 1982.

As the investigation progressed, it was determined necessary to place a number of inmates into the Administration Detention Unit, either for possible involvement in the murder or for having been identified as inmates who would most likely retaliate on behalf of the victim.

During the week of December 13-17, 1982, Institution staff and Special Agents of the FBI conducted numerous interviews of inmates towards the ultimate development of cooperative inmate witnesses.

On December 15, 1982, a confidential inmate informant furnished the following information to [REDACTED] b7C

During the middle part of November, 1982, victim Baumgarten had arranged to purchase a quantity of cocaine which was to be received within the Institution from the outside over the weekend of November 27-28, 1982. Arrangements were made and \$1,000 was sent to cover the purchase of the cocaine. Due to this transaction, Baumgarten began purchasing drugs on credit within the Institution, using the imminent arrival of the cocaine as collateral.

The purchase of the cocaine was being directed by another inmate within the Institution whose identity was not known to the source. During the period of time that the cocaine was to arrive at the Institution, shakedowns by USP authorities resulted in various inmates getting "busted" for narcotics. This apparently

led to the postponement of the introduction of the cocaine. Simultaneously, Baumgarten continued to purchase drugs on credit and got further in debt.

Baumgarten owed [REDACTED] two papers of heroin valued at approximately \$150. [REDACTED] began charging interest on the debt and started pressuring the victim for payment.

During the following days, Baumgarten continued stalling for time, in order to obtain the money owed to [REDACTED] indicating on three separate occasions that the money had already been sent. When the payment did not arrive, [REDACTED] again demanded payment.

During breakfast on the morning of December 9, 1982, prior to the murder, Baumgarten informed the confidential source that he was going to pay [REDACTED] the initial debt and interest but not the full amount demanded by [REDACTED]. The initial debt with the accrued interest amounted to \$350, with the full amount demanded by [REDACTED] being \$500.

Federal Grand Jury (FGJ), Middle District of Pennsylvania, Williamsport, PA, surrounding the murder of Baumgarten on December 9, 1982.

Further investigation has developed a high probability of involvement by [REDACTED]. It is speculated [REDACTED] was the lookout during the murder and was stationed at and holding up the folding restraining gate, located between the recreation areas connecting C-3 and A-3, which allowed access into C-Block by [REDACTED] and their escape thereafter.

During the period from December 1982 to the present, information has been received and compiled indicating the presence of a large group of inmates within the USP, Lewisburg, which has organized into a retaliatory and murder organization. This group is comprised of Black inmates from the Washington, D. C. area and is known as the "D. C. Blacks". A large segment of this group also has membership and/or ties with the Moorish Science Temple. Information has been received indicating that this group of inmates have banded together and have plotted the murders and attempted murders of white inmates at the USP their "cause" being the retaliation of the killing of Raymond "Cadillac" Smith who was purportedly murdered at the USP, Marion, Illinois, by incarcerated members of the Aryan Brotherhood (AB).

To support the above information, on December 11, 1982, a U. S. Bureau of Prisons transcript of a telephone conversation between [REDACTED]

During the last 180-day period, investigation in this matter has been primarily concerned with developing sources of information regarding the Aryan Brotherhood (AB).

CONTACT WITH OTHER AGENCIES

One such source of information is known as the California Prison Gang Task Force (PGTF). This task force is made up of representatives from various law enforcement and corrections-related agencies throughout the state, and meets on a once per month basis. The meetings offer investigators and corrections officers the frequent opportunity to discuss the latest intelligence and developments relating, not only to the AB, but to other prison gangs, including the Mexican Mafia (EME), La Nuestra Familia (NF), and the Black Guerilla Family (BGF). The Los Angeles Division now has a member representative who will be attending the PGTF meetings on a regular basis.

During this investigative period, the following information regarding members and associates of the AB was derived from various Federal and local agencies in the Los Angeles area:

On January 13, 1983, AB member, Robert "Blinky" Griffen, was found guilty in San Bernardino County Superior Court, for the 1980 murder of "T-Bone Gibson." Griffen was also found not guilty of being in possession of a weapon.

Since the inception of the AB in the Federal prison system, the organization has planned and carried out a number of brutal prison murders. During this investigative period, a [REDACTED] source has been developed who has provided information, and is willing to testify regarding [REDACTED] murders which took place at various Federal penal institutions throughout the nation. These AB Commission sanctioned murders took place [REDACTED] and involved victims who were "hit" because they were suspected informants, because they failed to pay drug debts, or just for making disparaging remarks about the AB. These murders involve members and associates of the LCN, AB, EME, and a Washington D.C. based street gang known as the D.C. Mob. One such murder, that of D.C. Mob leader Raymond "Cadillac" Smith in 1982, has been followed by many other murders, thought to be retaliatory in nature. The source has been interviewed extensively [REDACTED] and the results have been turned over to the appropriate United States Attorneys for prosecutive decisions and action. b7D

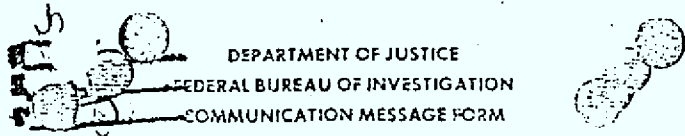

The reason for the murder is believed to be that ANDREASEN was involved in some supermarket robbery for which he was arrested, along with two other individuals. One of the robbers was unknown, and it is believed that ANDREASEN gave up that name. The ABs who are doing a lot of time are carrying out murder contracts for the Mexican Mafia (EME) as some of them are about to get out and it would be a waste for short timers to get a long beef as they can best be utilized on the outside.

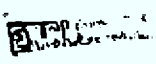

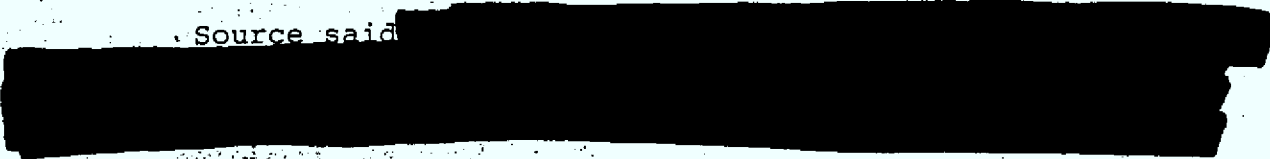

For information of the Bureau, Springfield Division has one United States Penitentiary within it's boundaries, that being the United States Penitentiary, Marion, Illinois, which is covered investigatively by the Carbondale Resident Agency of the FBI. This institution is the only level 6 facility in the U.S. Bureau of Prison System and houses approximately 325 long term inmates of which approximately one-third are State prisoners. There are approximately 100 short term inmates which are housed in a camp setting adjacent to the maximum security penitentiary.

As of 5/11/84 there are currently 13 verified [redacted] ARYAN BROTHERHOOD (AB) members of which two are on the NATIONAL COMMISSION, who are [redacted]

It should be noted that [redacted] is the acknowledged leader in the Federal system and as such controls the illegal activities in other Federal institutions. The acts consist of murder, extortion, drugs, and the introduction of other contraband.

In addition to AB, the MEXICAN MAFIA (EME), who have been allies of the AB, are also housed at Marion. At the present time there are currently 19 confirmed members, one of which is the acknowledged successor to [REDACTED] who is [REDACTED] b7c

b7c Both the AB and EME have had control over most inmates in the Federal system by use of the activities noted above and have a strong following of non-members who are sympathetic to their activities.

Marion has had numerous murders committed by both groups. On 10/22/83 two officers were stabbed to death by [REDACTED] an AB commission member, and [REDACTED] a member of the AB. b7c

b7c Since 10/83 the penitentiary has been in a "locked down" status and there has been an obvious "splitting" of allies between AB and EME. There has been noted friction between the two groups and at the present time there is little overt communication between AB and EME except when actually required.

Intelligence indicates that there is a plot in progress to take over the institution by all inmates which is currently being discussed by [REDACTED] among his followers. b7c This plot is supposed to occur as soon as the institution "opens up" in the summer, 1984. This information has been furnished to authorities at Marion and emanate from a current member source.

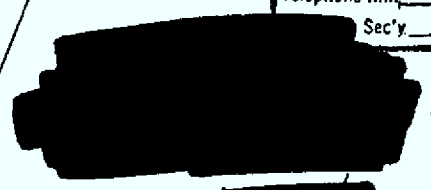

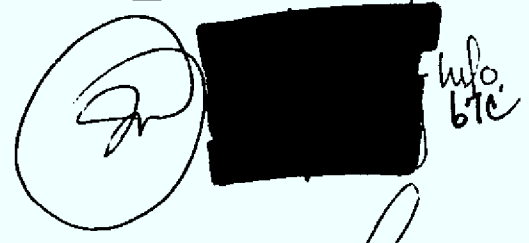

Further, both SSA [redacted] and SSA [redacted] stressed the necessity of full cooperation between FBI and BOP, not only in the investigation of prison gang offenses, but the full dissemination of any and all gang related information regarding these offenses. This dissemination can facilitate, not only the criminal act under investigation, but also the potential impact of these isolated criminal acts on an overall RICO effort against the entire organization. b7c

Throughout the meeting, BOP voiced full willingness and eager cooperation in assisting and joining in the FBI's efforts to address the prison gang problems. This joint cooperation can greatly aid in the investigations of CGR type cases as well as provide timely intelligence information from BOP as to prison gang activities within BOP and anticipated release of identified gang members on parole to a given region.

These two meetings, AB Strategy meeting and BOP Gang Activity meeting, were highly beneficial for both the Organized Crime Section and the Personal Crimes Section as to identified programs within each section. The established direction and mutual areas of concern will be closely coordinated between all effected substantive desk supervisors.

Sacramento is not currently investigating prison gangs, i.e, Aryan Brotherhood, Black Guerrilla Family, or Mexican Mafia, on other than a reactive basis.

The Sacramento investigation of La Nuestra Familia (NF) reached the prosecution stage with convictions of 21 gang members. On 2/6/84, a hearing was held before USDJ Edward Price, EDC, at which time defense attorneys for the remaining four defendants argued motions for dismissal based on outrageous government conduct before the FGJ and RICO statute violation of First Amendment Rights of association. To date, Judge Price has not ruled on the motions.

It is not anticipated that Sacramento will conduct further active investigation of the NF due in part to a lack of enthusiasm on the part of the USA's office. Sacramento has been advised that any further prosecution of the NF should center on active members not currently incarcerated and whose crimes are homicides.

IN JUNE, 1986, THE UNITED STATES ATTORNEY'S OFFICE, LOS ANGELES, CA RECEIVED A WRITTEN REQUEST FROM THE LOS ANGELES SHERIFF'S DEPARTMENT (LASD) REQUESTING THE FEDERAL GOVERNMENT CONSIDER A POSSIBLE RICO STATUTE PROSECUTION OF AN INFAMOUS CALIFORNIA PRISON GANG KNOWN AS THE ARYAN BROTHERHOOD (AB). A COPY OF THE LETTER AND SIMILAR REQUEST WAS MADE TO THE LA OFFICE OF THE FBI. SINCE JUNE, 1986, A PRELIMINARY INVESTIGATION HAS BEEN CONDUCTED TO DETERMINE THE EXTENT OF THE ILLEGAL ACTIVITIES CONDUCTED BY THE ARYAN BROTHERHOOD AND THE FEASIBILITY OF PROSECUTION UNDER FEDERAL STATUTES. IN CALIFORNIA, THE GANG AROSE DURING THE 1960'S AS A RESPONSE BY WHITE INMATES TO ATTACKS BY BLACK AND HISPANIC GANGS. THE AB IS RACIST IN NATURE IN THAT THEY BELIEVE THAT THE WHITE INMATE IS SUPERIOR TO BLACK AND HISPANIC INMATES. THE AB IS NOT ASSOCIATED WITH OTHER OUTSIDE WHITE SUPREMICIST

RECENTLY, WHEN AB LEADERS WERE PLACED IN SECURITY HOUSING UNITS FOLLOWING OUTBREAK OF VIOLENCE AT FOLSOM, PRISON, AB LEADERS ORDERED THEIR ASSOCIATES IN THE PRISON TO BEGIN STABBING RAPISTS AND CHILD MOLESTERS ON A DAILY BASIS UNTIL THE CORRECTION DEPT. SAW FIT TO RELEASE THE LEADERSHIP BACK TO THE GENERAL POPULATION.
