(Check ascertained these phones are located in Apartment 210, 1001 Grigsby Street, Dallas.)

The above information was immediately furnished to Lt. JACK REVILL on 9/13/63 and on 9/16/63, Lt. REVILL advised he had just ascertained that the telephones had been moved out of the apartment on the same date, 9/16/63. Lt.
