Dear friend Webb;

We shall address you no more  
from No. 21 Cornhill, <sup>-at present, certainly-</sup> We have left that  
venerable & somewhat disappitiated office, and  
take up our head-quarters in a far more eligible  
& central situation, in a new building, in which  
we have a quite spacious room, giving us a  
chance to turn around, and to bestow our books  
& tracts, without picking them on the floor. Would we  
could see you walk in, some day, to inspect our  
office and us, and to give us your word of cheer.  
- This is Anniversary week, - our N. E. Anti-  
Slavery Convention commences tomorrow, and we  
are busy in preparation. I will, however, to  
day a few words to you, by tomorrow's steamer;  
and so I begin. - Please forward enclosed, for  
H. Martineau. - I am hoping to hear from you  
of the arrival of the Box of books which I forwarded  
to y<sup>r</sup>. care, per steamship, some time since. I trust  
it all reached you in good order. It would impose  
labour on you, I know very well, in the distribution;  
yet I see not how it could be helped. I ought to  
have got off to you, by tomorrow's steamer, a parcel of  
our "Annual Report for y<sup>r</sup>. ending May 1, 1859" - an  
admirable document, though tardy. prepared by Mr. Burleigh

and just published. We are hoping that  
the Report, for 1859-60, will be out by August 1<sup>st</sup> 1. D  
at the latest. I hope to live to see the  
Society "up to time" in respect to these Reports.


On the other side I give a list of some  
changes to be made in our "Advocate" list - 2. S  
of which please take note. - I am collecting  
the Advocate money for current year (Octo. to Octo.) 3. S  
and it will be \$13.50, or thereabouts. - Our discontinuing  
subscribers say, that so much of the Advocate matter is taken  
from Liberator & Standard, or, is copied from Advocate into those  
papers, (which most of them see) that they do not need it, &c.  
- "Every one to his taste"; I find much in the "Advocate" that  
I see no where else, & could not do without it.

I believe that Garrison has finally abandoned all  
thought of going to England this summer - or this year. I am  
sorry now I gave you any reason to expect him. For myself,  
I have decided to remain at home this summer, - or rather, not  
to stray far from it, - mainly on account of my father's impaired  
health. - We continue to have good accounts of my boy  
Edward. He is in China now, or Cochin-China, with a prospect of  
remaining for the present. - I hear that F. Douglass is  
in this country again; - I don't know it to be so,

This morning we receive tidings of the death of Theodore Parker  
at Florence, May 10<sup>th</sup>. His loss is a tremendous one to the Cause of  
Free thought, speech, & action in America - not to say in a wider field.
