Libraries awaiting the 5th update to PATENT OFFICE CLASSIFICATION DEFINITIONS will see the microfiche sometime in June. Both the Patent Office and GPO rejected the poor quality fiche submitted by a contractor, and the job is being redone. It is distributed under Item Number 252-A (C 21.3/2:).

WE TRIED!

A very alert Documents Librarian, Ms. Margaret Aycock, with the Arthur J. Morris Law Library at the University of Virginia, brought to our attention a new publication of the Federal Reserve Board. It was described as a loose-leaf service titled, FEDERAL RESERVE REGULATORY SERVICE, and we requested it for a survey. However, we have been informed that it is produced by the Board of Governors of the Federal Reserve System which receives funds from assessments on the Federal Reserve Banks. By statute (12 USC, section 244) these funds are not construed as Government or appropriated money. Also, the publication is considered as "cooperative" under 44 USC, section 1903 as it is intended to be sold in order to be self-sustaining. Regrettably, we cannot obtain it for distribution. But many thanks to Ms. Aycock for giving us the chance to try!
