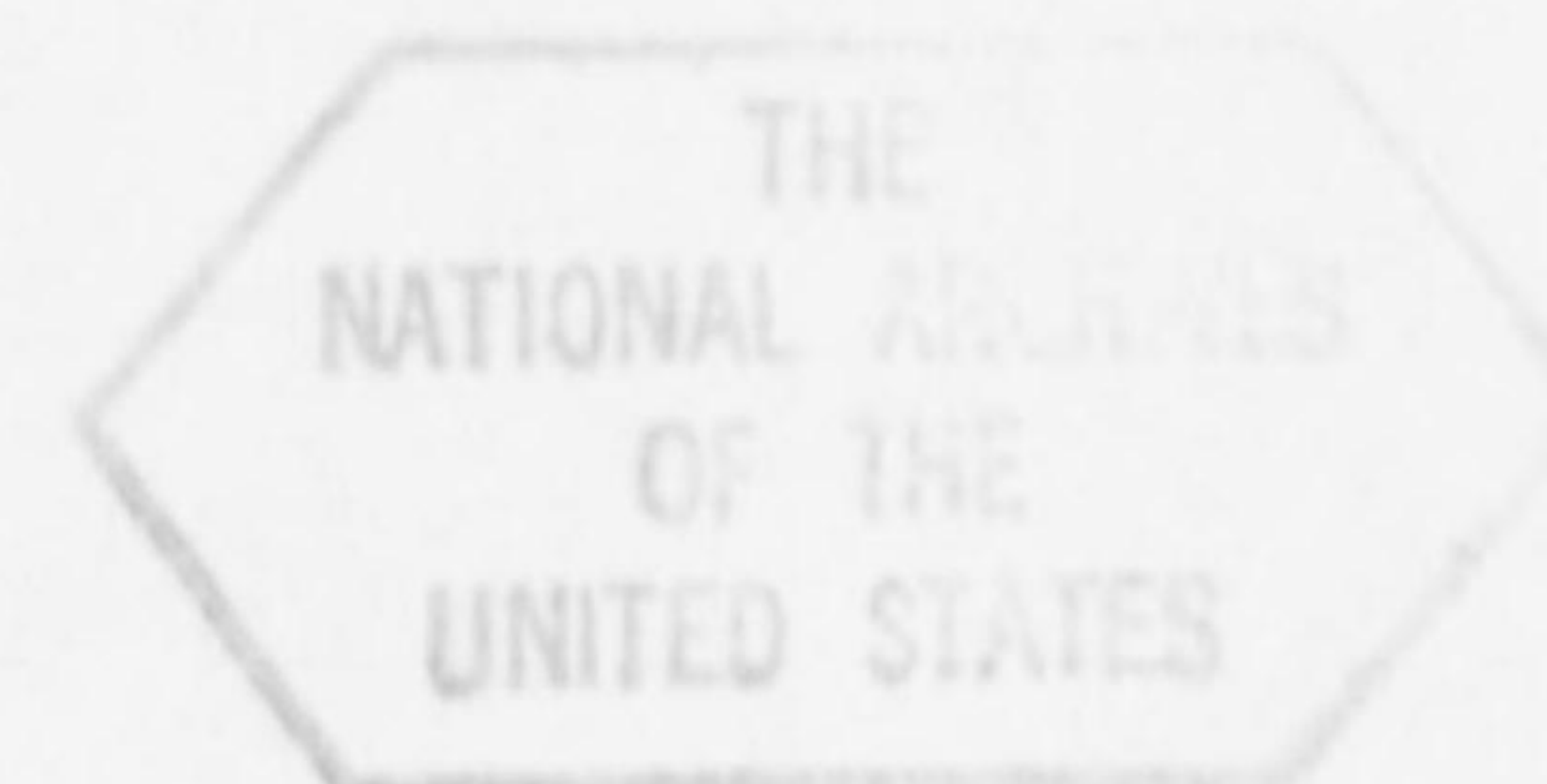

1. Attention is directed to Comptroller General's decision, CG-29-99, which states in part:

SUBJECT: Pecuniary Liability

1. I have been notified that I am liable in the amount of seven dollars and five cents (\$7.05) for loss of government property.

2. The following statement was made by me on 19 March 1951:

"On the evening of 8 March 1951 riding back to Takamatsu from labor rallies in Sakaide in a Civil Affairs jeep, we were surprised to discover when we were stopped, that the rear tire was flat and had been for some distance. However, the road was so rough that occupants, including myself, were not aware of the condition. It is very easy to travel on Japanese roads without realizing that such a thing is happening, particularly at night when additional hazards, such as lighting problems, tend to draw the attention to a more complicated set of factors."

3. In view of the above statement I submit my protest of this pecuniary liability and apply for reimbursement.
