Subject on the charge of accounts of money, etc., presented to P.W.

I sanction and make them promulgate the "subject on the charge of accounts of money, etc., presented to P.W."

The War Minister or Naval Minister can take charge of accounts and custody of money presented to P.W.

(exclusive of money left by the enemy's person died in action or of other causes or money P.W. ought to be payed.)

Supplementary Rule

This Ordinance is carried into effect on and after the day of promulgation.
