*(Acts whose publication is obligatory)***COMMISSION REGULATION (EEC) No 3226/80****of 8 December 1980****fixing the free-at-frontier reference prices applicable to wine imports from 16 December 1980**

THE COMMISSION OF THE EUROPEAN COMMUNITIES,

Having regard to the Treaty establishing the European Economic Community,

Having regard to the Act of Accession of Greece, and in particular Article 146 (2) thereof,

Having regard to Council Regulation (EEC) No 337/79 of 5 February 1979 on the common organization of the market in wine⁽¹⁾, as last amended by Regulation (EEC) No 2930/80⁽²⁾, and in particular Article 18 (8) thereof,

Whereas Article 18 of Regulation (EEC) No 337/79 lays down special rules relating to the importation of certain products in the wine-growing sector; whereas Commission Regulation (EEC) No 1393/76⁽³⁾, as last amended by Regulation (EEC) No 3104/80⁽⁴⁾, lays down the relevant implementing rules; whereas, under Article 18 (8) of Regulation (EEC) No 337/79, the Commission is required to fix the free-at-frontier reference prices;

Whereas the list of free-at-frontier reference prices should be established taking particular account of trade requirements and with a view to administrative simplicity;

Whereas, pursuant to Article 64 (2)(b) of the Act of Accession of Greece, products in the wine sector for

which a reference price is fixed are to be fully subject to the duty in the Common Customs Tariff; whereas it therefore seems appropriate to fix free-at-frontier reference prices which are the same as those appearing in the 'other third countries' column;

Whereas Article 18 (1) of Regulation (EEC) No 337/79 provides that the free-at-frontier reference prices are to be equal to the reference price less customs duties actually levied; whereas the amounts or coefficients under the system of monetary compensatory amounts must not be taken into account in assessing the customs duty to be deducted from the reference price,

HAS ADOPTED THIS REGULATION:

Article 1

The free-at-frontier prices referred to in Article 18 (8) of Regulation (EEC) No 337/79 shall be as indicated in the Annex hereto.

Article 2

This Regulation shall enter into force on 16 December 1980.

In the Hellenic Republic, this Regulation shall apply with effect from 1 January 1981.

This Regulation shall be binding in its entirety and directly applicable in all Member States.
