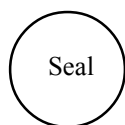

**A PROCLAMATION BY HIS EXCELLENCY THE PRESIDENT OF THE DEMOCRATIC
SOCIALIST REPUBLIC OF SRI LANKA**

KNOW YE that by virtue of the powers vested in me by paragraph (5) of Article 70 of the Constitution of the Democratic Socialist Republic of Sri Lanka to be read with paragraph (2) (c), of Article 33 of the Constitution of the Democratic Socialist Republic of Sri Lanka and paragraph (2) of the Article 62 of the Constitution of the Democratic Socialist Republic of Sri Lanka and in pursuance of the provisions of Section 10 of the Parliamentary Election Act, No. 01 of 1981, I, Maithripala Sirisena, President of the Democratic Socialist Republic of Sri Lanka, do by this proclamation-

- (a) Dissolve Parliament, with effect from midnight today and summon the new Parliament to meet on the Seventeenth day of January, Two Thousand and Nineteen;
- (b) Fix, Fifth day of January Two Thousand and Nineteen as the date for election of the Members of Parliament.
- (c) Specify the period beginning on the Nineteenth day of November Two Thousand and Eighteen and ending at Twelve Noon of the Twenty Sixth day of November, Two Thousand and Eighteen as the nomination period, during which nomination papers shall be received by the Returning Officers; and



- (d) Specify each place mentioned in Column II of the Schedule hereto as the place of nomination for candidates seeking election in the electoral district mentioned in the corresponding entry in Column I of that Schedule.

Given at Colombo on this Ninth day of November, in the year Two Thousand and Eighteen.
