SUBJECT: Reports Required for Agricultural Land Commissions Election

TO: See Distribution

1. Reference: Paragraph 7, Operational Directive 19, 2 April 1949, as amended by Operational Directive 19/1, 15 June 1949, this headquarters.

2. Reports called for by referenced directive will not be required by this headquarters for the coming general election of members of Agricultural Land Commissions to be held on 18 August 1949 except those reports which are required by paragraphs 7a (2), 7c (3), and 7c (4) of the above reference.

3. One narrative report from the Civil Affairs Team of each prefecture, will be submitted in triplicate, (Reports Control Symbol MG 22 R1) direct to this headquarters, with information copies to intermediate headquarters. Reports will be dispatched within ten days after the election day and will contain the following information:

a. The name, location of committee to which elected, and name of supporting political party, if any, of each successful candidate. No report of independent candidates elected will be required.

b. A general account of the election with emphasis on voting interest of the electorate, publicity given the election, prominent campaign issues and significant political strategy.

c. Any serious violation of election laws.
