



## 'Outstanding Teachers' Named

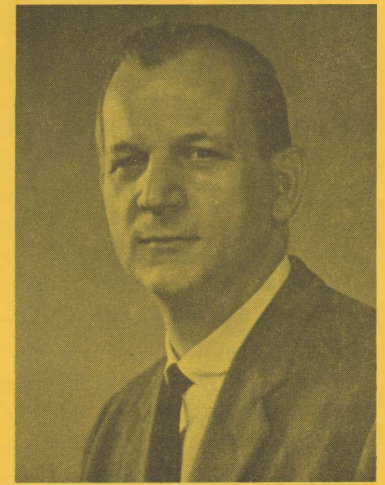

Two RIT faculty members will be awarded the Institute's highest teaching honors at the 87th annual commencement exercises Saturday, June 10, at the Rochester War memorial.

Albert D. Rickmers, 7 Wethersfield Rd., Chili, a professor in the School of Photographic Arts and Sciences of the College of Graphic Arts and Photography, will receive the Outstanding Teacher Award, and Dr. Morton Isaacs, 757 Harvard St., Rochester, an assistant professor of social science in the College of General Studies, will be awarded the Institute's Distinguished Young Teacher Award.

## Brady Promoted To Research Post

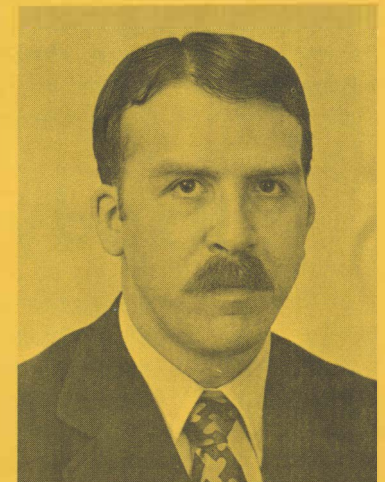
Registrar George E. D. Brady has been promoted to coordinator of institutional research, effective July 1.

In making the announcement, Dr. Todd H. Bullard, provost, said Brady's primary function will be to work with the various divisions of the Institute in gathering, systemizing and interpreting data. In the new position Brady will become involved with a broad range of Institute concerns and projects in reporting to the provost.

"Mr. Brady will be directly involved in gathering data relating to admissions, enrollment, and educational matters," Dr. Bullard said, adding, "Such information is of vital importance in planning and budgeting. Mr. Brady's outstanding performance as registrar leads us to think that he will bring unusual talent and experience to this new work."

Brady joined RIT in July 1966, coming from the State University of New York at Buffalo, where he served as admissions counselor, foreign student admissions officer, and assistant to the

president for Academic Affairs, stated that the honors serve to exemplify the importance RIT places on teaching excellence, and to reward individuals who have demonstrated a devotion to intellectual development along with the ability to stimulate students in their pursuit of knowledge.

Recipients of the two awards are chosen by a committee of faculty, administrators, and students. The Outstanding Teacher Award was first presented in 1965 and has no upper limit in age or service. The Distinguished Young Teacher Award is for younger faculty members who have served more than two, but less than seven years at RIT and was first presented in 1967.

Professor Rickmers, who is well known nationally as a lecturer on statistics and quality control, has been a faculty member in RIT's School of Photographic Arts and Sciences since 1955. Previously he taught high school math and science at Ellicottville, N.Y. and Limestone, N.Y.

He received an M.S. degree in statistics from RIT in 1969; an M.Ed. degree from St. Bonaventure University, Olean, N.Y. in 1950; a B.S. degree in mathematics from Bloomsburg State College, Bloomsburg, Pa., in 1948; and a graduating diploma from Hershey Junior College, Hershey, Pa. in 1942.

A native of Benton, Pa., he was named "Outstanding Alumnus of the Year" in 1970 from the Milton Hershey School in Hershey, Pa.

Rickmers has co-authored a book titled "Statistics: An Introduction," published in 1967 by McGraw-Hill.

He is a past president of the Rochester Society for Quality Control, and has held numerous offices in the national association. He is listed in Who's Who in American Science, 1967; Who's Who in America, East, 1968; Who's Who in American Education, 1968; and Who's Who in Consulting, 1968.

Rickmers is currently serving as a consultant to the S. C. Johnson and Son Wax Company of Racine, Wis., and the Lord Corporation of Erie, Pa.

Dr. Isaacs, assistant professor of psychology, became a faculty member at RIT in 1970. He previously served as a

lecturer in psychology at Norwalk Community College in Norwalk, Conn., and was an instructor in psychology at Pratt Institute in Brooklyn, N.Y.

He received his Ph.D. degree in psychology in 1972 from Yeshiva University in New York City; an M.A. degree in experimental psychology from Columbia University in 1955; his B.A. in psychology from Columbia University in 1954; and a B.S. degree in liberal arts from the University of Chicago in 1952.

He is a member of the American Psychological Association, the American Association of University Professors, and the New York State Psychological Association. While at Columbia, he was elected to the Phi Beta Kappa.

## Trackmen Claim National Record

The RIT varsity track team has claimed the national record for the longest college division dual meet winning streak with 40 consecutive victories.

Ironically, a search for an established record has found that nobody seems to know what the record is.

"We don't have such a record," said a spokesman at the National Collegiate Athletic Association Service Bureau in New York City. The NCAA headquarters in Kansas City didn't have the answer either.

"Track and Field News" editor Burt Nelson didn't have knowledge of such a winning streak and noted that the only way that such a record could be established would be to have RIT make a claim and have it challenged.

"We're sure that in order to have a team beat us for this record, they're going to have to schedule quite a few meets," says RIT mentor Pete Todd. Todd's 1969 cross country team set the record for the most dual meet victories in one season (18).

RIT has recorded season records of 6-0, 12-0, 13-0 and is presently 9-0 this season. The team has also won three straight Upper New York State championships.
