



The Conference Committee on the Constitutional Convention reported in favor of allowing the members of the Convention \$10 a day, and to retain the 30 delegates at large. The Convention is to assemble at Sacramento on Septem her 28th, so as not to interfere with the State Fair. The Assembly has passed the Folsom Branch State Prison bill. Oregon and Washington Territory, valnable chiefly for timber and nufit for cultivation, may be sold to United States citizens in quantities not exceeding 160 acres to any one person or association at the minimum price of \$2 50 per acre,

and lands valuable chiefly for stone may he sold on the same terms. The bill. however, expressly excepts from its op-erations all mining claims or the improvements of any hons fide setller on lands containing gold, silver, cinnabar, copper or coal, and all State selections under grants for education, internal improvements or other purposes, and lands within Indian or military reservations. It is also provided that the bill shall not defeat any rights conferred by the Art of '66 granting the right of way for ditches, etc., over public lands, or
